THEIR MAJESTIES' COURTS, 1920.

REGULATIONS.

- 1. The King and Queen will hold two Courts during the coming season, one in the first week in June and one in the third week in June, for the presentation of ladies to Their Majesties.
- 2. Ladies who have themselves been presented, and who desire to be summoned to one of these Courts for the purpose of making presentations, are requested to make a written application to the Lord Chamberlain, St. James's Palace, S.W. 1, as soon as possible. The names of the ladies to be presented should be forwarded by the lady who wishes to make the presentations when she sends in her own name.
- 3. No applications can be received from ladies who wish to be presented. Their names must be forwarded by the ladies who wish to make the presentations.
- 4. A lady presented for the first time can only present her daughters or daughters-in-law at the Court at which she is presented.
- 5. Ladies may be accompanied to Court by their husbands if the latter have been presented, but gentlemen do not pass before The King and Queen. Ladies who wish to be accompanied by their husbands should state

state if the ladies they desire to present wish to be accompanied by their husbands. Once the summons has been issued, the amending of a summons card in order to include a lady's husband can only be permitted under the most exceptional circumstances.

- 6. The Dress Regulations are: Ladies: Court Dress without feathers and trains. Gentlemen: Full Court Dress.
- It is urgently requested that all applications will be made strictly in accordance with the above Regulations.

SPECIAL ACTS (EXTENSION OF TIME) ACT, 1915.

CALEDONIAN RAILWAY ORDERS.

Whereas by the Special Acts (Extension of Time) Act, 1915, it is provided, inter alia, that where the time within which a duty is to be performed or a power may be exercised under any Special Act is limited, an application may be made by or on behalf of the person by whom such duty is to be performed or by whom such power may be exercised to the appropriate Government Department for an Order extending that time, and that the Department, if satisfied that the time should be extended, may make an the fact in their applications, and they should also | Order accordingly, and it is further provided

Order for more than a year, without prejudice, however, to the making of any further Order:

And whereas, by the Caledonian Railway Orders (Extension of Time) Order, 1917 (hereinafter referred to as "the Order of 1917.") the times within which the powers respectively of the Caledonian Railway Company (hereinafter called "the Company") and the Lanarkshire and Ayrshire Railway Company might be exercised under the Orders and for the purposes therein mentioned were extended, and by the Caledonian Railway, etc., Orders (Extension of Time) Order, 1918 (hereinafter referred to as "the Order of 1918"), the said times were further extended, and the times within which the powers of the Company, the Lanarkshire Ayrshire Railway Company, the Glasgow and South Western Railway Company, and the Portpatrick and Wigtownshire Joint Committee might be exercised under the Act and Orders and for the purposes therein mentioned were extended:

And whereas by the Caledonian Railway Orders (Extension of Time) Order, 1919, the said times were further extended:

And whereas the Company have in terms of the said Act applied to the Secretary for Scotland for an Order extending the periods limited respectively for the compulsory purchase of lands and the completion of works authorised Acts and Orders hereinafter tioned:

And whereas I am satisfied that the periods in respect of which the application is made should be extended.

Now, therefore, in pursuance of the powers vested in me by the Special Acts (Extension of Time) Act, 1915, I, the Right Honourable Robert Munro, His Majesty's Secretary for Scotland, hereby order as follows:—

- (1) The time within which the powers of the Company for the compulsory purchase under Section 6 of the Caledonian Railway Order, 1907, of the lands numbered (2), (3), (9), (11), and (13), in that Section may be exercised, as extended by the Orders of 1917, 1918 and 1919, is hereby further extended for a period of one year, that is to say, until the 19th day of May 1921.
- (2) The time within which the powers of the Company for the compulsory purchase under Section 5 of the Caledonian Railway Order, 1910, of the lands numbered (1), (2), (3), (4), (6) and (7), in that Section may be exercised, as extended by the Orders of 1917, 1918, and 1919 is hereby further extended for a period of one year, that is to say, until the 26th day of July 1921.
- (3) The time during which the power of the Lanarkshire and Ayrshire Railway Company under Section 40 of the Caledonian Railway Order, 1907, to retain and hold lands acquired by them which have not been applied for the purposes of their undertaking or sold or disposed of by them may be exercised, as extended by the Orders of 1917, 1918 and 1919, is hereby further extended for a period of one year, that is to say, until the 28th day of August 1921.

(4) The time within which the powers of the Company for the compulsory purchase under Section 5 of the Caledonian Railway Order, 1913,

that no time shall be extended under any such of the lands numbered (1) in that Section may be exercised, as extended by Section 14 of the Caledonian Railway Order, 1915, and by the Orders of 1918 and 1919, is hereby further extended for a period of one year, that is to say, until the 4th day of July 1921.

- (5) The time during which the powers of the Company for the construction and completion of the Railway (Work No. 1) authorised by the Caledonian Railway Order, 1907, may be exercised as revived and extended by Section 15 of the Caledonian Railway Order, 1915, and as extended by the Orders of 1918 and 1919, is hereby further extended for a period of one year, that is to say, until the 19th day of May
- (6) The time during which the powers of the Company under Section 7 of the Caledonian Railway Order, 1910, for the construction and completion of the bridge lengthening (Work No. 1) authorised by that Order may be exercised, as extended by Section 13 of the Caledonian Railway Order 1915, and by the Orders of 1918 and 1919, is hereby further extended for a period of one year, that is to say, until the 26th day of July 1921.
- (7) The time during which the powers of the Company under Section 7 of the Caledonian Railway Order, 1913, for the construction and completion of the bridge widening at Beattock authorised by that Order may be exercised, as extended by the Orders of 1918 and 1919, is hereby further extended for a period of one year, that is to say, until the 4th day of July
- (8) The time within which the powers of the Company under Section 4 of the Caledonian Railway (General Powers) Act, 1899, for the construction and completion of the Railway (No. 3) authorised by that Act may be exercised, as extended by Section 10 of the Caledonian Railway Order, 1915, and by the Order of 1919, is hereby further extended for a period of one year, that is to say, until the 9th day of August 1921
- (9) The time within which the Company are required by Section 26 of the Caledonian Railway Act, 1900, to carry out the street improvement and works referred to in that Section, as extended by Section 12 of the Caledonian Railway Order, 1915, and by the Order of 1919, is hereby further extended for a period of one year, that is to say, until the 6th day of August 1921.

(10) The time within which the Company are required by Section 22 of the Caledonian Railway (Grangemouth Harbour) Act, 1876, to complete the dredging, deepening and improvement of the navigation of the River Carron authorised by that Act as now extended by Section 20 of the Caledonian Railway Order, 1910, is hereby further extended for a period of one year, that is to say, until the 27th day of June 1921.

This Order may be cited as the Caledonian Railway Orders (Extension of Time) Order, 1920, and this Order and the Orders of 1917, 1918 and 1919, may be cited together as the Caledonian Railway Orders (Extension of Time) Orders, 1917 to 1920.
