(France and Flanders unless otherwise stated.)

Awarded the Distinguished Conduct Medal.

200105 Pte. L. R. W. Barton, 10th Bn., E. Kent R., attd. 21st Inf. Bde., Sig. Sec., 7th Ind. Div. Sig. Coy. (Margate).

(PALESTINE)

For gallantry and devotion to duty on the 19th September 1918, when he laid a wire under heavy fire and maintained communication between his unit and the brigade until the final objective was reached.

165951 Sit. P. C. Bryan, 45th Bde., Sig. Sub. Sec., R.E. (Savannah, U.S.A.).

For continuously good work and great courage and devotion to duty, especially on the 29th September 1918. On this date in the neighbourhood of Messines he went forward with the attacking infantry, and maintained during the whole of a day of heavy fighting communication between the brigade and the advancing infantry brigade, thus enabling most valuable information to be sent back to the heavy artillery.

S/15520 Pte. C. Campbell, 7th Bn., Argyll and Suth'd Highrs., T.F. (Airdrie).

For gallantry and devotion to duty east of Gavrelle on the 27th August 1918, when after his company had gained its objective a strong enemy attack developed, which drove back several of our posts and inflicted heavy Pte. Campbell immediately took casualties, command of the situation, and by his personal example inspired those around him to great efforts, which resulted in the position being held. His coolness and utter disregard of danger was an example to all.

14244 Sjt. H. N. Clarke, 9th Bn., E. Surr. R. (Aberdeen).

For gallantry and devotion to duty during the advance east of Cambrai in October 1918, when on several occasions he showed great energy and skill when the outpost line was temporarily held up by enemy shell and machine-gun fire. He was able to secure the prompt capture of hostile machine guns, and so prevented the advance being delayed.

200045 Sjt. J. Crow, 1/4th Bn., R. Scots T.F. (Edinburgh).

For consistent gallantry and good work. Throughout a period of nineteen months he acted as battalion scout sergeant and did excellently. He was frequently in sole charge of the battalion scouts, and his work in "No Man's Land" when in the line or in action with the battalion was always gallantly and ably carried out.

19465 Pte. G. Dempster, 12th Bn., R. Ir. Regt. (Antrim).

For gallantry and devotion to duty on the 30th September 1918, near Dadizeele. When the advance on Hill 41 was held up by machinegun fire, he ran forward with his Lewis gun, killed and wounded a number of the enemy, and so cleared the way for his company to advance.

M2/194380 Pte. J. Douglas, R.A.S.C. (M.T.) (Jedburgh).

(TRANS-CAUCASIA)

For conspicuous gallantry in action in the Tartar country, south of Erivan, when with a Ford car he proceeded to the rescue of the Allied Consuls who had been held up on the top of Kasbek Mountain. He came under heavy fire on the Georgian Road, and the guide accompanying him was killed.

8420 Pte. R. Edom, 1st Bn., S. Gds. (Cork).

For gallantry and devotion to duty near the Ypres-Menin road during the period 27th October to 11th November 1914. He voluntarily carried out reconnaissance work under very heavy shell and machine-gun fire, accounted for a large number of the enemy, and obtained valuable information. On more than one occasion he volunteered to carry important messages over fire-swept ground.

5911 Sjt. T. Foley, 2nd Bn., R. Mun. Fus. (Limerick).

For conspicuous gallantry on the 27th August 1914, during the rearguard action from Fesmy to Etreux. He led a dashing counterattack which cleared Fesmy of the enemy, driving them back with heavy loss. He commanded his platoon with great skill, and held up the enemy advance guard several hours in spite of superior numbers. Again at Oisy village he commanded his platoon most gallantly, and later, when all his officers were wounded, he took command of the company and led it in the attack on Etreux village. He was a splendid example to all.

6522 A./C./Q./M./S. G. Graham, 1st Bn., R.W. Surr. R. (Lewisham).

For gallantry and devotion to duty in August 1914, when in charge of the battalion machine-gun corps section. Later, at Gheuvelt, his example was an inspiration to all.

13052 Sjt. G. Graham, 12th Bn., R. Scots (St. Boswells).

For consistent gallantry and devotion to duty as transport-serjeant. On several occasions, as at Hoegenacker, on 18th July 1918, and east of Ypres, on 29th September, when the transport, bringing up rations, came under heavy shell fire, he displayed great resourcefulness and disregard of personal danger in transferring the rations to pack ponies and leading them across country himself under very trying conditions.

5330 R./S./M. H. Hamilton, 1st Bn., R. Ir. Fus. (Dublin).

For gallantry and devotion to duty between

February 1917 and March 1918. His fine example on many occasions was invaluable in the actions in which the battalion took part, especially on the 24th March 1918, when he handled a portion of the rearguard with great skill, covering the retirement and evacuating all our wounded.

10554 Sjt. P. G. Hyde, M.M., 2nd Bn., Sco. Rif. (Willesden Green).

For gallantry and initiative at Voyennes, on 24th March 1918, when the enemy crossed the Somme Canal and broke the battalion front. Sjt. Hyde took command when the platoon commander was killed, and led the platoon in face of heavy machine-gun fire, and drove back the enemy. Although severely wounded he continued in his command, and held a forward position for several hours. He set a fine example to his platoon, and held back the enemy at a critical time.

558244 Sjt. W. H. Isaac, 75th Div. Sig. Coy., R.E., T.F. (Lewisham).

(PALESTINE)

For gallantry and devotion to duty when in charge of the advanced brigade head-quarter's signal section. On the morning of the 19th September 1918 the enemy had put up a strong barrage, and the fire was severe. Although control in the half-light and thick dust and smoke was most difficult, Sjt. Isaac nevertheless, by extreme exertion and entire disregard of personal danger, kept his section together, led them through "No Man's Land," and maintained communication. His conduct throughout was splendid.

99301 C./S./M. J. Jennings, 1/5th Bn., L'pool R., T.F. (Torrington).

He, with a small party of men, played an important part when his company crossed the canal at Don, on the 15th October 1918, by personally conducting the placing of a foot bridge across the canal under heavy artillery fire. It was due to him that the speedy crossing of the canal was made by the whole battalion.

265148 C./S./M. W. Keegan,  $2/7 {\rm th}$  Bn., L'pool R., T.F. (Liverpool).

As company serjeant-major throughout the campaign. By his personal example in action, especially during the period under review, he has inspired the confidence and admiration of all that have been in action with him.

G/58211 Cpl. A. J. Leonard, 20th Bn., Midd'x R. (Norbiton).

For very great gallantry and devotion to duty. During the fighting on 28th September 1918, his personal gallantry was outstanding, and by cool and courageous handling of his gun he was instrumental in driving the enemy from a position of serious menace to the success of the attack. On another occasion, at Ypres, he remained for over two hours in "No Man's Land" with a wounded comrade until assistance could be brought.

1081 Sjt. R. S. Mackay, 1st Bn., Sea. Highrs. (Golspie). (PALESTINE)

For gallantry and devotion to duty at Tabsor, on the 19th September 1918, when he led his platoon with marked skill and resource under heavy machine gun fire from the flank. His gallant conduct deserves the greatest praise. He had on several occasions, whilst serving in Mesopotamia, shown gallantry and initiative.

200004 C./S./M. (a./R./S./M.) G. Manvell, 4th Bn., R. Suss. R. (Brighton).

For gallantry and devotion to duty throughout the war. On all occasions he has shown great coolness under fire, and by his personal example has inspired all ranks. His services were particularly outstanding near Soissons on the 29th July 1918, when he assisted in controlling the advance under heavy shell fire until himself wounded.

12091 Sjt. G. Mason, 272nd Coy., M.G. Corps (Manchester).

For conspicuous gallantry and devotion to duty at Delville Wood, on the 27th July 1916. When his gun team and gun were buried, he, under heavy shell fire, dug them out, and bandaged up one man whose leg was broken. He also brought in a wounded N.C.O. of another unit who was lying out in front.

32072 A./Sjt. N. Mills, 8th Bn., Y. & L.R. (Leeds). (ITALY)

Sjt. Mills has served continuously in the field since January 1917, and has taken part in every action which the battalion has fought. During severe fighting in Flanders, from June to October 1917, he did excellent work as Lewis-gun N.C.O., and distinguished himself in particular on the 15th June 1918, during the Austrian offensive on the Asiago Plateau. His work has been excellent throughout.

238054 Cpl. M. Mulhall, 1/4th Bn., H. Lan. R., T.F. (Liverpool).

On 29th September 1918, near La Bassee, he was in command of two Stokes trench mortars. During the subsequent advance he kept his gun well forward, and at Hantay, despite many difficulties of supply, marshy ground, and proximity of the enemy in open country, several times came into action against enemy machine guns and snipers' posts, materially assisting the infantry. He always displayed great courage and initiative.

D/20674 R./S./M. S. J. Oxford, 1st R. Dns. (Winchester).

As regimental serjeant-major he has served with the regiment continuously in the field since September 1914, has always displayed marked devotion to duty, and his conduct in action has been exemplary throughout.

86853 Pte. G. E. Price, M.G.C. (Cav.) (W. Bromwich). (TRANS-CAUCASIA)

For gallant conduct at the battle of Ilidja and the siege of Erzerum, in March 1918.

When the Caucasus Military Agency was captured he showed great fearlessness and devotion.

12971 C./S./M. E. Rothwell, 9th Bn., W. Rid. R., attd. 293rd P. of W. Coy. (Barnoldswick).

He joined the battalion in 1914. Since then he has done splendid work for the battalion. For many months, as a platoon serjeant in the line, he inspired all ranks by his courage and cheerfulness under trying conditions. As C.S.M. he has shown himself to be a born leader, and has inspired the men with that same spirit of cheerfulness and devotion to duty.

225209 Farr./S./Sjt. W. A. Salter, 35th Hy. By., R.G.A. (Charlton, S.E.).

For gallantry and continued devotion to duty. Has served in the field continuously since August 1914, and has rendered invaluable services to his battery, and on several occasions has, by his coolness and presence of mind, saved casualties when the horse lines were shelled or bombed.

21875 Sjt. W. G. Stephenson, 18th Bn., L'pool R. (Birkenhead).

For gallantry and devotion to duty during the period from 8th October to 11th November 1918. On 10th October, when the advance was held up by the River Selle, near Le Cateau, he twice crossed the stream in face of heavy rifle and machine-gun fire. Although he was unable to get many men to cross the stream, his coolness set a fine example to all ranks.

### AUSTRALIAN FORCE.

5185 Sjt. (T./Sqdn./S./M.) N. Dawkins, 1st Sig. Sqdn., Aust. Engrs. (PALESTINE)

During September and October 1918, whilst in command of a cable detachment, this warrant officer showed great energy in maintaining communications. He has on previous occasions done particularly good work under fire.

1324 L./C. T. B. George, 3rd Aust. M.G. Sqdn. (PALESTINE)

For gallantry and good leading at Jenin on the night of the 20th September 1918, when, with his section, he moved along the Nablus Road to take up a position. On the way a large force of the enemy was met with, and L./C. George gave great assistance to his section leader in handling a difficult situation. His prompt and courageous action prevented considerable casualties, and secured a large number of prisoners. He has on several occasions proved himself to be a very fine and fearless soldier.

620 Trpr. G. A. Hill, 12th Aust. L.H.R. (PALESTINE)

For gallantry and devotion to duty during the Jesr El Demia operations in May 1918. He carried despatches repeatedly across fireswept ground, and his daring in watching the movements of the enemy resulted in valuable information. At Mussalaba also his night scouting was of the greatest value. His courage and coolness in action has always been conspicuous.

736 L./C. (T./Cpl.) E. J. Ringrose, 6th Aust. L.H.R. (PALESTINE)

For gallantry and devotion to duty at Amman on the 22nd October 1918. Whilst the squadron was moving down the defile leading into the town a machine-gun opened fire, causing several casualties. Without hesitation Cpl. Ringrose wheeled his section and galloped them straight at the gun, causing the crew to surrender. His courage and initiative was a fine example to all.

1676 Cpl. S. H. Treyvaud, 1st Sig. Sqd., A.M.D. (PALESTINE)

For gallantry and devotion to duty during the operations in the Jordan Valley and Amman area from July to October 1918, when as a despatch rider he showed great tenacity of purpose and set a magnificent example of coolness under fire.

172 Cpl. (L./Sjt.) P. Weatherilt, 2nd Sig. Trp., Aust. Engrs. (PALESTINE)

A fearless despatch rider in action, and no mishap has ever prevented him from getting through with a despatch. In the Amman operations, October 1918, when all wheeled traffic had to be left behind, he succeeded in getting through with his motor-cycle to the 2nd Australian Light Horse Brigade across the mountains of Moab, although under fire and molested by Bedouins. He showed throughout a fearless example, and his devotion to duty was of the highest.

#### NEW ZEALAND FORCE.

7/629 S./S./M. C. S. Bruce, 1st N.Z. M.G. Sqdn. (PALESTINE)

For consistent good work and devotion to duty during operations in Gallipoli, Sinai, Palestine and Syria. His courage and leadership has been outstanding at all times.

7/1051 Sjt. D. Campbell, 1st N.Z. M.G. Sqdn. (PALESTINE)

For gallantry and devotion to duty at Amman on 30th March 1918, when his machinegun having been damaged by hostile fire, he quickly repaired it in action, and opened fire again. He has at all times set a remarkably good example to his men.

7/528 S./S./M. E. Clarkson, Canterbury Mtd. Rif. Regt. (PALESTINE)

He has served continuously with the regiment with the exception of one month when absent from duty on account of wounds. He has frequently led a troop in action with success, and has throughout shown a splendid example to all ranks by his courage and devotion to duty.

SOUTH AFRICAN FORCE.

1067 C./Q./M./S. (A./C./S./M.) A. J. Hendricks, 1st Bn., Cape Corps. (PALESTINE)

For gallantry and devotion to duty near Sinjil on the night of the 18th September; 1918. When his company was heavily engaged and most of the officers had become casualties, he took command of a large party and led them with ability and captured the objective. He has at all times shown great courage and devotion to duty, and his splendid example has inspired confidence in all under his control.

TRADE BOARDS ACTS, 1909 AND 1918.

BRUSH AND BROOM TRADE BOARD (GREAT BRITAIN).

MINIMUM RATES OF WAGES AS FIXED OR VARIED FOR MALE AND FEMALE WORKERS.

EFFECTIVE AS FROM 14TH APRIL 1920.\*

In accordance with the Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour, and dated 31st October 1918, the Trade Board established in Great Britain under the Trade Boards Act, 1918, for the Brush and Broom Trade, as specified in th Trade Boards (Brush and Broom) Order, 1919, having given due notice on 12th January 1920 of Proposal to Fix General Minimum Piece Rates and to Vary Overtime Rates in respect of Male and Female Piece Workers, hereby give notice as required by Section 3 (5) of the Trade Boards Act, 1918, that they have Fixed General Minimum Piece Rates for Male Workers for Pan Work, Hairs, Painting Brush Making, Hand Finishing and Bone Brush Making and for Female Workers for Hand Drawing, and have Varied Overtime Rates in respect of all Male and Female Piece Workers as follows:—

The Minimum Rates for Overtime to apply in substitution for the Minimum Rates otherwise applicable in respect of all hours worked by all Male and Female Piece Workers in excess of the number of hours declared by the Trade Board to be the normal number of hours of work in the trade, shall be as follows, subject to the provisions of Section II. of Part III. of the Schedule to the Notice of the Minimum Rates of Wages fixed, dated 31st December 1919, viz.:—

- (a) For the first two hours' overtime on any day, except Sundays and Customary Public and Statutory Holidays, the Overtime Rate shall be:—
  - (i) For Male Workers, the General Minimum Piece Rate applicable as set out above, or where no General Minimum Piece Rate has been fixed by the Trade Board, a Piece Rate which would yield in the circumstances of the case to an ordinary worker at least the same amount of money as the General Minimum Time Rate, with the addition in both cases of one-quarter of the General Minimum Time Rate, which under the terms of the Trade Board's Notice, dated 31st December 1919, would be applicable to the worker if he were employed on Time Work.
  - (ii) For Female Workers, the General Minimum Piece Rate applicable as set out above above, or, where no General Minimum Piece Rate has been fixed by the Trade Board, a Piece Rate which would yield in the circumstances of the case to an ordinary worker not less than 9\frac{1}{4}d. per hour, with an addition in both cases of 2\frac{6}{16}d. per hour.
- (b) For Overtime after the first two hours of Overtime on any day, except Sundays and Customary Public and Statutory Holidays, the Overtime Rate shall be:—
  - (i) For Male Workers, the General Minimum Piece Rate applicable as set out above, or, where no General Minimum Piece Rate has been fixed by the Trade Board, a Piece Rate which would yield in the circumstances of the case to an ordinary worker at least the same amount of money as the General Minimum Time Rate, with the addition in both cases of one-half of the General Minimum Time Rate which under the terms of the Trade Board's Notice, dated the 31st December 1919, would be applicable to the worker if he were employed on Time Work.
  - (ii) For Female Workers, the General Minimum Piece Rate applicable as set out

- above, or, where no General Minimum. Piece Rate has been fixed by the Trade Board, a Piece Rate which would yield in the circumstances of the case to an ordinary worker not less than  $9\frac{1}{4}$ d. per hour, with an addition in both cases of  $4\frac{5}{8}$ d. per hour.
- (c) For all time worked on Sundays and Customary Public and Statutory Holidays the Overtime Rate shall be:—
  - (i) For Male Workers, the General Minimum Piece Rate applicable as set out above, or, where no General Minimum Piece Rate has been fixed by the Trade Board, a Piece Rate which would yield in the circumstances of the case to an ordinary worker at least the same amount of money as the General Minimum Time Rate, with the addition in both cases of the General Minimum Time Rate which under the terms of the Trade Board's Notice, dated 31st December 1919, would be applicable to the worker if he were employed on time work.
  - (ii) For Female Workers, the General Minimum. Piece Rate applicable as set out above, or, where no General Minimum Piece Rate has been fixed by the Trade Board, a Piece Rate which would yield in the circumstances of the case to an ordinary worker not less than 9½d. per hour, with an addition in both cases of 9½d. per hour.
