DE-WEARING ORDERS, MINIATURE CORATIONS AND MEDALS WITH EVEN-ING DRESS.

By His Majesty's Command the Regulations issued in June 1912, defining the occasions when Orders, Miniature Decorations and Medals are worn with Evening Dress, are cancelled.

In future, Knights Grand Cross and Knights Commanders on all occasions, when wearing the Stars of their Orders will also wear a Riband and Badge.

The following are the occasions upon which Orders, Miniature Decorations and Medals are to be worn with Evening Dress, viz. :-

1. At all Parties and Dinners when the Members of the Royal Family referred to in the attached list are present.

(The host should notify his guests if any of these Members of the Royal Family will be present.)

2. At all Parties and Dinners given in houses of Ambassadors and Ministers accredited to this Court, unless otherwise notified by the Ambassador or Minister concerned.

(A decoration of the Country concerned should be worn in preference to a British one, and if both are worn, the former should take precedence of the latter.)

3. At all Official Dinners and Receptions,

including Naval and Military Dinners, Dinners

of City Livery Companies, and Public Dinners. (The word "Decorations" on the invitation card to be the intimation from the host that the entertainment is an official one.)

4. On official occasions when entertained by :-

The Lord Lieutenant of a County within his County.

Ex-Cabinet Ministers.

Knights of the Order of the Garter.

Knights of the Order of the Thistle.

Knights of the Order of St. Patrick. Great Officers of State and of the King's Household.

Whereas Section 1 of the Profiteering Act, 1919 (9 and 10 Geo. V. c. 66) as amended by the Profiteering (Amendment) Act, 1920 (10 and 11 Geo. V. c. 13) provides that that Section may be applied by Order of the Board of Trade to any article or class of articles declared by the Order to be one or one of a kind in common use by the public or being material, machinery or accessories used in the production thereof.

MALE AND FEMALE WORKERS.

EFFECTIVE AS FROM 4TH JUNE 1920.*

In accordance with Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour, and dated 31st October 1918, the Trade Board, established under the Trade Boards Act, 1918, for the Jute Trade in Great Britain, as specified in the Trade Boards (Jute) Order, 1919, having given due notice on 6th February 1920, of Proposal to Fix General Minimum Time-Rates for Male and Female Workers, hereby give Notice, as required by Section 3 (5) of the Trade Boards Act, 1918, that they have fixed General Minimum Time-Rates for Male and Female Workers, and that the General Minimum Time-Rates fixed are as shown in the Schedule set out below.

And the Trade Board further give Notice that they have received notification from the Minister of Labour that he has made an Order dated 1st June 1920, under Section 4 (2) of the Trade Boards Act, 1918, confirming the General Minimum Time-Rates fixed by the Trade Board, and specifying 4th June 1920,* as the date from which such General Minimum Time-Rates shall become effective.

SCHEDULE.

PART I.

GENERAL MINIMUM TIME-RATES.

SECTION I.-Male Workers.

- Workers of 21 years of age and over, 50s. per week of 48 hours.
- Workers of 18 and under 21 years of age, 45s. per week of 48 hours.
- Workers of 16 and under 18 years of age, 28s. per week of 48 hours.
- Workers under 16 years of age, 22s. per week of 48 hours.

SECTION II.—Female Workers.

- Workers of 18 years of age and over, 32s. per week of 48 hours.
- Workers of 16 and under 18 years of age, 28s. per week of 48 hours.
- Workers under 16 years of age, 22s. per week of 48 hours.

SECTION III.—The above General Minimum Time-Rates are weekly rates, based on a week of 48 hours, but they shall be subject to a proportionate deduction or increase, according as the number of hours spent by the worker in the factory or workshop under contract of employment in any week is less or more than 48.

PART II.

The respective General Minimum Time-Rates set out in Part I. of this Schedule shall apply, subject to the provisions of the Trade Boards Acts and of this Notice, to all Male and Female Workers in Great Britain who are employed

* Should this date not correspond with the beginning of the period for which wages are paid by an employer who pays wages at intervals not exceeding seven days, the rates shall become effective as from the beginning of the next full-pay period, but in any case not later than 10th June 1920.

during the whole or any part of their time in any branch of the trade specified in the Trade Boards (Jute) Order, 1919, that is to say :-

The preparing, spinning, or weaving (a) of jute or (b) of jute and any other fibre except flax or hemp,

Including :

- (1) The preparing and spinning of waste reclaimed at any stage, and
- (2) All packing, despatching, warehousing, storing, or other operations incidental to or appertaining to any of the abovementioned work,

But excluding :

- (1) The calendering, bleaching, dyeing or finishing of any of the above-mentioned materials, and
- (2) The preparing, or spinning of materials required for the making or re-making of (a) rope (including driving rope and banding), (b) cord (including blind and window cord, but excluding silk, worsted and other fancy cords), (c) core for wire ropes, (d) lines, (e) twine including binder and trawl twine). (f) lanyards, (g) net and similar articles, when such preparing or spinning is carried on in the same factory or workshop as the said making or remaking, and
- (3) The making or repair of sacks or bags, and also
- (4) The weaving of carpets, rugs or mats.

PART III.

SECTION I.—The above General Minimum Time-Rates shall be paid clear of all deductions other than deductions under the National Insurance Act, 1911, as amended by any subsequent enactments, or deductions authorised by any Act to be made from wages in respect of contributions to any superannuation or other provident fund.

SECTION II .- The above General Minimum Time-Rates are without prejudice to workers who are earning higher rates of wages.

It is provided by the above-mentioned Regulations that :-

Every Occupier of a factory or workshop or of any place used for giving out work to out-workers shall, on receipt of this Notice, post up and keep posted up a sufficient number of true copies thereof in prominent positions in the factory, workshop or place used for giving out work, in such a manner as to ensure that in each case the Notice shall be brought to the knowledge of all workers employed by him or on his premises who are affected thereby. Penalty for non-compliance, a fine not exceeding 40s.

Under the Trade Boards Acts, 1909 and 1918, it is provided amongst other things that :-

1. Where any minimum rate of wages fixed by a Trade Board has become effective, an employer shall, in cases to which the minimum ! not paid wages at less than the minimum rate.

rate is applicable, pay wages to the person employed at not less than the minimum rate clear of all deductions, and if he fails to do soshall be liable on summary conviction in respect of each offence to a fine not exceeding twenty pounds and to a fine not exceeding five pounds for each day on which the offence is continued after conviction therefor.

In the foregoing provision, the expression "deductions" includes deductions for or in respect of any matter whatsoever (other than deductions under the National Insurance Act, 1911, asamended by any subsequent enactments or deductions authorised by any Act to be made from wages in respect of contributions to any superannuation or other provident fund), and notwithstanding that they are deductions which may lawfully be made from wages under the provisions of the Truck Acts, 1831 to 1896, and where any payment being a payment authorised to be received by an employer under section one, section two, or section three of the Truck Act, 1896, is made by any employed person to his. employer, the employer shall, for the purposes. of the foregoing provision, be deemed to have deducted that amount from wages.

On the conviction of an employer for failing to pay wages at not less than the minimum rate to a person employed, the Court may by the conviction adjudge the employer convicted to. pay, in addition to any fine, such sums as appears to the court to be due to the person employed on account of wages, the wages being calculated on the basis of the minimum rate, but the power to order the payment of wages under this provision shall not be in derogation of any right of the person employed to recover wages by any other proceedings.

2. If a Trade Board are satisfied that any worker employed, or desiring to be employed, in any branch of a trade to which a general minimum time-rate, a guaranteed time-rate or a time-work overtime rate is applicable is affected by any infirmity or physical injury which renders. him incapable of earning that minimum rate, and where the worker is not already employed on piece work, are of opinion that the case cannot suitably be met by employing him on piecework, the Trade Board may, if they think fit, grant to the worker, subject to such conditions, if any, as they prescribe, a permit exempting the employment of the worker from the provisions of this Act relating to the payment of wages at less than the minimum rate, and, while the permit is in force, the employer shall not be liable for paying wages to the worker at a rate less than the minimum rate so long as the conditions prescribed by the Trade Board on the grant of the permit are complied with.

3. It shall be the duty of every employer in a trade to which a minimum rate is applicable to keep such records of wages as are necessary to show that the provisions of this Act are being: complied with as respects persons in his employment, and if he fails to do so, he shall be liable on summary conviction in respect of each offence to a fine not exceeding two pounds, and also to a fine not exceeding one pound for every day during which the default continues after conviction.

On any prosecution of a person for failing topay wages at not less than the minimum rate, it shall lie on that person to prove that he has

Any agreement for the payment of wages in contravention of the provisions of the Acts shall be void.

4. An employer shall, in cases where persons are employed on piece-work and a general minimum time-rate but no general minimum piece-rate has been fixed be deemed to pay wages at less than the minimum rate---

- (a) In cases where a special minimum piecerate has been fixed under the provisions of this Act for persons employed by that employer, if the rate of wages is less than that special minimum piece-rate ; and
- (b) In cases where a special minimum piecerate has not been so fixed, unless he shows that the piece-rate of wages paid would yield, in the circumstances of the case, to an ordinary worker at least the same amount of money as the basis-rate.

For the purpose of this section the expression ""basis-rate" means the general minimum timerate, or, where a rate (*i.e.*, a "piece-work basis time-rate") has been fixed by the Trade Board for the purpose of being substituted for the general minimum time-rate as the basis-rate, the rate so fixed.

5. (1) Where a worker in any trade being a person to whom a minimum rate of wages fixed by a Trade Board applies, is an apprentice or learner, it shall not be lawful for his employer to receive directly or indirectly from him, or on his behalf or on his account, any payment by way of premium :

Provided that nothing in the foregoing provision shall apply to any such payment duly made in pursuance of any instrument of apprenticeship, not later than four weeks after the commencement of the employment.

(2) If any employer acts in contravention of this provision, he shall be liable on summary conviction in respect of each offence to a fine not exceeding twenty pounds, and the Court may by the conviction, in addition to imposing a fine, adjudge him to repay to the worker or other person by whom the payment was made the sum improperly received by way of premium.

6. For the purpose of calculating the amount of the wages payable in the case of a worker employed on any work for which a minimum rate of wages has been fixed under the principal Act, the worker shall be deemed to have been employed during all the time during which he was present on the premises of the employer, unless the employer proves that he was so present without the employer's consent, express or implied, or that he was so present for some purpose unconnected with his work and other than that of waiting for work to be given to him to perform, and in the case of a worker employed on piece-work shall be deemed during any time during which he was so present and was not doing piece-work to have been employed at the general minimum time-rate applicable to workers of the class to which he belongs :

Provided that-

- (a) where a worker resides on the premises of the employer he shall not be deemed to be employed during any time during which he is present on the premises by reason only of the fact that he is so resident; and
- (b) a worker while present during normal meal times in a room or place in which

no work is being done shall be deemed to be present for a purpose unconnected with his work.

PROPOSAL TO FIX MINIMUM RATES OF WAGES FOR FEMALE AND MALE WORKERS.

In accordance with Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour, and dated 31st October 1918, the Trade Board established in Great Britain under the Trade Boards Act, 1918, for the Stamped or Pressed Metal Wares Trade as specified in the Trade Boards (Stamped or Pressed Metal Wares) Order, 1919, hereby give Notice as required by Section 3 (5) of the Trade Boards Act, 1918, that they propose to fix General Minimum Time-Rates and Overtime Rates for Male and Female Workers, and also Piece-work Basis Time Rates for Female Workers, and to declare the normal number of hours of work in the Trade for the purpose of the application of the Overtime Rates, as follows :--

PART I.

PROPOSED GENERAL MINIMUM TIME-RATES FOR MALE AND FEMALE WORKERS.

SECTION (i).-Male Workers.

- Workers of 21 years of age and over, 1s. $4\frac{1}{2}d$. per hour.
- Workers of 20 and under 21 years of age, 1s. 2d. per hour.
- Workers of 19 and under 20 years of age, $11\frac{1}{2}d$. per hour.
- Workers of 18 and under 19 years of age, 9d. per hour.
- Workers of 17 and under 18 years of age, 8d. per hour.
- Workers of 16 and under 17 years of age, 7d. per hour.
- Workers of 15 and under 16 years of age, 6d. per hour.

Workers under 15 years of age, $4\frac{1}{2}d$. per hour.

SECTION (ii).—Female Workers.

Workers of 18 years of age and over, 9d. per hour.

- Workers of 17 and under 18 years of age, $7\frac{1}{2}d$. per hour.
- Workers of 16 and under 17 years of age, 6¹/₂d. per hour.

Workers of 15 and under 16 years of age, $5\frac{1}{2}d$. per hour.

Workers under 15 years of age, 4d. per hour.

Provided that in the case of Female Workers entering the trade for the first time at or over the age of 18 years the General Minimum Time-Rate applicable during the first two months of employment shall be 8d. per hour.

PART II.

PROPOSED PIECE-WORK BASIS TIME-RATES FOR FEMALE WORKERS,

Workers of 18 years of age and over, 10d. per hour.

- Workers of 17 and under 18 years of age, 8¹/₂d. per hour.
- Workers of 16 and under 17 years of age, $7\frac{1}{2}d$. per hour.
- Workers of 15 and under 16 years of age, $6\frac{1}{2}d$. per hour.

Workers under 15 years of age, 5d. per hour.

In the case of Female Workers employed on Piece-work each Piece-Rate paid shall be such .as would yield, in the circumstances of the case, to an ordinary worker, at least the equivalent of the appropriate Piece-work Basis Time-Rate.

PART III.

PROPOSED OVERTIME RATES FOR MALE AND FEMALE WORKERS (ALL AGES).

SECTION (i).—In accordance with Section 3 (i) (c) of the Trade Boards Act, 1918, the Trade Board propose to declare the normal number of hours of work in the trade to be as follows :—

In any week			47
On Saturday	••	••	4 <u>1</u>

Provided that all hours worked on Sundays and on Statutory Holidays shall be regarded as Overtime to which the Overtime Rates shall apply.

SECTION (ii).—The Trade Board propose to fix for all Male and Female Workers, Overtime Rates in respect of hours worked by a worker in excess of the declared normal number of hours in the trade as follows, that is to say :—

- (a) For all hours worked on Sundays and Statutory Holidays the Overtime Rate shall be equivalent to Double Time (that is to say, Twice the Minimum Rate otherwise applicable).
- (b) For all hours worked in excess of four-anda-half on Saturday, the Overtime Rate shall be equivalent to Time-and-a-Half (that is to say, One-and-a-Half times the Minimum Rate otherwise applicable), notwithstanding that the total number of hours worked in the week does not exceed 47.
- (c) For all hours worked in excess of 47 in any week, the Overtime Rate shall be equivalent to Time-and-a-Quarter for the first two hours and Time-and-a-. Half thereafter, except in so far as higher Overtime Rates are payable under the provisions of Sub-Sections (a) and (b) of this Section.

NOTE.—The hours which female workers and young persons are allowed to work are subject to the provisions of the Factory and Workshop Act, 1901.

PART IV.

The above proposed Minimum Rates of Wages shall apply, subject to the provisions of the Trade Boards Acts and of this Notice, to all workers who are employed during the whole or any part of their time in any branch of the trade specified in the Trade Boards (Stamped or Pressed Metal Wares) Order, 1919, that is to .say :--

The manufacture from metals (other than precious metals) by the processes of cold stamping or cold pressing (including cutting or piercing) of cabinet fittings, window fittings, curtain Britain), 5 Chancery Lane, London, W.C. 2.

accessories, stationers' sundries, drapers' sundries, fittings for gas or electric light, fittings for suit-cases or handbags or purses, buckles, eyelets, ferrules, labels, collar studs, tie-clips, thimbles, photograph frames, stamped chains, bells, fancy nails (excluding the shanks), parts of safety razors (excluding the blades), parts of braces or suspenders, corset steels or busks, whistles, tin-openers, medals or any similar articles or metal parts of such articles;

Including—

- (a) The operations of annealing, hardening, barrelling, polishing, bionzing, nickelling, lacquering, japanning, non - vitreous enamelling, tinning or assembling, where these operations are carried on in association with or in conjunction with the manufacture of such stamped or pressed metal articles;
- (b) The operations of carding, boxing, packeting, labelling, weighing, packing, warehousing or despatching, where these operations are incidental to or appertaining to the manufacture of such stamped or pressed metal articles;

But excluding-

- (a) The operations specified in the Trade Boards (Hollow-ware) Order, 1913;
- (b) The making of buttons or any operations incidental thereto;
- (c) The making of coffin furniture or any operations incidental thereto;
- (d) The making of pins, hairpins, hooks and eyes, hair-curlers, snap fasteners or safety pins or any operations incidental thereto;
- (e) The making of steel pens and the making of stationers' metal sundries or other similar metal articles when carried on as a subsidiary branch of work in association with or in conjunction with the making of steel pens, so as to provide a common or interchangeable form of employment for the workers;
- (/) The minting of coinage of the realm;
- (g) The process of hand-embossing.

PART V.

SECTION I.—The above proposed Minimum Rates of Wages shall be paid clear of all deductions, other than deductions under the National Insurance Act, 1911, as amended by any subsequent enactments, or deductions authorised by any Act to be made from wages in respect of contributions to any superannuation or other provident fund.

SECTION II.—The above Minimum Rates of 'Wages are without prejudice to workers who are earning higher rates of wages, or to agreements made or that may be made between employers and workers for the Payment of Wages in excess of these Minimum Rates of Wages.

The Trade Board will consider any Objections to the above Proposals which may be lodged with them within two months from the 5th June 1920. Such Objections should be in writing and signed by the person making the same (adding his or her full name and address), and should be sent to The Secretary, Stamped or Pressed Metal Wares Trade Board (Great Britain), 5 Chancery Lane, London, W.C. 2. It is desirable that the Objections should state | precisely, and so far as possible with reasons, | what is objected to.

COAL MINES ACT, 1911.

The Secretary of State for the Home Department gives notice that, on the 3rd June 1920, in pursuance of Section 86 of the Coal Mines Act, 1911, he made General Regulations (in substitution for the General Regulations made under the Act on the 9th September 1913) to apply to all mines under the Act in which ganister or other stone containing not less than 80 per cent. of silica (S_1O_2) is worked with a view to sale or manufacture. The Regulations will come into force on the 1st July 1920.
