“And whereas Your Majesty was graciously pleased, by Your Order in Council, dated the 22nd day of January 1920, to sanction, *inter alia*, the payment of certain allowances to Accountant Officers performing the duties of Secretary to a Chief of the Staff or Chief Staff Officer:

“And whereas we are of opinion that similar allowances should be paid to Accountant Officers performing the duties of Secretary to a Captain of the Fleet:

“We beg humbly to recommend that Your Majesty may be graciously pleased by Your

“Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, *inter alia*, that all pay, pensions, or other allowances in the nature thereof, payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer Seaman, or Marine therein, shall be paid in such manner, and subject to such restrictions, conditions, and provisions as are from time to time directed by Order in Council :

“And whereas by His late Majesty's Order in Council, dated the 11th day of June 1902, Officers vacating the appointment of Adjutant-General, Royal Marines, were granted a higher rate of Half-Pay and Retired Pay than other Officers of corresponding rank :

“And whereas under the provisions of Your Majesty's Order in Council of the 22nd day of January 1920, the rates of Half-Pay and Retired Pay for General Officers, Royal Marines, are dependent upon their rank irrespective of whether such Officers have held the appointment of Adjutant-General, Royal Marines :

“And whereas we are of opinion that an Officer of the rank of Major-General who has held the appointment of Adjutant-General, Royal Marines, has a claim to a higher rate of Half-Pay and Retired Pay than an Officer of the same rank who has not held that appointment :

“We beg leave humbly to recommend that on vacating the appointment of Adjutant-General, Royal Marines, an Officer holding the rank of Major-General, Royal Marines, may be granted the Half-Pay of a Lieutenant-General, Royal Marines, and if retired on the former rank may be granted on retirement Retired Pay on the scale authorised for a Lieutenant-General, Royal Marines :

“The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in this proposal.”

His Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of His Privy Council, to approve of what is therein proposed.

And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly.

Notice of denunciation of the Convention respecting Commercial relations between France and the Seychelles Islands, signed at London, April 16th, 1902, was given by the French Government on September 10th, 1918, and was published in the London Gazette of October 15th, 1918. Since the expiration of the period of denunciation, the Convention has remained in operation subject to three months' notice on either side.

His Majesty's Government having decided to terminate this Convention, notice to that effect was given to the French Government by His Majesty's Ambassador in Paris on the 5th instant.

In accordance with this notice, the Convention will cease to have effect on September 5th next.

THE PROFITEERING ACTS, 1919 AND 1920, ORDER (No. 10), DATED JULY 2ND, 1920, MADE BY THE BOARD OF TRADE UNDER SECTION 1 OF THE PROFITEERING ACT, 1919 (9 & 10 Geo. 5, c. 66), AS AMENDED BY THE PROFITEERING (AMENDMENT) ACT, 1920 (10 & 11 Geo. 5, c. 13).

Whereas Section 1 of the Profiteering Act, 1919 (9 & 10 Geo. 5, c. 66) as amended by the Profiteering (Amendment) Act, 1920 (10 & 11 Geo. 5, c. 13) provides that that Section may be applied by Order of the Board of Trade to any article or class of articles being an article or class of articles declared by the Order to be one or one of a kind in common use by the public or being material, machinery or accessories used in the production thereof.

Now, therefore, the Board of Trade do hereby declare that the articles set out in the Schedule annexed hereto are articles of a kind in common use by the public, and do hereby order that Section 1 of the Profiteering Act, 1919 (9 & 10 Geo. 5, c. 66) as amended by the Profiteering (Amendment) Act, 1920 (10 & 11 Geo. 5, c. 13) shall apply to each article or class of articles mentioned in the Schedule hereto.

This Order shall come into force as from the fifth day of July 1920, and may be cited as the Profiteering Acts, 1919 and 1920, Order (No. 10).

TRADE BOARDS ACTS, 1909 AND 1918.

NOTICE OF INTENTION TO MAKE A SPECIAL ORDER, TO BE CITED AS THE TRADE BOARDS (FISH, POULTRY, GAME AND RABBITS DISTRIBUTIVE) ORDER, 1920.

The Minister of Labour hereby gives notice that he intends, pursuant to the powers conferred upon him by Section 1 of the Trade Boards Acts, 1918, to make a Special Order applying the Trade Boards Acts, 1909 and 1918, to the trade specified in the Appendix to this notice.

Copies of the Draft Special Order may be obtained on application in writing to the Secre-

tary, Ministry of Labour, Montagu House, Whitehall, London, S.W. 1.

Objections to the Draft Special Order must be sent to the above address within forty-two days from the 2nd July 1920.

Every objection must be in writing and must state :—

- (a) the specific ground for objection ; and
- (b) the omissions, additions or modifications asked for.

APPENDIX.

TRADE.

The Fish, Poultry, Game and Rabbits Distributive Trade, that is to say :—

(1) The wholesale or retail sale for human consumption off the premises of fish, poultry, game or rabbits in or in connection with any establishment or business or branch or department in which such sale is the main or principal business of that establishment or business or branch or department.

(2) The sale of any goods or the cooking, preparing or serving for sale of food or drink for consumption on or off the premises when performed in or in connection with and by workers principally engaged in an establishment or business or branch or department of the kind specified in paragraph 1 above.

Including :—

The following or similar operations when incidental to or carried on in conjunction with the operations specified in paragraph 1 or 2 above.

- (i) Checking, grading, sorting.
- (ii) Weighing, boiling, cutting, gutting, cleaning, cleansing, dressing, freshening, shelling, opening, filleting, spitting, curing, smoking, plucking, trussing, skinning, boning.
- (iii) Labelling, ticketing, barrelling, bundling, packing, unpacking, parcelling, bagging, boxing, basketing.
- (iv) Collecting, delivering, despatching, portering, loading, unloading, lift or hoist operating, time-keeping, cleaning or heating premises.
- (v) Storing, stock-keeping, warehousing, cold storing, refrigerating.
- (vi) Cleaning, adjusting or sharpening implements, cleaning utensils or receptacles. Window or show-case dressing.
- (vii) Horse or motor keeping, care of vehicles.
- (viii) Clerical work, buying, commercial travelling or canvassing.

But excluding :—

- (a) The sale or cooking or preparing or serving for sale of fried fish when carried on as a main or principal business and sales of any goods and any operations when carried on in connection with, and by workers principally engaged in, such business.
- (b) The sale of tinned fish when carried on as a distinct business, or as subsidiary to a

business not of the kind specified in (1) or (2) above ; and sales of any goods and any operations when carried on in connection with, and by workers principally engaged in, such business.

(c) Operations performed by workers employed in an establishment or business or branch or department principally engaged in the curing or smoking of fish.

(d) The sale of goods for export and operations incidental thereto, except when carried on in association with the sale of goods for consumption within the United Kingdom.

(e) Operations performed by workers employed by wholesale merchants or brokers who do not employ warehouse workers or carters.

(f) Operations performed by workers employed in boats or ships or in operations incidental to fishing.

(g) Operations of cleaning or maintenance of premises and operations performed at docks, wharves, or warehouses or elsewhere when such operations are performed by workers not directly employed by employers engaged in a business of the kind specified in (1) and (2) above.

(h) Operations performed by common carriers or by workers in any industry or trade concerned exclusively with carting and operations incidental thereto.

(i) Operations performed by workers in or in connection with any establishment or business or branch or department principally engaged in the production of fish at hatcheries or fish farms, or the rearing of poultry or game or rabbits.

(j) Post Office business.

(k) Operations included in the Trade Boards (Sugar Confectionery and Food Preserving) Order, 1913.
