TRADE BOARDS ACTS, 1909 AND 1918.

AERATED WATERS TRADE BOARD (SCOTLAND).

PROPOSAL TO VARY GENERAL MINIMUM TIME-RATES AND OVERTIME RATES FOR CERTAIN CLASSES OF MALE AND FEMALE WORKERS.

In accordance with Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour, and dated 31st October 1918, the Trade Board established in Scotland under the Trade Boards Act, 1918, for the Aerated Waters Trade, as specified in the Trade Boards (Aerated Waters) Order, 1919, hereby give notice as required by Section 3 (5) of the Trade Boards Act, 1918 (the Minister of Labour having given his consent to such notice being given), that they Propose to Vary the General Minimum Time-Rates and Overtime Rates as set out in their notice dated 11th June 1920, in their application to certain classes of Male and Female Workers, the proposed variation of the Minimum Rates of Wages being as shown in the Schedule set out below :—

SCHEDULE.

PART I.

Proposed Variation of General Minimum Time-Rates for Certain Classes of Male and Female Workers.

SECTION I.

For Male Workers of 21 years of age and over, from 1s. 2d. per hour to 1s. 3d. per hour. SECTION II.

For Female Workers of 18 years of age and over, with not less than six months' experience in the trade, from $7\frac{1}{2}d$. per hour to 8d. per hour.

PART II.

Proposed Variation of Overtime Rates for Certain Classes of Male and Female Workers.

Overtime Rates calculated on the General Minimum Time-Rates specified in Part I. of this Schedule, in the manner set out in Part II. of the Schedule to the notice issued by the Trade Board dated 11th June 1920, fixing Minimum Rates of Wages for Male and Female Workers, shall apply in substitution for the General Minimum Time-Rates set out in Part I. of this Schedule in respect of hours worked in excess of the number of hours declared by the Trade Board, in the said notice dated 11th June 1920, to be the normal number of hours of work in the trade.

PART III.

The above Minimum Rates of Wages shall apply subject to the provisions of the Trade Boards Acts and of this notice, to all workers in Scotland who are employed during the whole or any part of their time in any branch of the trade specified in the Trade Boards (Aerated Waters) Order, 1919, that is to say :--

The manufacture, wherever carried on, of mineral or aerated waters, non-alcoholic cordials, flavoured syrups, unfermented sweet drinks, and other similar beverages, and the manufacture in unlicensed premises of brewed liquors. *including*—

(a) the operations of bottle washing, bottling and filling, and all other operations preparatory to the sale of any of the aforesaid liquors in bottles, jars, syphons, casks, or other similar receptacles;

and including also-

(b) the operations of bottle washing, bottling and filling, and all subsidiary operations preparatory to the sale in bottles, jars, or other similar receptacles, of cider, ale, stout, porter, and other alcoholic beers, where all or any of such last-mentioned operations are, or is, conducted or carried on in association with or in conjunction with all or any of the operations specified under (a) above so as to form a common or interchangeable form of employment for workers, and whether the two sets of operations or any of them are, or is, carried on simultaneously or not.

PART IV.

The above Minimum Rates of Wages shall be paid clear of all deductions, other than deductions under the National Insurance Act, 1911, as amended by any subsequent enactments, or deductions authorised by any Act to be made from wages in respect of contributions to any superannuation or other provident fund.

SECTION II.

SECTION I.

The above Minimum Rates of Wages are without prejudice to workers who are earning higher rates of wages.

The Trade Board will consider any Objections to the above Proposal to Vary which may be lodged with them within two months from 6th July 1920. Such Objections should be in writing, and signed by the person making the same (adding his or her full name and address), and should be sent to the Secretary of the Aerated Waters Trade Board (Scotland), 5 Chancery Lane, London, W.C. 2.

It is desirable that the Objections should state precisely, and so far as possible with reasons, what is objected to.

It is provided by the above-mentioned Regulations that :---

Every Occupier of a factory or workshop or of any place used for giving out work to outworkers, shall, on receipt of this Notice, post up and keep posted up a sufficient number of true copies thereof in prominent positions in the factory, workshop or place used for giving out work, in such a manner as to ensure that in each case the Notice shall be brought to the knowledge of all workers employed by him or on his premises who are affected thereby. Penalty for non-compliance, a fine not exceeding 40s.

Under the Trade Boards Acts, 1909 and 1918, it is provided amongst other things that :-- 1. Where any minimum rate of wages fixed by a Trade Board has become effective, an employer shall, in cases to which the minimum rate is applicable, pay wages to the person employed at not less than the minimum rate clear of all deductions, and if he fails to do so shall be liable on summary conviction in respect of each offence to a fine not exceeding twenty pounds and to a fine not exceeding five pounds for each day on which the offence is continued after conviction therefor.

In the foregoing provision, the expression "deductions "includes deductions for or in respect of any matter whatsoever (other than deductions under the National Insurance Act, 1911, as amended by any subsequent enactments or deductions authorised by any Act to be made from wages in respect of contributions to any superannuation or other provident fund), and notwithstanding that they are deductions which may lawfully be made from wages under the provisions of the Truck Acts, 1831 to 1896, and where any payment being a payment authorised to be received by an employer under Section I., Section II., or Section III. of the Truck Act, 1896, is made by any employed person to his employer, the employer shall, for the purposes of the foregoing provision, be deemed to have deducted that amount from wages.

On the conviction of an employer for failing to pay wages at not less than the minimum rate to a person employed, the Court may by the conviction adjudge the employer convicted to pay, in addition to any fine, such sum as appears to the Court to be due to the person employed on account of wages, the wages being calculated on the basis of the minimum rate, but the power to order the payment of wages under this provision shall not be in derogation of any right of the person employed to recover wages by any other proceedings.

2. If a Trade Board are satisfied that any worker employed, or desiring to be employed, in any branch of a trade to which a general minimum time-rate, a guaranteed time-rate or a time-work overtime rate is applicable is affected by any infirmity or physical injury which renders him incapable of earning that minimum rate, and where the worker is not already employed on piece-work, are of opinion that the case cannot suitably be met by employing him on piece-work, the Trade Board may, if they think fit, grant to the worker, subject to such conditions, if any, as they prescribe, a permit exempting the employment of the worker from the provisions of this Act relating to the payment of wages at less than the minimum rate, and, while the permit is in force, the employer shall not be liable for paying wages to the worker at a rate less than the minimum rate so long as the conditions prescribed by the Trade Board on the grant of the permit are complied with.

3. It shall be the duty of every employer in a trade to which a minimum rate is applicable, to keep such records of wages as are necessary to show that the provisions of this Act are being complied with as respects persons in his employment, and if he fails to do so, he shall be liable on summary conviction in respect of each offence to a fine not exceeding two pounds, and also to a fine not exceeding one pound for every day during which the default continues after conviction.

On any prosecution of a person for failing to pay wages at not less than the minimum rate, it shall lie on that person to prove that he has not paid wages at less than the minimum rate.

Any agreement for the payment of wages in contravention of the provisions of the Acts shall be void.

4. An employer shall, in cases where persons are employed on piece-work and a general minimum time-rate but no general minimum piece-rate has been fixed, be deemed to pay wages at less than the minimum rate :—

- (a) In cases where a special minimum piecerate has been fixed under the provisions of this Act for persons employed by that employer, if the rate of wages is less than that special minimum piece-rate; and
- (b) In cases where a special minimum piecerate has not been so fixed, unless he shows that the piece-rate of wages paid would yield, in the circumstances of the case, to an ordinary worker at least the same amount of money as the basisrate.

For the purpose of this section the expression "basis-rate" means the general minimum timerate or, where a rate (*i.e.*, a "piece-work basis time-rate") has been fixed by the Trade Board for the purpose of being substituted for the general minimum time-rate as the basis-rate, the rate so fixed.

5. (1) Where a worker in any trade being a person to whom a minimum rate of wages fixed by a Trade Board applies, is an apprentice or learner, it shall not be lawful for his employer to receive directly or indirectly from him, or on his behalf or on his account, any payment by way of premium;

Provided that nothing in the foregoing provisions shall apply to any such payment duly made in pursuance of any instrument of apprenticeship, not later than four weeks after the commencement of the employment.

(2) If any employer acts in contravention of this provision, he shall be liable on summary conviction in respect of each offence to a fine not exceeding twenty pounds, and the court may by the conviction, in addition to imposing a fine adjudge him to repay to the worker or other person by whom the payment was made the sum improperly received by way of premium.

6. For the purpose of calculating the amount of the wages payable in the case of a worker employed on any work for which a minimum rate of wages has been fixed under the principal Act, the worker shall be deemed to have been employed during all the time during which he was present on the premises of the employer, unless the employer proves that he was so present without the employer's consent, express or implied, or that he was so present for some purpose unconnected with his work and other than that of waiting for work to be given to him to perform, and in the case of a worker employed on piece-work shall be deemed during any time during which he was so present and was not doing piece-work to have been employed at the general minimum time-rate applicable to workers of the class to which he belongs :-

Provided that—

(a) where a worker resides on the premises of the employer he shall not be deemed to be employed during any time during which he is present on the premises by reason July 1920.

only of the fact that he is so resident; and

(b) a worker while present during normal meal times in a room or place in which no work is being done shall be deemed to be present for a purpose unconnected with his work.

TRADE BOARDS ACTS, 1909 AND 1918.

BUTTON-MAKING TRADE BOARD (GREAT BRITAIN).

MINIMUM RATES OF WAGES FIXED FOR MALE and Female Workers other than Home-Workers. Effective as from 7th July 1920.*

In accordance with Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour and dated 31st October 1918, the Trade Board established in Great Britain under the Trade Boards Act, 1918, for the Button-Making Trade as specified in the Trade Boards (Button-Making) Order, 1919, having given due notice on 26th March 1920 of Proposal to Fix General Minimum Time-Rates, Piece-work Basis Time-Rates, and Overtime Rates for Male and Female Workers other than home-workers) hereby give notice, as required by Section 3 (5) of the Trade Boards Act, 1918, that they have fixed General Minimum Time-Rates, Piece-work Basis Time-Rates, and Overtime Rates for Male and Female Workers, and have declared the normal number of hours of work in the trade for the purposes of the application of the Overtime Rates, and that the Minimum Rates of Wages as fixed are as shown in the Schedule set out below, which is incorporated herewith.

And the Trade Board further give notice that they have received notification from the Minister of Labour that he has made an Order dated 1st July 1920, under Section 4 (2) of the Trade Boards Act, 1918, confirming the Minimum Rates of Wages as fixed by the Trade Board, and specifying 7th July 1920,* as the date from which such Minimum Rates of Wages shall become effective.

SCHEDULE.

PART I.

GENERAL MINIMUM TIME-RATES.

A.—Male Workers.

SECTION I.—For Male Workers employed in Stamping, Burnishing, Spinning, Dipping, Staining, Sawing, Turning, or Cutting (other than Cutting on Wet Lathes) :—

 Workers of 21 years of age and over (a) who have had not less than two years' experience in one or more of the aforesaid operations, 1s. 6d. per hour; '(b) who have had not less than one but less than two years' experience in one or more of the aforesaid operations, 1s. 5d. per hour;

* Should this date not correspond with the beginning of the period for which wages are paid by an employer who pays wages at intervals not exceeding seven days, the rates shall become effective as from the beginning of the next full pay period, but in any case not later than 13th July 1920.

(c) who have had less than one year's experience in one or more of the aforesaid operations, 1s 4d. per hour.

- 2. Workers of 20 and under 21 years of age, 1s. 3d. per hour.
- 3. Workers of 19 and under 20 years of age, ls. per hour.
- 4. Workers of 18 and under 19 years of age, 10d. per hour.

SECTION II.—For all other Male Workers of 18 years of age and over :—

- 1. Workers of 21 years of age and over, 1s 3¹/₂d. per hour.
- 2. Workers of 20 and under 21 years of age, 1s 2d. per hour.
- 3. Workers of 19 and under 20 years of age, 1s. 1d. per hour.
- 4. Workers of 18 and under 19 years of age, 1s. per hour.

SECTION III.—For all Male Workers under 18 years of age :—

- Workers of 17 and under 18 years of age, 8½d. per hour.
- 2. Workers of 16 and under 17 years of age, 6d. per hour.
- 3. Workers of 15 and under 16 years of age, 5d. per hour.
- 4. Workers under 15 years of age, 4d. per hour.

B.—Female Workers.

- 1. Workers of 18 years of age and over, 8¹/₂d. per hour.
- Workers of 17 and under 18 years of age, 7½d. per hour.
- 3. Workers of 16 and under 17 years of age, 6d. per hour.
- Workers of 15 and under 16 years of age, 5d. per hour.
- 5. Workers under 15 years of age, 4d. per hour.

PART II.

PIECE-WORK BASIS TIME-RATES.

SECTION I.—For Male Workers employed in Stamping, Burnishing, Spinning, Dipping, Staining, Sawing, Turning, or Cutting (other than Cutting on Wet Lathes), 1s. 10¹/₂d. per hour.

In the case of all Male Workers employed on Piece-work in Stamping, Burnishing, Spinning, Dipping, Staining, Sawing, Turning, or Cutting (other than Cutting on Wet Lathes), each Piece-Rate paid must be such as would yield, in the circumstances of the case, not less than 1s. 10¹/₂d. per hour to an ordinary Male Worker (*i.e.*, a Male Worker of ordinary skill and experience in these processes).

SECTION II.—For all Female Workers, 10d. per hour.

In the case of all Female Workers employed on Piece-work, each Piece-Rate paid must be such a swould yield, in the circumstances of the case, not less than 10d. per hour to an ordinary Female Worker (*i.e.*, a Female Worker of ordinary skill and experience in the circumstances in question).

PART III.

OVERTIME RATES FOR MALE AND FEMALE Workers.

SECTION I.—In accordance with Section 3 (1) (c) of the Trade Boards Act, 1918, the Trade Board

hereby declare the normal number of hours of work in the trade to be as follows :---

In any week			47
On Saturday	••	••	5

Provided that all hours worked on Sundays and on Customary Public and Statutory Holidays shall be regarded as Overtime.

SECTION II.—The Minimum Rates for Overtime for Male Workers employed on Time-work, and for all Female Workers, in respect of hours worked by a worker in excess of the declared normal number of hours of work in the trade, shall be as follows, that is to say :—

(a) Male and Female Workers employed on Time-work :—

(1) For all hours worked on Sundays and on Customary Public and Statutory Holidays the Overtime Rate shall be twice the general minimum time-rate applicable, *i.e.*, double time.

Provided that the said Overtime Rate shall not apply—(i) in respect of time worked on Good Friday in the case of workers who are given Easter Tuesday as a holiday in lieu of Good Friday; or (ii) in respect of time worked on Easter Tuesday in the case of workers who are given Good Friday as a holiday in lieu of Easter Tuesday.

(2) For all hours worked in excess of five on Saturdays, the Overtime Rate shall be oneand-a-quarter times the general minimum time-rate applicable, *i.e.*, time-and-a-quarter, except in so far as higher Overtime Rates are payable under the provisions of paragraph (1) of Sub-Section (a) of this Section.

(3) For all hours worked in excess of 47 in any week, the Overtime Rate shall be one-anda-quarter times the general minimum timerate applicable, *i.e.*, time-and-a-quarter, except in so far as higher Overtime Rates are payable under the provisions of paragraph (1) of Sub-Section (a) of this Section.

(b) Female Workers employed on Piece-Work.

Female Workers employed on Piece-work shall receive in respect of each hour worked in excess of 47 hours in any week, in addition to payment at Piece-Rates each of which would yield, in the circumstances of the case, at least 10d. per hour to an ordinary worker, the sum of Id. per hour.

PART IV.

The above Minimum Rates of Wages shall apply, subject to the provisions of the Trade Boards Acts to all workers specified in Parts I. and II. above in respect of any time during which they are employed in any branch of the trade specified in the Trade Boards (Button-Making) Order, 1919, that is to say :--

The manufacture of buttons, button moulds, upholsterers' buttons, or upholsterers' buttonheaded nails (excluding the shanks), from any material by the processes of cutting, sawing, stamping, pressing, turning, drilling, fancying, grinding, barrelling, polishing, japanning, lacquering, dyeing, colouring, painting, varnishing, sewing, crocheting, or the covering of button-moulds;

including-

(a) The manufacture of studs, links, or parts thereof, from any material other than metal, where such manufacture is carried on in association with or in conjunction with button-making, so as to provide a common or interchangeable form of employment for workers;

- (b) The manufacture of shanks for buttons where carried on in association with or in conjunction with button-making;
- (c) The carding of any of the above articles, wherever carried on ;
- (d) All despatching, packing, warehousing, or other operations incidental to or appertaining to the manufacture of any of the above articles;

.but excluding—

- (e) The manufacture of wooden button moulds;
- (f) The covering of button moulds where carried on in association with or in conjunction with the making of wearing apparel.

Provided that the above Minimum Rates shall not apply to home-workers.

PART V.

SECTION I.—The above Minimum Rates of Wages shall be paid clear of all deductions, other than deductions under the National Insurance Act, 1911, as amended by any subsequent enactments, or deductions authorised by any Act to be made from wages in respect of contributions to any superannuation or other provident fund.

SECTION II.—The above Minimum Rates of Wages are without prejudice to workers who are earning higher rates of wages.

LAUNDRY TRADE BOARD (GREAT BRITAIN).

MINIMUM RATES OF WAGES FIXED FOR CERTAIN CLASSES OF MALE WORKERS.

EFFECTIVE AS FROM 19TH JULY 1920.*

In accordance with Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour and dated 31st October 1918, the Trade Board established in Great Britain under the Trade Boards Act, 1918, for the Laundry Trade as specified in the Trade Boards (Laundry Order, 1919, as varied by the Trade Boards (Women's Clothing) Order, 1919, the Trade Boards (Shirtmaking) Order, 1920, and the Trade Boards (Linen and Cotton Handkerchief and Household Goods and Linen Piece Goods) Order, 1920, having given due notice

* Should this date not correspond with the beginning of the period for which wages are paid by an employer who pays wages at intervals not exceeding seven days, the rates shall become effective as from the beginning of the next full-pay period, but in any case not later than 25th July 1920.

on the 23rd March 1920, of Proposal to Fix General Minimum Time Rates and Overtime Rates for certain classes of Male Workers and to declare the normal number of hours of work in the trade for the purpose of the application of the Overtime Rates, hereby give Notice that they have fixed General Minimum Time Rates and Overtime Rates for certain classes of Male Workers, and declare the normal number of hours of work in the trade for the purpose of the application of the Overtime Rates, the minimum rates as fixed and the normal number of hours as declared being as shown in the Schedule set out below which is incorporated herewith.

And the Trade Board further give Notice that they have received notification from the Minister of Labour that he has made an Order dated 5th July 1920, under Section 4 (2) of the Trade Boards Act, 1918, confirming the Minimum Rates as fixed by the Trade Board and specifying 19th July 1920,* as the date from which such rates shall become effective.

SCHEDULE.

GENERAL MINIMUM TIME-RATES.

FOR MALE WASH-HOUSE AND GENERAL INSIDE WORKERS.

SECTION I.

- (a) 1. Workers of under 15 years of age, 15s. per week.
 - 2. Workers of 15 and under 16 years of age, 18s. per week.
 - 3. Workers of 16 and under 17 years of age, 22s. per week.
 - 4. Workers of 17 and under 18 years of age, 28s. per week.
 - 5. Workers of 18 and under 19 years of age, 36s. per week.
 - 6. Workers of 19 and under 20 years of age, 44s. per week.
 7. Workers of 20 and under 21 years of
 - 7. Workers of 20 and under 21 years of age, 52s. per week.
 - 8. Workers of 21 years of age and over, 60s. per week.
- (b) Provided that in the case of any worker who enters the trade for the first time at or over the age of 17 years and under 21 years of age and who is employed on Time-work, the Minimum Rates payable shall be during the first six months of employment in the Trade :--
 - 1. For Workers entering the trade at 17 and under 18 years of age, 22s. per week.
 - 2. For Workers entering the trade at 18 and under 19 years of age, 28s. per week.
 - 3. For Workers entering the trade at 19 and under 20 years of age, 36s. per week.
 - 4. For Workers entering the trade at 20 and under 21 years of age, 44s. per week.

On the completion of six months' employment in the Trade the minimum rate payable shall be that applicable to a worker according to his age as set out in Section I. (a) above.

- (c) Provided also that in the case of any worker who enters the trade for the first time at or over the age of 21 years and who is employed on Time-work, the Minimum Rates payable during the first twelve months of employment shall be :---
- 1. During the first six months of employment, 52s. per week.

 During the second six months of employment, 56s. per week.

On the completion of twelve months' employment in the Trade, the Minimum Rate payable shall be the full Minimum Rate of 60s. per week.

- SECTION II.—The above General Minimum Time-Rates are for a week not exceeding 48 hours, and save as provided in Section V. hereof no deductions shall be made from such rates where the number of hours of work in any week is less than 48 except :—
 - (a) Where the worker is absent without the permission of the employer or at his own request or in order to comply with an obligation imposed by Law, or through being incapacitated from work by illness or other cause, or during any customary local holidays.
 - (b) Where, at his own desire, it is agreed that any worker shall be regularly employed for a less period than the full working week of the Laundry.
 - (c) Where, in pursuance of an agreement made in writing between an employer and the workers affected (and registered with the Trade Board) it is provided that by reason of seasonal trade, or for any cause not within the control of the employer, short time is regularly to be worked for any period commencing not less than seven days after the date of such agreement.
 - (d) Where in any week a worker is required to stand off for not less than a quarter of the normal working week of the Laundry by reason of a stoppage of work caused by a breakdown in machinery, a stoppage in supplies of water, gas, electric current or fuel, a general breakdown in transport services or other similar emergency over which the employer has no control. Provided that this clause shall not operate until the expiration of at least seven days from the date on which notice so to stand off is given to the worker by an employer.

In such cases a proportionate deduction may be made according as the number of hours worked is less than the full working week of the Laundry when not on short time.

Provided that for the purpose of calculating the proportionate deduction under the provisions of the foregoing clause, no deduction shall be made in respect of absence from work on any day during which the Laundry is closed by reason of such day being a holiday allowed to female workers under the provisions of Section 35 of the Factory and Workshop Act, 1901, except where in any week in which such holiday occurs the worker without reasonable and sufficient cause absents himself for more than two hours during the period in which he had the opportunity of working.

OVERTIME RATES FOR TIME-WORKERS.

EMPLOYED AS WASH-HOUSE AND GENERAL INSIDE WORKERS.

Section III.-

(a) 1. For Workers entitled under Section I. above to the General Minimum Time-Rate of 15s. per week, the Overtime Rate shall be 4³/₂d. per hour.

- For Workers entitled under Section I. above to the General Minimum Time-Rate of 18s. per week, the Overtime Rate shall be 5¹/₂d. per hour.
- 3. For Workers entitled under Section I. above to the General Minimum Time-Rate of 22s. per week, the Overtime Rate shall be 7d. per hour.
- For Workers entitled under Section I. above to the General Minimum Time-Rate of 28s. per week, the Overtime Rate shall be 8³/₂d. per hour.
- For Workers entitled under Section I. above to the General Minimum Time-Rate of 36s. per week, the Overtime Rate shall be 11¹/₂d. per hour.
- For Workers entitled under Section I. above to the General Minimum Time-Rate of 44s. per week. the Overtime Rate shall be 1s. 1³/₄d. per hour.
- For Workers entitled under Section I. above to the General Minimum Time-Rate of 52s. per week, the Overtime Rate shall be 1s. 4¹/₄d. per hour.
- 8. For Workers entitled under Section I. above to the General Minimum Time-Rate of 56s. per week, the Overtime Rate shall be 1s. 5¹/₂d. per hour.
- 9. For Workers entitled under Section I. above to the General Minimum Time-Rate of 60s. per week, the Overtime Rate shall be 1s. $6\frac{3}{4}d$. per hour.
- (b) The normal number of hours of work per week is hereby declared to be 48, and the above Overtime Rates shall be payable in respect of all time worked in any week in excess of 48 hours.

A

- (c) The normal number of hours of work on Saturday (or on such weekly short day other than Saturday as has been substituted for Saturday in pursuance of the provisions of Section 43 of the Factory and Workshop Act, 1901, as respects female workers), is hereby declared to be five, and the above Overtime Rates shall be payable in respect of time worked on such day in excess of five hours, notwithstanding that the number of hours worked in the week does not exceed 48.
- SECTION IV .- The Minimum Rates set out in this Notice shall apply, subject to the provisions of the Trade Boards Acts, to all Male Workers in Great Britain as specified in Section I. of this Notice in respect of all time during which they are employed in any branch of the trade specified in the Trade Boards (Laundry) Order, 1919 (that is to say, the laundering of articles of every description and all processes and operations incidental thereto performed by way of trade or for the purpose of gain), as varied by the Trade Boards (Women's Clothing) Order, 1919, the Trade Boards (Shirtmaking) Order, 1920, and the Trade Boards (Linen and Cotton Handkerchief and Household Goods and Linen Piece Goods) Order, 1920, by virtue of which all processes of laundering and other similar operations incidental to or appertaining to the making of the articles specified in the Appendices to the three last mentioned Orders are excluded from the scope of the Trade Boards (Laundry) Order, 1919.
- Provided that the Minimum Rates set out in this Notice shall not apply to male workers

enginemen or stokers.

SECTION V.-The Minimum Rates set out in this Notice shall be paid clear of all deductions other than deductions as are provided for in Section II., deductions under the National Insurance Act, 1911, as amended by any subsequent enactments, or deductions authorised by any Act to be made from wages in respect of contributions to any superannuation or other provident fund.

SECTION VI.—The Minimum Rates set out in this Notice are without prejudice to workers earning higher rates of wages.

It is provided by the above-mentioned Regulations that :-

Every Occupier of a Factory or Workshop or of any place used for giving out work to outworkers shall, on receipt of this Notice, post up and keep posted up a sufficient number of true copies thereof in prominent positions in the Factory, Workshop or place used for giving out work, in such a manner as to ensure that in each case the Notice shall be brought to the knowledge of all workers employed by him or on his premises who are affected thereby. Penalty for noncompliance, a fine not exceeding 40s.

Under the Trade Boards Acts, 1909 and 1918, it is provided amongst other things that :

1. Where any minimum rate of wages fixed by a Trade Board has become effective, an employer shall, in cases to which the minimum rate is applicable, pay wages to the person enployed at not less than the minimum rate clear of all deductions, and if he fails to do so shall be liable on summary conviction in respect of each offence to a fine not exceeding twenty pounds and to a fine not exceeding five pounds for each day on which the offence is continued after conviction therefor.

In the foregoing provision, the expression "deductions" includes deductions for or in respect of any matter whatsoever (other than deductions under the National Insurance Act, 1911, as amended by any subsequent enactments or deductions authorised by any Act to be made from wages in respect of contributions to any superannuation or other provident fund), and notwithstanding that they are deductions which may lawfully be made from wages under the provisions of the Truck Acts, 1831 to 1896, and where any payment being a payment authorised to be received by an employer under section one, section two, or section three of the Truck Act, 1896, is made by any employed person to his employer, the employer shall, for the purposes of the foregoing provision, be deemed to have deducted that amount from wages.

On the conviction of an employer for failing to pay wages at not less than the minimum rate to a person employed, the Court may by the conviction adjudge the enployer convicted to pay, in addition to any fine, such sum as appears to the Court to be due to the person employed | learner, it shall not be lawful for his employer

wholly or mainly employed as transport workers, I on account of wages, the wages being calculated on the basis of the minimum rate, but the power to order the payment of wages under this provision shall not be in derogation of any right of the person employed to recover wages by any other proceedings.

2.-If a Trade Board are satisfied that any worker employed, or desiring to be employed, in any branch of a trade to which a general minimum time-rate, a guaranteed time-rate, or a time-work overtime rate is applicable is affected by any infirmity or physical injury which renders him incapable of earning that minimum rate, and where the worker is not already employed on piece-work, are of opinion that the case cannot suitably be met by employing him on piece-work, the Trade Board may, if they think fit, grant to the worker, subject to such conditions, if any, as they prescribe, a permit exempting the employment of the worker from the provisions of this Act relating to the payment of wages at less than the minimum rate, and, while the permit is in force, the employer shall not be liable for paying wages to the worker at a rate less than the minimum rate so long as the conditions prescribed by the Trade Board on the grant of the permit are complied with.

3.—It shall be the duty of every employer in a trade to which a minimum rate is applicable, to keep such records of wages as are necessary to show that the provisions of this Act are being complied with as respects persons in his employment, and if he fails to do so he shall be liable on summary conviction in respect of each offence to a fine not exceeding two pounds, and also to a fine not exceeding one pound for every day during which the default continues after conviction.

On any prosecution of a person for failing to pay wages at not less than the minimum rate, it shall lie on that person to prove that he has not paid wages at less than the minimum rate.

Any agreement for the payment of wages in contravention of the provisions of the Acts shall be void.

4.—An employer shall, in cases where persons are employed on piece-work and a general minimum time-rate but no general minimum piece-rate has been fixed be deemed to pay wages at less than the minimum rate-

- (a) in cases where a special minimum piecerate has been fixed under the provisions of this Act for persons employed by that employer, if the rate of wages is less than that special minimum piece-rate ;
- (b) in cases where a special minimum piecerate has not been so fixed, unless he shows that the piece-rate of wages paid would yield, in the circumstances of the case, to an ordinary worker at least the same amount of money as the basis-rate.

For the purpose of this section the expression basis-rate " means the general minimum timerate, or where a rate (i.e., a "piece-work basis time-rate ") has been fixed by the Trade Board for the purpose of being substituted for the general minimum time-rate as the basis rate, the rate so fixed.

5.-(1) Where a worker in any trade, being a person to whom a minimum rate of wages fixed by a Trade Board applies, is an apprentice or to receive directly or indirectly from him, or on his behalf or on his account, any payment by way of premium :

Provided that nothing in the foregoing provision shall apply to any such payment duly made in pursuance of any instrument of apprenticeship not later than four weeks after the commencement of the employment.

(2) If any employer acts in contravention of this provision, he shall be liable on summary conviction in respect of each offence to a fine not exceeding twenty pounds, and the Court may by the conviction, in addition to imposing a fine, adjudge him to repay to the worker or other person by whom the payment was made the sum improperly received by way of premium.

6.—For the purpose of calculating the amount of the wages payable in the case of a worker employed on any work for which a minimum rate of wages has been fixed under the principal Act, the worker shall be deemed to have been employed during all the time during which he was present on the premises of the employer, unless the employer proves that he was so present without the employer's consent, express or implied, or that he was so present for some purpose unconnected with his work and other than that of waiting for work to be given to him to perform, and in the case of a worker employed on piece-work shall be deemed during any time during which he was so present and was not doing piece-work to have been employed at the general minimum time-rate applicable to workers of the class to which he belongs :

Provided that-

- (a) where a worker resides on the premises of the employer he shall not be deemed to be employed during any time during which he is present on the premises by reason only of the fact that he is so resident; and
- (b) a worker while present during normal meal times in a room or place in which no work is being done shall be deemed to be present for a purpose unconnected with his work.
