For gallantry and initiative at Alba Keinal on the 11th January 1920, when his post having been attacked and surrounded, he made a most gallant sortie and rescued a convoy which had been attacked when approaching from the south. Later, he again went out and salvaged a derelict van. He set throughout a magnificent example to the small garrison of the port.

(MESOPOTAMIA)

For conspicuous gallantry and devotion to duty on the 1st March 1920, at Safrah, when in command of a squadron after his squadron leader had been killed. His squadron was suddenly attacked, and, although almost surrounded and outnumbered, by skilful leadership and sound judgment he extricated the squadron with little loss from an extremely critical situation. His gallant conduct and coolness throughout the action were beyond all praise.

Lt. Robert M'Combe, I.A.R.O. (ADEN)

On the 14th December 1918, for conspicuous gallantry and good leadership. Under heavy machine-gun and rifle fire he led his company with great dash and determination, and was instrumental in capturing five Nordenfolt guns.

Capt. Oswald Bede Plowden Russell, 10th Lrs., I.A. (MESOPOTAMIA)

For conspicuous gallantry and devotion to duty near Sasiliyah on 7th March 1920. He led a mounted attack along the edge of some cliffs over most difficult ground and drove the enemy out of a nullah, and subsequently directed a successful dismounted attack. By his skilful leadership and sound judgment he forced the enemy to retire, and so prevented another squadron from being outflanked.
