# ACT OF ADJOURNAL.

For Regulating the Procedure in Scotland under the Aliens Restriction Acts, 1914 and 1919 (4 & 5 Geo. V., Cap. 12, and 9 & 10 Geo. V., Cap. 92), and The Aliens Order, 1920.

At Edinburgh, the twenty-first day of July nineteen hundred and twenty.

The Lord Justice-General, Lord Justice-Clerk, and Lords Commissioners of Justiciary, CON-SIDERING that by the provisions of the Aliens Restriction Acts, 1914 and 1919, and of the Aliens Order, 1920, made under the powers contained in the said Acts, and in particular by the provisions of Sections 12 (6) (b) and 23 (1) of the said Order, it is lawful for the High Court of Justiciary on the application of the Lord Advocate to make Rules necessary to give effect to the provisions of the said Order in accordance with the provisions of the Summary Jurisdiction (Scotland)

Act, 1908, Section 16, and considering that an application has been made by the Lord Advocate to the Court to make such rules, and that it is expedient to provide forms of certificates required under Sections 12 (6) (a) and (b), and 12 (7), and for the form of proceedings under Section 12 (6) (b) of the said Order, DO ENACT and DE-CLARE as follows :—

- I. All proceedings under Section 12 (6) (b) of the said Aliens Order, 1920, relating to the deportation of pauper aliens and aliens convicted abroad of extradition crimes shall be commenced by Complaint and the provisions of The Summary Jurisdiction (Scotland) Act, 1908, and The Criminal Procedure (Scotland) Act, 1887, shall apply so far as the same are applicable to such proceedings.
- II. The forms of certificates set forth in the Schedule hereto, or forms to the like effect, may be used with such variations as circumstances may require for the purposes of The Aliens Order, 1920.
- III. This Act of Adjournal shall come into operation on the date hereof, and in order that due notice thereof may be given, it shall be forthwith printed and published in His Majesty's Edinburgh Gazette.

THE PROFITEERING ACTS, 1919 AND 1920, ORDER (NO. 9), DATED 2ND AUGUST 1920. MADE BY THE BOARD OF TRADE UNDER SECTION 2 OF THE PROFITEERING (AMENDMENT) ACT, 1920 (10 & 11 Geo. V. c. 13).

Whereas Section 2, Sub-Section (2) of the Profiteering (Amendment) Act, 1920 (10 & 11 Geo. V. c. 13) provides that the Board of Trade may by Order amend Section 1 of the Profiteering Act, 1919 (9 & 10 Geo. V. c. 66) to any process of manufacture or to the repairing, altering, dyeing, cleaning, washing, or otherwise treating of any articles mentioned in the Order and processes incidental thereto, subject to such modification as may be necessary to adapt the provisions of that section thereto :

Now, therefore, the Board of Trade do hereby extend Section 1 of the Profiteering Act, 1919 (9 & 10 Geo. V. c. 66) to the repairing, altering, or washing of all articles of wearing apparel (except boots and shoes) and of cloths and dusters, table and bed linen, blankets, towels, mattresses, pillows, bolsters and curtains, and to any processes incidental thereto: to the repairing, altering or cleaning of clocks and watches, and to the repairing or altering of boots, shoes and umbrellas subject to the following modifications, namely :--that the words "sale," "seller," and "price" shall include treating or offering to treat in any of the manners aforesaid, any person so doing, and the charge for so doing respectively.

This Order shall come into force as from the ninth day of August 1920, and may be cited as the Profiteering Acts, 1919 and 1920 Order (No. 9).

# TRADE BOARDS ACTS, 1909 AND 1918.

#### PAPER BOX TRADE BOARD (GREAT BRITAIN).

#### PROPOSAL TO VARY AND TO FIX MINIMUM RATES OF WAGES FOR FEMALE WORKERS.

In accordance with Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour and dated 31st October 1918, the Trade Board established under that Act, for that branch of the Box Trade in Great Britain, which is engaged in the making of Boxes or parts thereof, made wholly or partially of paper, cardboard, chip or similar material, hereby give Notice, as required by Section 3 (5) of the Trade Boards Act, 1918, that they Propose to Vary the General Minimum Time-Rates and Piece-work Basis Time-Rates for Female Workers at present Fixed and set out in the Schedule to their Notice, dated 13th November 1919, and effective under the Order of the Minister of Labour, dated 12th November 1919, and that they Propose to Fix Overtime Rates for Female Workers and to declare the normal number of hours of work in the trade for the purpose of the application of the Overtime Rates as shown in the Schedule set out below.

# SCHEDULE.

# PART I.

PROPOSED VARIATION OF GENERAL MINIMUM TIME-RATES FOR FEMALE WORKERS.

SECTION I.—For Female Workers (other than Learners as defined in Part IV., Section I. of this Schedule), namely :—

- (a) Workers other than Home-workers, from 9d. to 9<sup>1</sup>/<sub>4</sub>d. per hour.
- (b) Home-workers, from 8d. to  $9\frac{1}{4}$ d. per hour.

(i) The General Minimum Time-Rate for Learners under 14 years of age shall be 11s. 6d. per week of 48 hours or  $2\frac{7}{5}$ d. per hour, and on reaching the age of 14 they shall be entitled to the amount shown in Column I. above as if they had commenced at 14.

(ii) A learner shall cease to be a Learner and be entitled to the full General Minimum Time-Rate for a Worker, applicable to her under Part I., Section I. upon the fulfilment of the following conditions :—

#### Age of entering upon Employment and Conditions.

Under 15 years of age, the completion of not less than four years' employment and the attainment of the age of 18 years.

- 15 and under 17 years of age, the completion of three years' employment.
- 17 and under 20 years of age, the completion of two years' employment.
  - 20 years of age and over, the completion of one year's employment.

(iii) A Learner returning to the trade after absence shall not serve a longer period as a Learner than would be required if she were entering the trade for the first time.

(iv) For the purposes of reckoning the General Minimum Time-Rate applicable to a Learner who has had previous employment in the trade, and the length of time during which she may continue to be employed as a Learner, the provisions of this Section shall be held to apply to the whole period of her employment in the trade.

#### PART II.

PROPOSED VARIATION OF PIECE-WORK BASIS TIME-RATES FOR ALL FEMALE WORKERS.

- (a) Workers other than Home-workers, from  $8\frac{1}{2}d$ . to  $9\frac{3}{4}d$ . per hour.
- (b) Home-workers, from  $8\frac{1}{2}$ d. to  $9\frac{3}{4}$ d. per hour.

In the case of all Female Persons employed on Piece-work, each Piece-Rate paid shall be such as will yield, in the circumstances of the case, not less than  $9\frac{3}{4}$ d. per hour to an Ordinary Worker. Provided that in determining as to whether any Piece-Rate satisfies the foregoing conditions, regard shall be had only to the earnings of workers other than Learners.

#### PART III.

#### PROPOSED OVERTIME RATES FOR ALL FEMALE WORKERS.

In accordance with Section 3 (1) (c) of the Trade Boards Act, 1918, the Trade Board hereby propose to declare the normal number of hours of work in the Trade to be as follows :---

In any week	۰.	48
On any day (other than Saturday)	٠.	9
On Saturday	••	5

Provided that all hours worked on Sundays and on Customary Public and Statutory Holidays shall be regarded as Overtime to which the Overtime Rates shall apply.

The Trade Board propose to fix Minimum Rates for Overtime in respect of hours worked by a worker employed in any branch of the trade specified in Part V. of this Schedule in excess of such declared normal number of hours as follows, that is to say :—

- (a) For Workers employed on Time-work :---
- 1. For the first two hours' Overtime on any day, except Saturdays, Sundays, and Customary Public and Statutory Holidays the Overtime Rate shall be equivalent to Time-and-a-Quarter, that is to say, One-and-a-Quarter times the General Minimum Time-Rate otherwise applicable.
- 2. For Overtime after the first two hours of Overtime on any day except Sundays and Customary Public and Statutory Holidays, and for all Overtime on Saturdays, the Overtime Rate shall be equivalent to Time-and-a-Half, that is to say, Oneand-a-Half times the General Minimum Time-Rate otherwise applicable.

3. For all time worked on Sundays and Customary Public and Statutory Holidays, the Overtime Rate shall be equivalent to Double Time, that is to say, Twice the General Minimum Time-Rate otherwise applicable.

(b) For Workers other than Learners (as defined in Part IV. of this Schedule) employed on Piece-work :—

Workers other than Learners employed on Piece-work shall be entitled to receive in respect of each hour of Overtime worked, in addition to Piece-Rates, each of which would yield, in the circumstances of the case, to an Ordinary worker not less than the Piecework Basis Time-Rate applicable, the appropriate Piece-work Basis Time-Rate, One-Half of the appropriate Piece-work Basis Time-Rate, or One-Quarter of the appropriate Piece-work Basis Time-Rate, according as the Overtime Rate which would have been payable under the provisions of paragraph (a) of this Section if the worker had been employed on Time-work were Double Time, Time-and-a-Half, or Time-and-a-Quarter respectively.

(c) For Learners (as defined in Part IV. of this Schedule) employed on Piece-work :----

Learners employed on Piece-work shall be entitled to receive in respect of each hour of Overtime worked, in addition to Piece-Rates, each of which would yield, in the circumstances of the case, to an Ordinary worker not less than the Piece-work Basis Time-Rate applicable, the appropriate General Minimum Time-Rate, One-Half of the appropriate General Minimum Time-Rate, or One-Quarter of the appropriate General Minimum Time-Rate, according as the Overtime Rate which would have been payable under the provisions of paragraph (a) of this Section if the worker had been employed on Time-work were Double Time, Time-and-a-Half, or Time-and-a-Quarter respectively.

Provided that :---

- (a) Where it is or may become the established practice of an employer only to require attendance on five days a week the Overtime Rate shall only be payable where on any day the number of hours worked exceeds  $9\frac{1}{2}$ .
- (b) Where it is or may become the established practice of an employer to require attendance only on al<sup>+</sup>ernate Saturdays, the normal number of hours of work for the week in which attendance on Saturday is required shall be deemed to be 50.
- (c) Where an employer requires attendance on any week-day, not being a Statutory or Customary Public Holiday on which it is not the established practice of the employer to require attendance, all time worked thereon during the otherwise normal working hours of such day shall be paid for at Time-and-a-Quarter for the first two hours and Time-and-a-Half thereafter.
- (d) Notwithstanding the provisions of this Section as to payment of Overtime where a worker who has worked Overtime in any week is absent during any normal working hours in the same week for any

reason other than illness or other reasonable cause unavoidable by the worker, payment for the Overtime worked shall only be made at the appropriate rate if and when the hours during which the worker was absent have been recovered in such week.

Note.—The hours which female workers, young persons and children are allowed to work are subject to the provisions of the Factory and Workshop Acts.

# PART IV.

SECTION I.—A Female Learner is a worker who :---

- (a) Is employed by an employer who provides such Learner with reasonable facilities for practically and efficiently learning the branch or branches of the trade (as carried on by the employer subject to the provisions of this Section) in which the Learner is for the time being employed; provided that no person shall be deemed to be a Learner if employed for a longer period than six months on any one or more than twelve months on any two or more of the following processes, viz. : carrying about ; collecting work from benches and machines ; Lidding-up (other than round boxes); Tying-up and Nesting, except in so far as such processes may be incidental to any other process upon which the worker may be engaged.
- (b) Has received a certificate or has been registered in accordance with rules from time to time laid down by the Trade Board, or has made application for such certificate or registration, which has been duly acknowledged and is still under consideration.

Provided that the certification or registration of a Learner may be cancelled if the other conditions of learnership are not complied with.

Provided that an employer may employ a Female Learner on her first employment without a certificate or registration for a probation period not exceeding eight weeks, but the probation period shall be included in her period of learnership.

Provided that notwithstanding compliance with the conditions contained in this Section a person shall not be deemed to be a Learner if she works in a room used for dwelling purposes and is not in the employment of her parent or guardian.

SECTION II.—The expression "Home-worker" shall be held to mean a worker who works in her own home or in any other place not under the control or management of the employer.

#### PART V.

The above proposed rates shall, subject to the provisions of the Trade Boards Acts, apply to all Female Workers who :---

(i) Are engaged in manufacturing processes upon boxes or parts thereof made wholly or partially of paper, cardboard, chip or similar material, and, generally, to all processes; or

(ii) Are engaged in transferring material from the storeroom to the factory or workshop, and to workers engaged in transferring finished boxes from the factory or workshop to the warehouse, if such workers are also to any considerable extent engaged in connection with the work of distributing the material among, or collection of the finished boxes from, the workers engaged in the processes of box-making.

They shall not apply to Female Workers who :--

- (i) Are wholly or mainly engaged in occupations in a storeroom which involve no change in, or treatment of, the material necessary to its being made into boxes;
- (ii) Are wholly or mainly engaged in a warehouse on occupations directly connected with the storage or despatch of finished boxes which involve no examination or change in the form of such boxes; or
- (iii) Are wholly or mainly engaged in transferring material in bulk from the storeroom to the factory or workshop; or
- (iv) Are wholly or mainly engaged in transferring finished boxes from the factory or workshop to the warehouse for despatch to customers; or
- (v) Wherever employed are engaged as clerks, telephone attendants, and others whose work stands in a relationship to the trade similar to that of such workers.

#### PART VI.

SECTION I.—The above proposed Minimum Rates of Wages shall be paid clear of all deductions other than deductions under the National Insurance Act, 1911, as amended by any subsequent enactments or deductions authorised by any Act to be made from wages in respect of contributions to any Superannuation or other Provident Fund.

SECTION II.—The above proposed minimum rates of wages are without prejudice to workers who are earning higher rates of wages.

The Trade Board will consider any Objections to the above Proposals which may be lodged with them within two months from the 5th August 1920. Such Objections should be in writing and signed by the person making the same (adding his or her full name and address), and should be sent to The Secretary of the Paper Box Trade Board (Great Britain), 5 Chancery Lane, London, W.C. 2.

It is desirable that the Objections should state precisely, and so far as possible with reasons, what is objected to.

The Coastal and General Air Charts prepared by the Admiralty during the war for the use of R.A.F. Pilots have now been placed on sale to the public at one shilling and sixpence per sheet. The index sheets to the series are priced at one shilling.

The Coastal Air Charts cover the coasts of Great Britain and Ireland on the Scale of 1 inch to 3 nautical miles (Air Chart Index A), and the Southern and Eastern shores of the North Sea from Ostend to Plaavand Pt. (in Denmark), and the Cattegat, on the scale of 1 inch to 5 nautical miles (Air Chart Index B).

The General Air Charts cover a slightly larger area and range in scale from 1 inch to 10 nautical miles to 1 inch to 30 nautical miles (Air Chart Index P).

These Air Charts, which are constructed on Mercator's projection, measure approximately  $20'' \times 18''$ . They show lights and fog signals, buoys and beacons, sites of wrecks, and the direction of the flood and ebb streams; soundings are given in fathoms; conspicuous objects on land are also shown for navigational purposes.
