A PROCLAMATION

IN ORDER TO THE ELECTING THREE PEERS OF SCOTLAND.

GEORGE R.I.

WHEREAS the Right Honourable David John, Earl of Northesk, the Right Honourable Alexander Hugh, Baron Balfour of Burleigh, K.T., G.C.M.G., G.C.V.O., and the Right Honourable Alexander Charles, Baron Belhaven and Stenton, were duly elected and returned to be three of the Sixteen Peers of Scotland to sit in the House of Peers in the present Parliament of the United Kingdom of Great Britain and Ireland, and are since deceased: In order to the Electing three Peers of Scotland to sit in their room, We do, by and with the advice of Our Privy Council, issue forth this Our Royal Proclamation, strictly charging and commanding all the Peers of Scotland to assemble and meet at Holyrood House, at Edinburgh, on Friday, the Thirteenth day of January One thousand nine hundred and twenty-two. at Twelve o'clock Noon, to nominate and choose three Peers of Scotland to sit and vote in the House of Peers in this present Parliament of the United Kingdom of Great Britain and Ireland, in the room of the said David John, Earl of Northesk, the said Alexander Hugh, Baron Balfour of Burleigh, and the said Alexander Charles, Baron Belhaven and Stenton, deceased, by open Election and Plurality of Voices of the Peers that shall be then present, and of the Proxies of such as shall be absent (such Proxies !

being Peers and producing a Mandate in Writing duly signed before Witnesses, and both the Constituent and Proxy being qualified according to Law); and the Lord Clerk Register and the Principal Clerk of the Session appointed by him to officiate in his Name, are hereby respectively required to attend such Meeting, and to take the Votes of the said Peers, and immediately after such Election made and duly examined to certify the Names of the Peers so elected, and to sign and attest the same in the presence of the said Peers and Electors, and return such Certificate into Our High Court of Chancery of Great Britain: And We strictly charge and command that this Our Royal Proclamation be duly published at the Market Cross at Edinburgh, and in all the County Towns of Scotland, Ten Days at least before the Time hereby appointed for the Meeting of the said Peers to proceed to such Election.

His Majesty the KING has been graciously pleased to award the Edward Medal of the 2nd Class to Arthur Denton, Works Fitter at the Wandsworth works of Metal Powders Ltd., in the following circumstances:

On the 20th April 1921 an explosion of aluminium powder took place at the Wandsworth works of Metal Powders Ltd., causing an outbreak of fire. One of the female employees, Mrs. Draper, was in the act of entering the room where the explosion took place, but became dazed, and, instead of retiring from the room, ran into the flames. Mr. Denton, the Works' Fitter, who was passing the door when the explosion occurred, entered the room, found Mrs. Draper on the floor enveloped in flames from the waist upwards, and carried her out. She was so badly injured that her life was at one time despaired of, while Denton himself was severely burnt in effecting her rescue.

Denton exhibited great bravery, as he was fully aware that a more serious explosion might occur at any moment. If it had, there is little doubt that he would have lost his life.

Also the Edward Medal of the 2nd Class to Robert Edward Paddock and Joseph Thomas

Between 9 and 10 o'clock on April 29th, 1921, Chidley, with three other men, was engaged in pumping water from old workings in the Bulthy Mine, in Shropshire, when the foreman became affected by fumes from a petrol engine, and ordered the men to leave. He became unconscious, and was carried out by Chidley, who was himself in a semi-conscious condition on arrival at the foot of the air-shaft. The two other men

were overcome by gas and collapsed.

Paddock came to work at 10 o'clock, and, proceeding towards the working place, met Chidley and the foreman and helped them into the open air. He then returned and made two attempts to reach the other two men, but was each time driven back by the gas. He returned

Chidley, who had now recovered, the two men determined to make a third attempt. They managed to reach one of the men and got him as far as the air-shaft, but were then becoming overcome, and had to leave him. Unfortunately, this man was dead when eventually he was brought to the surface, but the remaining man, whom it had not been possible to reach, subsequently regained consciousness, managed to make his way to the surface. Both Paddock and Chidley displayed great courage and determination in the work of rescue.
