ORDER OF THE MINISTER OF AGRICULTURE AND FISHERIES.

(DATED 23RD JANUARY 1922.)

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1914, and of every other power enabling him in this behalf, hereby orders as follows:—

Authorisation of Landing of Animals for exceptional purposes.

1. The landing of the animal described in the First Schedule hereto, which is intended for exceptional purposes, is hereby allowed, subject to the provisions of Part II. (Quarantine) of the Third Schedule to the Diseases of Animals Act, 1894, and of the Foreign Animals (Quarantine) Order of 1896, and of this Order.

Definition of Quarantine Station.

2. The premises described in the Second Schedule hereto are hereby defined as a Foreign Animals Quarantine Station for the purpose of the landing and detention of the animal described in the First Schedule hereto.

Regulations applicable to the Animal on Landing.

3.—(1) The animal on being landed shall forthwith be moved under the supervision of an Inspector of the Ministry of Agriculture and Fisheries from the quay to the premises described in the Second Schedule hereto, and shall be there detained for a period of twenty-eight days, and during such period no other animals shall be moved into such premises.

(2) The animal shall not be moved out of the Foreign Animals Quarantine Station defined in this Order until the expiration of the prescribed

period of detention and until the animal, after such expiration, has been examined by a Veterinary Inspector of the Ministry, and declared by him to be free from disease and from the conditions imposed by the said Order of 1896 and this Order.

This condition is substituted for the fifth condition in Article 3 of the said Order of 1896 in respect of the said Animal.
