LUCE BAY.

WHEREAS it is enacted by section six of the Juries Act, 1922, that provision may be made by Order in Council for requiring and authorising the registration officer to mark as jurors or as special jurors in the Autumn

and liable or qualified to serve as such, notwithstanding that their names have not been so marked in the electors lists, and for making, so far as relates to the operation of that Act in that year any consequential modifications in the provisions thereof :

And whereas for the purposes aforesaid it is expedient to make such provision as is hereinafter contained for the purpose of the marking of jurors in the Autumn Register for the year 1922:

Now, therefore, His Majesty, in pursuance of the powers conferred upon Him by that section and of all other powers enabling Him in that behalf, is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, as follows :-

1. (1) The name of any person appearing in the Autumn Register for the year 1922 who is qualified and liable to serve as a juror shall be marked with the letter "J," and the name of any person so appearing who is qualified to serve as a special juror shall be marked with the letters "SJ" in the manenr hereinafter specified.

(2) The said letter or letters shall be printed in heavy type and shall be inserted in column 3 of the register, immediately after the names of the jurors concerned, as shown in the following example :-

Provided that the Secretary of State may, in any particular case, authorise such variation as he thinks fit.

2. (1) The overseers of every parish shall, if so required by the registration officer of their area, furnish him with a list of all the persons in their parish, or where the parish consists of more than one registration unit, in each registration unit in their parish, who are qualified and liable to serve as jurors, showing in the case of each person the address of his qualifying premises in that unit and elsewhere in the parish and the value of those premises for the purposes of assessment to the poor rate or inhabited house duty and his occupation, and whether he is qualified to serve as a special juror

Provided that the registration officer may, if he thinks fit, require the overseers to insert in copies of the electors lists and lists of claimants, if any, the marks required by this Order to be inserted in the Autumn Register for the year 1922 against the names of those persons in those lists who are qualified and liable to serve as jurors or qualified to serve as special jurors, as the case may be, and to transmit to him the copies so marked :

(2) The foregoing provisions of this Article shall not be deemed to relieve the overseers of their liability under subsection (3) of section one of the Juries Act, 1922, to furnish the registration officer with any further information which he may require for the purpose of enabling him to carry out the provisions of that Act and any Order in Council made thereunder with respect to the Autumn Register for the year 1922.

(3) For the purpose of furnishing the registration officer with any further information which he may require under the provisions of this Order Form C of heading I. of Schedule I. to the Register for the year in which that Act comes | Representation of the People Order shall, with

applicable.

3. (1) For the purpose of the operation of the Juries Act, 1922, in the year 1922, the following shall be substituted for the first paragraph of subsection (4) of section one of that Act :-

"(4) If any person who is marked as a juror or as a special juror in the Autumn Register for the year 1922 claims that by reason of some disqualification or exemption he ought not to be so marked, he may at any time after publication of the Register and not later than the 25th day of October 1922, apply to the registration officer to have the mark placed against his name removed."

(2) If the registration officer complies with any application made to him under subsection (4) of section one of the said Act as modified by this Order he shall forthwith notify the sheriff in writing of his decision, and in the case of every such application shall notify in writing his decision thereon to the applicant not later than the 10th day of November 1922.

(3) Notice of the dates fixed by virtue of and in consequence of this provision with respect to applications to the registration officer and appeals to a court of summary jurisdiction shall be published at the time of publication of the Register at all places where copies of the register are kept for inspection and in such other places as the registration officer may think fit.

SECTION I.--

The General Minimum Piece-Rates shall not apply in any case where special difficulty is caused by bad cotton, making or dressing. In all such cases each piece-rate paid must be such as would yield, in the circumstances of the case, to an Ordinary worker at least the equivalent of the appropriate General Minimum Time-Rate.

SECTION II.-

Workers who fetch their own work from the Warehouse, and do not receive it through a Middlewoman or Middleman, shall be entitled to a Minimum Rate not less than 15 per cent. above that otherwise payable.

The General Minimum Time-Rates for Learners are weekly rates based on a week of 48 hours, and are subject to a proportionate increase or decrease according as the number of hours of employment in any week is more or less than 48.

In reckoning the period of employment for the purpose of determining the General Minimum Time-Rate applicable to a Learner, previous experience in any section of the trade covered by this Notice must be included except (1) that experience in finishing Hair Nets shall be included only in cases where the worker is employed in that section or the trade, and (2) in the Hair Net Section of the trade no experience except in finishing Hair Nets shall be included.

It shall be optional to the employer to place the Learner on piece-rates during this period of learnership.

### PART V.

For the purpose of this Notice :---

I. Learners not working on frame clipping are persons who :---

- (a) Are definitely and effectively employed in the practical learning of the trade and have not been definitely employed in learning the trade more than four years ;
- (b) Are under 18 years of age ;

- ment of the employment or within such period thereafter as the Trade Board may in any case or class of cases allow. Provided always that in granting or withholding such certificate the Trade Board may take into consideration whether, having regard to the number of Learners employed in any factory or workshop or under any journeyman or worker, the Learner proposed to be certificated has a reasonable prospect of receiving due instruction. Provided also that any certificate may be withdrawn if the Trade Board consider that the conditions of employment have ceased to be such as would have originally justified the grant thereof.

II. Learners working on frame clipping are persons who :---

- (a) Are definitely and effectively employed in the practical learning of this branch of the trade and have not been definitely employed more than two years ;
- (b) Are under 18 years of age;
- (c) Are working on frame clipping in either a warehouse or a workshop;
   (d) Hold a certificate from the Trade Board issued on an application made at the commencement of the employment or within such period thereafter as the Trade Board may in any case or class of cases allow. Provided always that in granting or withholding such certificate the Trade Board may take into consideration whether, having regard to the number of Learners employed in any factory or workshop or under any journeyman or worker, the Learner proposed to be certificated has a reasonable prospect of receiving due instruction. Provided also that any certificate may be withdrawn if the Trade Board consider that the conditions of employment have ceased to be such as would have originally justified the grant thereof.

### PART VI.

The above minimum rates of Wages must be paid clear of all deductions other than deductions under the National Insurance Act, 1911, as amended by any subsequent enactments or deductions authorised by any Act to be made from wages in respect of contributions to any superannuation or other provident fund.

PROPOSAL TO VARY MINIMUM RATES OF WAGES FOR CERTAIN CLASSES OF FEMALE WORKERS IN THE RETAIL BRANCH OF THE TRADE.

In accordance with Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour, and dated 31st October 1918, the Trade Board established under the Trade Boards Acts, 1918, and the Trade Boards (Women's Clothing) Order, 1919, for the Dressmaking and Women's Light Clothing Trade in Scotland as defined in the Regulations made by the Minister of Labour and dated 29th March 1920, as varied by the Trade Boards (Shirtmaking) Order, 1920, hereby give Notice, as required by Section 3 (5) of the Trade Boards Act, 1918, that they Propose to Vary the General Minimum Time-Rates, Piece-Work Basis Time-Rates and Overtime Rates for the classes of Female Workers specified in the Schedule below, at present fixed and set out in the Schedule to their Notice W.D.S. (9), dated 23rd June 1922, the proposed General Minimum Time-Rates, Piece-Work Basis Time-Rates and Overtime Rates for such classes of Female Workers being as shown in the Schedule set out below.

The Minister of Labour has given his consent to the issue of this Notice of Proposal.

#### SCHEDULE.

### PART I.

PROPOSED VARIATION OF MINIMUM RATES FOR THE FOLLOWING CLASSES OF FEMALE WORKERS IN THE RETAIL BRANCH OF THE DRESSMAKING AND WOMEN'S LIGHT CLOTHING TRADE (as defined in Section II. of Part II. of this Schedule), viz. :---

For the purpose of this Notice, the Retail Branch of the Trade is that branch of the Trade specified in Part V. of the Schedule to the above-mentioned Notice W.D.S. (9) in which it is the usual practice of the employer to supply the garment direct to the wearer.

The Trade Board will consider any Objections to the above Proposal to Vary which may be lodged with them within two months from the 26th day of June 1922. Such Objections should be in writing and signed by the person making the same (adding his or her full name and address), and should be sent to the Secretary of the Dressmaking and Women's Light Clothing Trade Board (Scotland), 7-11 Old Bailey, London, E.C. 4.

It is desirable that the Objections should state precisely, and, so far as possible, with reasons, what is objected to.
