REGISTRATION OF ELECTORS.

SCOTLAND.

SCALES OF REGISTRATION EXPENSES FOR SCOTLAND FRAMED BY THE TREASURY, NOVEMBER 27TH, 1922, UNDER SECTION 15 OF THE REPRESENTATION OF THE PEOPLE ACT, 1918 (7 & 8 GEO. 5, C. 64), APPLICABLE TO THE SPRING REGISTER, 1923, AND SUBSEQUENT REGISTERS PREPARED UNDER THE ACT.

In pursuance of the powers conferred by Section 15 of the Representation of the People Act, 1918, We, being Two of the Lords Commissioners of His Majesty's Treasury, have framed the following scales of Registration Expenses for Scotland.

These scales will be applicable to the Spring Register, 1923, and to subsequent registers prepared under the Act, subject to any alterations which may from time to time be made.

I.

Registration Officer's Salary and Expenses in respect of the remuneration of his staff and other persons employed in the preparation of the Registers.

I.—Counties.

Provided that the expenditure allowable under any item of the foregoing scales for Counties and Burghs respectively shall not be less than the maximum under the preceding item.

NOTE.—For the purposes of the foregoing scale any number of electors in excess of a complete 100, if more than 50, shall be counted as a complete 100, and if not more than 50 shall be ignored.

II.

Printing and other Expenditure.

(1) Where the printing is carried out under arrangement made by His Majesty's Stationery Office such amount as may be certified by that Department to be expenditure incurred in connection therewith.

(2) Printing carried out directly by the Registration Officer and other expenditure.

The actual out-of-pocket expenditure supported as far as possible by vouchers. First class railway expenses and subsistence allowance at the rate of £1 a night when the Registration Officer is necessarily absent from home on account of his registration duties will be allowed.

DANGEROUS DRUGS.

Order, Dated 24th November 1922, Made by the Secretary of State, under the Dangerous Drugs Act, 1920 (10 & 11 Geo. 5, c. 46), Revoking the Authority Granted to Certain Persons Not Registered under the Dentists Act, 1878, to Purchase Preparations containing Not More Than One Per Cent. of Cocaine for Use as Local Anæsthetics in Dentistry.

In pursuance of the Dangerous Drugs Act, 1920, I hereby revoke as from the 30th November 1922, the authority, granted on the 13th August 1921, to persons who are *bonâ fidé* engaged in dentistry, and were so engaged on the 28th July 1916, but are not registered under the Dentists Act, 1878, to purchase preparations containing not more than one per cent. of cocaine for use as local anæsthetics in dentistry.
