MINIMUM RATES OF WAGES (AS VARIED) FOR MALE AND FEMALE WORKERS, EFFECTIVE AS FROM 1st JANUARY 1923.

Should this date not correspond with the beginning of the period for which wages are paid by any employer who pays wages at in-tervals not exceeding seven days, the rates become effective as from the beginning of the next full-pay period, but in any case not later than 7th January 1923.

General Minimum Time-Rates.

Male Workers of 21 years of age and over, 50s. per week of 48 hours.

Female Workers of 18 years of age and over, 26s, per week of 48 hours.

Male and Female Workers below the abovementioned ages, see Part I. of the Schedule below.

Piece-Work Basis Time-Rates.

All Male Workers, 1s. 41d. per hour. All Female Workers, 83d. per hour.

Overtime Rates.

See Part. III. of the Schedule below. The Rates in full as legally enforceable are set out in detail in the Schedule below.

SCHEDULE.

PART I.

General Minimum Time-Rates.

SECTION I.—(a) Male Workers:—

Workers of 14 years and under 15 years of age, 12s. per week of 48 hours.

Workers of 15 years and under 16 years of

age, 14s. per week of 48 hours.
Workers of 16 years and under 17 years of age, 18s. per week of 48 hours.

Workers of 17 years and under 18 years of age, 22s. per week of 48 hours.

Workers of 18 years and under 19 years of age, 26s. per week of 48 hours.

Workers of 19 years and under 20 years of age, 32s. per week of 48 hours.

Workers of 20 years and under 21 years of age, 40s. per week of 48 hours.

Workers of 21 years of age and over, 50s.

per week of 48 hours.

(b) Female Workers:—

Workers of 14 years and under 15 years of age, 12s. per week of 48 hours.

Workers of 15 years and under 16 years of age, 14s. per week of 48 hours.

Workers of 16 years and under 17 years of age, 18s. per week of 48 hours.

Workers of 17 years and under 18 years of

age, 21s. per week of 48 hours.
Workers of 18 years of age and over, 26s. per week of 48 hours.

Provided that a Male or Female Worker who enters the trade for the first time under the age of 18 years in the case of a Female Worker and under the age of 21 years in the case of a Male Worker and is employed on Time-Work shall until the expiry of two months' employment in the trade be paid at the rate of not less than three-quarters of the General Minimum Time-Rate which would otherwise be applicable according to his or her age under Sub-Sections (a) and (b) of this Section.

SECTION II.—The above General Minimum Time-Rates are Weekly Rates based on a week of 48 hours, and are subject to a proportionate decrease according as the number of hours spent by the worker in the factory or workshop under contract of employment in any week is less than 48.

PART II.

Piece-Work Basis Time-Rates.

SECTION I.—All Male Workers, 1s. 41d. per hour.

Section II.—All Female Workers, 83d.

In the case of all Workers employed on Piece-Work, each Piece-Rate paid must be such as would yield, in the circumstances of the case, not less than the appropriate Piece-Work Basis Time-Rate to an Ordinary Worker, i.e., a worker of ordinary skill and experience in the class of work in question.

PART III.

Overtime Rates-Male and Female Workers-(All Ages).

Section I.—In accordance with Section 3 (1) (c) of the Trade Boards Act, 1918, the Trade Board have declared the normal number of hours of work in the trade to be as follows:

> In any week 48 On Saturday 4\frac{1}{2}

Provided that any other day, not being Sunday, may, by agreement in writing between an employer and a worker, be substituted in the place of Saturday, as the weekly short day, and in such case the normal number of hours on such substituted day shall be 4½.

Provided also that all hours worked by a worker on Sunday and on Statutory Bank Holidays shall be regarded as Overtime to

which Overtime Rates shall apply.

The Minimum Rates for Overtime for all Male and Female Workers, whether employed on Time-Work or on Piece-Work to apply in substitution for the Minimum Rates which would otherwise be applicable in respect of all hours worked in excess of the declared normal number of hours of work in the trade are as follows:-

(1) For all time worked on Sunday and Statutory Bank Holidays the Overtime Rate shall be equivalent to Double-Time, that is to say, twice the Minimum Rate otherwise

applicable.

(2) For all time worked in excess of 4½ hours on a Saturday (or on the weekly short day substituted therefor under the terms of the first Proviso to Section I. of this Part of this Notice) the Overtime Rate shall be equivalent to Timeand-a-Half, that is to say, one-and-a-half times the Minimum Rate otherwise applicable, notwithstanding that the total number of hours worked in the week may not exceed 48.

(3) For all time worked in excess of 48 hours in any week the Overtime Rate shall be equivalent to Time-and-a-Quarter for the first two hours and Time-and-a-Half thereafter, except in so far as higher Overtime Rates are payable under the provisions of paragraphs (1) and (2) of this Section.

PART IV.

Applicability of Rates.

The above Minimum Rates of Wages apply, subject to the provisions of the Trade Boards. Acts, to all workers in England and Wales who are employed during the whole or any part of their time in any branch of the trade specified in the Trade Boards (Aerated Waters) Order, 1919, that is to say:

The manufacture, wherever carried on, of mineral or aerated waters, non-alcoholic cordials, flavoured syrups, unfermented sweet drinks and other similar beverages, and the manufacture in unlicensed premises of brewed liquors,

Including-

(a) The operations of bottle-washing, bottling and filling, and all other operations preparatory to the sale of any of the aforesaid liquors in bottles, jars, syphons, casks, or other similar receptacles;

and Including also-

(b) The operations of bottle-washing, bottling and filling, and all subsidiary operations preparatory to the sale in bottles, jars, or other similar receptacles, of cider, ale, stout, porter and other alcoholic beers, where all or any of such last-mentioned operations are, or is, conducted or carried on in association with or in conjunction with all or any of the operations specified under (a) above so as to form a common or interchangeable form of employment for workers, and whether the two sets of operations or any of them are, or is, carried on simultaneously or not.

Note.—The employment of female workers. young persons and children is subject to the provisions of the Factory and Workshop Acts, and to the Employment of Women, Young Persons and Children Act, 1920.

PART V.

SECTION I.—The above Minimum Rates of Wages must be paid clear of all deductions other than deductions under the National Insurance Act, 1911, as amended by any subsequent enactments, or deductions authorised by any Act to be made from wages in respect of contributions to any Superannuation or other Provident Fund.

SECTION II.—The above Minimum Rates of Wages are without prejudice to workers who are earning higher rates of wages or to agreements made or that may be made between employers and workers for the payment of wages in excess of the Minimum Rates.

PART III,

SECTION I.—In the application of the General Minimum Time-Rates set out in Parts I. and IIof this Schedule the following provisions apply: --

- (a) In the case of classes of whole-time workers, employed by the week or longer period, whose customary working week consists of a number of hours less than 48, but not less than 40, a "week" means a week of the number of hours customarily worked by the class in question.
- (b) In all other cases a "week" means a week of 48 hours.

SECTION II.—For the purpose of calculating the hourly rate applicable in respect of each hour of employment, the General Minimum Time-Rates set out above must be divided :--

- (a) In the case of the workers referred to in Section I. (a) of this Part of this Schedule by the number of hours per week customarily worked by the class in question.

 (b) In all other cases by 48.

SECTION III.—Payment at not less than the hourly rate, calculated as specified in Section II. of this Part of this Schedule, must be made for ALL hours of employment (not only for those constituting a "week" as specified in Section I. of this Part of this Schedule) except in so far as higher rates are payable under the provisions of Part IV. of this Schedule.

PART IV.

OVERTIME RATES FOR MALE AND FEMALE WORKERS (ALL AGES), OTHER THAN THOSE EXCLUDED BY SECTION I. OF PART VI. OF THIS SCHEDULE.

Section I.—In accordance with Section 3 (1) (c) of the Trade Boards Acts, 1918, the Trade Board HEREBY DECLARE the normal number of hours of work in the trade to be as follows:-

> In any Week On Sundays and Customary Public and Statutory Holidays

SECTION II.—The Minimum Rates for Overtime in respect of hours worked by a worker in excess of the declared normal number of hours of work in the trade are as follows:-

- (a) For all hours worked in excess of four on Sundays and Customary Public and Statutory Holidays, the Overtime Rate is twice the Minimum Rate otherwise applicable, i.e.,
- (b) For the first eight hours worked in excess of the first four hours of Overtime in any week, the Overtime Rate is One-and-a-Quarter times the Minimum Rate otherwise applicable, i.e., TIME-AND-A-QUARTER, and thereafter One-and-a-Half times the Minimum Rate otherwise applicable, i.e., TIME-AND-A-HALF, except in so far as a higher Overtime Rate is payable under the provisions of Sub-Section (a) of this Section.

Note.—During the first four hours in excess of 48 in any week, the minimum rate applicable is the appropriate General Minimum Time-Rate as set out in Part I. or Part II. of this Schedule, except in so far as a higher rate may be payable under the provisions of Sub-Section (a) of this Section.

PART V.

DEFINITIONS OF CLASSES OF WORKERS.

For the purpose of this Notice :-

SECTION I.—A "FOREMAN" is a person who is employed in any branch of the Trade specified in the Trade Boards (Milk Distributive) Order, 1920, and to whom is deputed the duty of exercising supervising authority over workers exceeding five in number (exclusive of the foreman) working in the same shop, department, or branch of the trade;

SECTION II.—A "ROUNDSMAN" or "ROUNDSWOMAN" is a person in charge of a round or rounds and is wholly or mainly so employed;

Section III.-A "CLERK" is a male or female person wholly or mainly employed on clerical work;

SECTION IV.—A "SHOP ASSISTANT" is a male or female person wholly or mainly employed in a shop in serving customers and/or in checking in and out.

PART VI.

SECTION I.—Notwithstanding anything contained in this Notice the Minimum Rates of Wages set out in this Schedule do NOT APPLY to :-

Workers employed in collection or delivery work by horse, motor, steam or oil driven vehicle, in garaging, in horse or motor keeping, in cleaning vehicles, or in stable work, in respect of the time during which they are so employed.

Section II.—Subject to the provisions of the Trade Boards Acts, the Minimum Rates of Wages set out in this Notice apply to all Male and Female Workers (other than those specified in Section I. of this Part) in respect of all time during which they are employed in Scotland in any branch of the trade specified in the Trade Boards (Milk Distributive) Order, 1920, viz. :-

1.—(a) The wholesale or retail sale of fresh milk when carried on as a main or distinct business or as a distinct branch or department of a business.

- (b) The sale of food or drink for consumption on the premises, or of other goods, when any such sale is carried on in association with and as a subsidiary part of such business, branch or department as aforesaid, if such sale involves the employment of workers who are principally employed in the sale specified in (a) above.
 - 2.—(a) The following operations when incidental to the sales specified in 1 above :—
 - (i) Boxing, parcelling, labelling, weighing, measuring, checking, bottling, unpacking, packing;

- (ii) Collecting, delivering, despatching, horsekeeping, cleaning vehicles;
 (iii) Portering, lift or hoist operating, timekeeping, storing, stock-keeping, warehousing, cleaning premises;
- (iv) Pasteurising, cooling, separating of milk;
- (v) Cleaning, utensils or receptacles;
- (vi) Blending, testing, sampling;
- (vii) Other incidental operations;

(b) Clerical work or canvassing when incidental to and carried on in conjunction with the work specified in 1 above.

But excluding any operations in :-

(a) The transport of goods by common carriers;

(b) Any industry or trade concerned exclusively with carting and operations incidental thereto;

(c) Post Office business;

(d) Agriculture within the meaning of the Corn Production Act, 1917.

PART VII.

Section I.—The above Minimum Rates of Wages must be paid clear of all deductions other than deductions under the National Insurance Act, 1911, as amended by any subsequent enactments, or deductions authorised by any Act to be made from wages in respect of contributions to any superannuation or other provident fund.

Section II.—The above Minimum Rates of Wages are without prejudice to workers who are earning higher rates of wages, or to agreements made or that may be made between employers and workers for the payment of wages in excess of these Minimum Rates of Wages.

The Trade Boards Acts provide, amongst other things, that-

(1) Exemption from Rates.—Where a time-worker is affected by infirmity or physical injury which renders him incapable of earning the General Minimum Time-Rate or Overtime Rate, and the Trade Board are of opinion that the case cannot suitably be met by employing the worker on piece-work, the Board may, on such conditions as they think fit, grant a certificate exempting the worker from payment at the minimum rate. All applications for such a permit of exemption should be made on a form to be obtained from the Secretary of the Trade Board.

(2) Workers Employed on Piece-Work.—Where no general or special minimum piece-rates or

(2) Workers Employed on Piece-Work.—Where no general or special minimum piece-rates or piece-work basis time-rates are effective, an employer must pay workers engaged on piece-work piece-rates each of which will yield, in the circumstances of the case, to an ordinary worker, at least

the same amount of money as the General Minimum Time-Rate.

(3) Waiting Time to be Paid for.—A worker must be paid at the General Minimum Time-Rate appropriate to him in respect of all time during which he is present on the premises of the employer (except during normal meal-times in a room or place where no work is being done), unless the employer can show that the worker (a) was present without the employer's consent, express or implied, or (b) was present for some purpose unconnected with his work and other than waiting for work, or (c) was present only by reason of the fact that he was resident on the premises.

A worker employed on piece-work is deemed during his waiting time to have been employed

at the General Minimum Time-Rate.

(4) Duty of Employer to keep Wages and Time Records.—Every employer must keep such records of wages as are necessary to show that the minimum rates are being paid and the other provisions of the Acts complied with. Failure to do this renders the employer liable to a fine not exceeding £2 for each offence, and to a fine not exceeding £1 for every day during which the offence continues after conviction.

(5) Premiums not Allowed except in certain cases.—An employer may not receive, directly or indirectly, any premium from an apprentice or learner to whom a minimum rate is applicable, unless it be a premium paid not later than four weeks after the commencement of employment in pursuance of an instrument of apprenticeship.

(6) Penalties for Paying less than the Minimum Rates.—(a) The penalty for paying wages at less than the minimum rates (clear of all deductions, as set out in Section I. of Part VII. above) is a fine not exceeding £20 for each offence, and a fine not exceeding £5 for each day on which the

offence is continued after conviction.

(b) On conviction for failure to pay the minimum rate, the Court may order the employer convicted to pay arrears of wages due.

(c) Onus of Proof on Employer.—On a charge of failing to pay wages at not less than the minimum rate, the onus rests upon the employer of proving that there has been no such failure.

(d) Agreements Void.—Any agreement for payment of wages at less than the minimum rate is

(7) Liability of Agents.—An agent of an employer, or any other person who commits any offence

for which an employer is liable to a fine, is liable to the same penalty as the employer.

The above notes are explanatory only, and must not be regarded as a full or authoritative interpretation of the Trade Boards Acts, 1909 and 1918. These Acts can be obtained from H.M. Stationery Office, Imperial House, Kingsway, London, W.C. 2.

PROPOSAL TO VARY MINIMUM RATES OF WAGES FOR FEMALE WORKERS.

In accordance with Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour, and dated 31st October 1918, and 1st August 1922, the Trade Board established under that Act and the Trade Boards Provisional Orders Confirmation Act, 1913, for the Shirtmaking Trade in Great Britain, as defined in the Regulations made by the Board of Trade and dated 26th December 1913, as varied by the Trade Boards (Shirtmaking) Order, 1920, HEREBY GIVE NOTICE, as required by Section 3 (5) of the Trade Boards Act, 1918, that they PROPOSE TO VARY the Minimum Rates of Wages for Female Workers, as present effective and set out in the Trade Board's Notice S. (7) dated 1st July 1922, the proposed Variations being as shown in the Schedule below.

For the purpose of determining the rate applicable, all employment prior to the age of 14 shall be disregarded.

- (i) The advances to be given to Learners commencing at under 21 years of age shall become due as from the first Monday in January and July of each year, the Learner being entitled to her first advance on the first Monday in January or July, as the case may be, provided that she has been in the trade at least three months.
- (ii) A Learner shall cease to be a Learner, and be entitled to the full General Minimum Time-Rate applicable to her under Section I. of this Part of this Schedule, upon the fulfilment of the conditions appropriate to her as set out below:—

Age of entering upon employment.	Conditions.
Under 15 years of age	The completion of not less than three years' employment, and the attainment of the age of 18 years.
15 and under 16 years of age	The completion of not less than two years' employment, and the attainment of the age of 18 years.
16 and under 21 years of age 21 years of age and over	The completion of two years' employment. The completion of one year's employment.

- (iii) No Female Learner shall be held to be entitled to the full General Minimum Time-Rate applicable under Section I. of this part of this Schedule until she has attained the age of 18 years, notwithstanding any employment she may have had.
- (iv) In determining the age of entry and the length of employment, all service prior to the age of 14 shall be disregarded.
- (v) For the purpose of reckoning the General Minimum Time-Rate to which a learner is entitled and of determining the date on which she ceases to be entitled to be employed as a learner, a learner shall be entitled to include all previous employment (a) in any branch of the Shirtmaking Trade as referred to in Part V. of this Schedule, and (b) in the making wherever carried on of overalls for male and female persons.
- (vi) If the conditions specified in Section I. of Part IV. are not complied with the rate applicable is that set out in Section I. of this Part of this Schedule.

Note.—The conditions at present attached by the Trade Board to the minimum rates of wages for female learners are set out in Section II. of Part I. of the Trade Board's Notice S. (7) dated 1st July 1922.

PART II.

PROPOSED VARIATION OF PIECE WORK BASIS TIME-RATES FOR FEMALE WORKERS.

(a) Workers other than Homeworkers as de-Proposed Variation. fined in Section II. of Part IV. of this from $8\frac{1}{2}d$. per hour to $7\frac{1}{2}d$. per hour. Schedule (b) Homeworkers (as so defined) ,, 8<u>₹</u>d. 71d.

Note.—In the case of workers employed on piece-work, each piece-rate paid must be such as would yield, in the circumstances of the case to an ORDINARY WORKER of the class in ques-

tion, not less than the Piece-Work Basis Time-Rate appropriate to the class.

In determining whether any piece rate satisfies the above-mentioned condition, regard must be had only to the earnings of ordinary workers, i.e., workers of ordinary skill and experience in the class of work in question and not to the earnings of workers of less than ordinary skill and experience, e.g., learners and infirm workers.

PART III.

PROPOSED VARIATION OF OVERTIME RATES FOR FEMALE WORKERS

In accordance with Section 3 (1) (c) of the Trade Boards Act, 1918, the Trade Board HAVE DECLARED THE NORMAL NUMBER OF HOURS OF WORK IN THE TRADE to be as follows:-

48 TOMARY PUBLIC AND STATUTORY HOLIDAYS

Provided that all hours worked by a worker on Sundays and Customary Public and Statutory Holidays and hours worked on Saturdays (subject to the provisions set out below) shall be regarded as Overtime, to which the Overtime Rates shall apply.

The Proposed Minimum Rates for Overtime in respect of hours worked by a worker in excess

of the declared normal number of hours shall be as follows:-

(A)—FOR FEMALE WORKERS EMPLOYED ON TIME-WORK:—

- (1) ON ANY DAY OTHER THAN SATURDAYS, SUNDAYS, AND CUSTOMARY PUBLIC AND STATUTORY HOLIDAYS:—
 - (a) For the first two hours of Overtime, One-and-a-Quarter times the General Minimum Time-Rate otherwise applicable, i.e., TIME-AND-A-QUARTER.
 - (b) For the second two hours of Overtime, One-and-a-Half times the General Minimum Time-Rate otherwise applicable, i.e., TIME-AND-A-HALF.
 - (c) For Overtime after the first four hours of Overtime, Twice the General Minimum Time-Rate otherwise applicable, i.e., DOUBLE TIME.

Provided that where it is the established practice of an employer only to require attendance on 5 days a week, the Overtime Rates specified in sub-paragraphs (a), (b) and (c) of this paragraph shall not be payable on any day (other than Saturdays, Sundays and Customary Public and Statutory Holidays) until the number of hours worked exceeds 91, 111, and 131 respectively.

- (2) ON SATURDAY in respect of:
- (a) That class of worker who customarily attends on SIX DAYS a week:—

For all Overtime worked after the first five hours of work:

- (i) For the first four hours of Overtime, One-and-a-Half times the General Minimum
- Time-Rate otherwise applicable, i.e., TIME-AND-A-HALF.

 (ii) For Overtime after the first four hours of Overtime, Twice the General Minimum Time-Rate otherwise applicable, i.e., DOUBLE TIME.
 - (Note.—During the first five hours worked on Saturday, the Minimum Rate applicable to the class of workers specified in this sub-paragraph is the appropriate General Minimum Time-Rate set out in Part I. of this Schedule.)
- (b) That class of worker who customarily attends on FIVE DAYS a week:-
 - (i) For the first two hours of Overtime (that is to say, for the first two hours worked on Saturday), One-and-a-Quarter times the General Minimum Time-Rate otherwise applicable, i.e., TIME-AND-A-QUARTER.
 - (ii) For the second two hours of Overtime, One-and-a-Half times the General Minimum Time-Rate otherwise applicable. i.e., TIME-AND-A-HALF.
 - (iii) For Overtime after the first four hours of Overtime. Twice the General Minimum Time-Rate otherwise applicable, i.e., DOUBLE TIME.
- (3) ON SUNDAYS AND CUSTOMARY PUBLIC AND STATUTORY HOLIDAYS:— For all time worked. Twice the General Minimum Time-Rate otherwise applicable. i.e., DOUBLE TIME.
- Note —The proposed Overtime Rates set out in paragraphs (1), (2), and (3) of this Sub-Sec-

tion shall be payable as provided above in respect of all hours of Overtime worked on any day. notwithstanding that the number of hours worked in the week does not exceed 48.

(4) For all hours worked in any week in excess of 48, One-and-a-quarter times the General Minimum Time-Rate otherwise applicable, i.e., TIME-AND-A-QUARTER, except in so far as higher Overtime Rates are payable under the provisions of paragraphs (1) (b) and (c), (2) (a) and (b) (ii) and (iii), and (3) of this Sub-Section.

Provided that where it is the established practice of an employer to require attendance only on alternate Saturdays, the Overtime Rate shall not be payable in the week in which

attendance on Saturday is required until 50 hours have been worked.

(5) Where it is, or may become, the established practice of an employer to require attendance on Sunday instead of Saturday, the Minimum Rates for Overtime as set out in this Section . shall apply to workers in like manner as if in the provisions of this Schedule as to Overtime the word "Saturday" were substituted for "Sunday" and the word "Sunday" for Saturday.'

(B) -FOR FEMALE WORKERS EMPLOYED ON PIECE-WORK:-

(1) ALL FEMALE WORKERS, other than learners, employed on Piece-Work, shall receive in respect of each Hour of Overtime worked, in addition to payment at Piece-Rates, each of which would yield in the circumstances of the case, to an ORDINARY worker not less than the Piece-Work Basis Time-Rate applicable, an amount equal to One-Quarter of the appropriate Piece Work Basis Time-Rate, One-Half of the appropriate Piece-Work Basis Time-Rate, or to the appropriate Piece-Work Basis Time-Rate according as the Overtime Rate which would have been payable under the provisions of Sub-Section (A) of this Section if the worker had been employed on Time-Work, were TIME-AND-A-QUARTER,

TIME-AND-A-HALF, or DOUBLE TIME respectively.

(2) ALL FEMALE LEARNERS, employed on Piece-Work, shall receive in respect of each hour of Overtime worked, in addition to payment at Piece-Rates each of which would yield in the circumstances of the case to an Ordinary Worker not less than the Piece-Work Basis Time-Rate applicable, an amount equal to One-Quarter of the appropriate General Minimum Time-Rate, One-Half of the appropriate General Minimum Time-Rate, or to the appropriate General Minimum Time-Rate according as the Overtime Rate which would have been payable under the provisions of Sub-Section (A) of this Section if the worker had been employed on Time-Work, were TIME-AND-A-QUARTER, TIME-AND-A-HALF, or

DOUBLE TIME respectively.

PART IV.

SECTION I.

For the purpose of this Notice the following definitions shall apply: A Female Learner is a Worker who:

(a) Is employed during the whole or a substantial part of her time in learning any branch or process of the trade by an employer who provides the Learner with reasonable facili-

ties for such learning; and
(b) Has received a certificate or has been registered in accordance with rules from time to time laid down by the Trade Board, or has made application for such certificate or registration which has been duly acknowledged and is still under consideration. Provided that the certificate or registration of a Learner may be cancelled if the other conditions of Learnership are not complied with.

Provided that an employer may employ a Female Learner, on her first employment, in the branch or branches of the trade as referred to in Part V. of this Schedule, without a certificate or registration for a probation period not exceeding four weeks, but the probation period shall be

included in her period of Learnership.

Provided that notwithstanding compliance with the conditions contained in this Section a person shall not be deemed to be a Learner if she works in a room used for dwelling purposes and is not in the employment of her parent or guardian.

SECTION II.

A Homeworker is a Worker who works in her own home or in any place not under the control or management of the employer.

PART V.

The above proposed Minimum Rates of Wages shall apply, subject to the provisions of the Trade Boards Acts, to all FEMALE WORKERS in respect of all time during which they are employed in Great Britain in any branch of the trade specified in the Trade Boards (Shirtmaking) Order, 1920, as set out in Part V. of the Schedule to the Notice S. (7) issued by the Trade Board and dated 1st July 1922.

Note. — The employment of women, young persons and children is subject to the provisions of the Factory and Workshop Acts, and to the provisions of the Employment of Women, Young Persons, and Children Act, 1920.

The Trade Board will consider any OBJECTIONS to the above Proposal to Vary which may be lodged with them within two months from the 5th day of January 1923. Such objections should be in writing and signed by the person making the same (adding his or her full name and address), and should be sent to the Secretary of the Shirtmaking Trade Board (Great Britain), 1 Whitehall Gardens, London, S.W. 1.

It is desirable that the Objections should state precisely, and, so far as possible, with reasons, what is objected to

JUTE TRADE BOARD (GREAT BRITAIN).

MINIMUM RATES OF WAGES FOR MALE LOOM TENTERS OF 21 YEARS OF AGE AND OVER WITH A RECOGNISED FULL CHARGE, EFFEC-TIVE AS FROM 8TH JANUARY 1923.

Should this date not correspond with the beginning of the period for which wages are paid by an employer who pays wages at intervals not exceeding seven days, the rates shall become effective as from the beginning of the next full-pay period, but in any case not later than 14th January 1923.

SCHEDULE.

PART I.

GENERAL MINIMUM TIME-RATES AND OVERTIME RATES FOR MALE LOOM TENTERS OF 21 YEARS OF AGE AND OVER WITH A RECOGNISED FULL CHARGE.

Section I.—(a) General Minimum Time-Rate, 56s 8d per week of 48 hours.

(b) The General Minimum Time-Rate set out in (a) above, is a weekly rate based on a week of 48 hours, and is subject to a proportionate adjustment according as the number of hours of employment in any week is less than 48.

Section II.—Overtime Rates calculated on the general minimum time-rate set out in Section I, in the manner specified in Part III, of the Schedule to the Trade Board's Notice J (18) dated 7th February 1922, apply in substitution for the general minimum time-rate set out in Section I, in respect of all hours worked in excess of the number of hours declared by the Trade Board in the Schedule to the above-mentioned Notice J (18) to be the normal number of hours of work in the trade.

PART II.

The above Minimum Rates of Wages apply, subject to the provisions of the Trade Boards Acts, to all workers of the class specified in Part I. of this Schedule in respect of all time during which they are employed in Great Britain in any branch of the trade specified in the Trade Boards (Jute) Order, 1919, and set out in Part VI. of the Schedule to the Trade Board's Notice J (18) dated 7th February 1922.

PART III.

The above minimum rates of wages must be paid clear of all deductions other than deductions under the National Insurance Act, 1911, as amended by any subsequent enactments or deductions authorised by any Act to be made from wages in respect of contributions to any superannuation or other provident fund.
