#### PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 5th day of April 1923 (C.W.11741/21), in the words following, viz.:--

"Whereas Your Majesty was graciously pleased, by Your Orders in Council bearing dates the 26th day of October 1914, and the 29th day of January 1923, to provide that the rank of Lieutenant-Commander or its equivalent should be extended to Officers of certain classes on the Retired and Emergency Lists who were retired from the rank or equivalent rank of Lieutenant and have attained or may attain eight years' seniority therein, these classes including certain of the Warrant Officer classes in Your Majesty's Navy:

"And whereas we are of opinion that advancement to the rank or equivalent rank of Lieutenant-Commander on the Retired List should be extended to all Warrant Officer classes under similar conditions:

"We beg leave humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council, to give authority for all Officers retired from the rank or equivalent rank of Lieutenant in Warrant Officer Branches which are not provided for in Your Orders in Council, bearing dates the 26th day of October 1914, and the 29th day of January 1923, or in which the rank or equivalent rank of Lieutenant on the Active List may be established in future, to be advanced at our discretion to the rank or equivalent rank of Lieutenant-Commander on attaining eight years' seniority in the rank of Lieutenant or its equivalent.

"The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in this proposal."

His Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of His Privy Council, to approve of what is therein proposed.

And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly.

This Notice sets out all the Minimum Rates of Wages for Male and Female Workers, as varied by the Trade Board and confirmed by Orders of the Minister of Labour, which are at present effective under the Trade Boards Acts, and takes the place of all Notices other than the Trade Board's Notice O.F. (7), which must be read in conjunction herewith.

The Minimum Rates of Wages set out in the Schedule below are effective as follows :-----

(1) For Male Workers ... ... ... As from 1st May 1923.\* (2) For Female Workers ... As from 1st January 1923.

\* Should this date not correspond with the beginning of the period for which wages are paid by an employer who pays wages at intervals not exceeding seven days, the rates shall become effective as from the beginning of the next full pay period, but in any case not later than 7th May 1923.

In the case of workers employed on piece-work, each piece-rate paid must be such as would yield, in the circumstances of the case, not less than the appropriate Piece-Work Basis Time-Rate to an Ordinary Worker, *i.e.*, a worker of the class in question of ordinary skill and experience.

# PART III.

## OVERTIME RATES.

Overtime Rates calculated on the appropriate minimum rate of wages specified in Parts I. and 11. of this Schedule in the manner set out in Part III. of the Trade Board's Notice O.F. (7), dated 18th April 1923, apply in substitution for the rates set out in Parts I. and II. of this Schedule in respect of all time worked in excess of the number of hours declared by the Trade Board in the above-mentioned Notice O.F. (7) to be the normal number of hours of work in the Trade.

The above Minimum Rates of Wages must be paid clear of all deductions other than deductions under the National Insurance Act, 1911, as amended by any subsequent enactments, or deductions authorised by any Act to be made from wages in respect of contributions to any Superannuation or other Provident Fund.

DEFINITIONS, CONDITIONS AND PROVISIONS GOVERNING THE APPLICATION OF ALL MINI-MUM RATES OF WAGES EFFECTIVE IN THE TRADE UNDER THE TRADE BOARDS ACTS.

#### SCHEDULE.

# PART I.

# Female Learners.

SECTION I.—For the purpose of the application of the Minimum Rates of Wages effective for Female Learners:—

A Female Learner is a worker who-

(a) Is employed during the whole or a substantial part of her time in learning any branch or process of the trade specified in Part IV. of this Schedule by an employer who provides the learner with reasonable facilities for such learning; and

(b) has received a certificate or has been registered in accordance with rules from time to time laid down by the Trade Board, and held subject to compliance with the conditions contained in this Section, or has made an application for such certificate or registration which has been duly acknowledged and is still under consideration. Provided that the certification or registration of a learner may be cancelled if the other conditions of learnership are not complied with.

Provided that an employer may employ a female learner on her first employment without a certificate or registration for a probation period not exceeding four weeks, but in the event of such learner being continued thereafter at her employment the probation period shall be included in her period of learnership.

If the conditions set out above are not complied with the minimum rate of wages payable to a female worker irrespective of her age and experience is that applicable to female workers other than learners.

Provided that, notwithstanding compliance with the conditions contained in this Section, a person shall not be deemed to be a learner if she works in a room used for dwelling purposes and is not in the employment of her parent or guardian.

SECTION II.—The Minimum Rates of Wages effective for female Learners are subject to the following provisions affecting (a) the payment of Advances and (b) the termination of the period of Learnership.

(a) The advances to be given to learners shall become due as from the first Monday in January and July of each year, the learner being entitled to her first advance as from the first Monday in January or July, as the case may be, provided that she has been in the trade at least three months.

(b) A learner shall cease to be a learner  $\begin{vmatrix} 2 \\ 2 \end{vmatrix}$ 

and be entitled to the full General Minimum Time-Rate applicable to workers other than learners, upon the fulfilment of the following conditions:—

#### Age of Entering upon Employment and Conditions.

14 and under 16 years of age.—The completion of not less than two years' employment and the attainment of the age of 18 years.

16 years of age and over.—The completion of two years' employment.

No female learner shall be entitled to the full General Minimum Time-Rate for workers other than learners until she has attained the age of 18 years, notwithstanding any employment she may have had.

In determining the age of entry and the length of employment, all service prior to the age of 14 shall be disregarded.

# PART II.

#### Home Workers.

For the purpose of the application of the Minimum Rates of Wages :---

A "Homeworker" is a worker who works in her own home or any other place not under the control or management of the employer.

# PART III.

#### Provisions as to Overtime Rates.

SECTION I.—In accordance with Section 3 (1) (c) of the Trade Boards Act, 1918, the Trade Board have declared the Normal Number of Hours of Work in the Trade to be as follows:—

In any week	$48^{\circ}$
On any day (other than Saturday)	9
On Saturday	5

Provided that any other day (not being Sunday) may be substituted by an employer for Saturday as the weekly short day, and in such case the normal number of hours of work on such substituted day shall be 5, and the normal number of hours on Saturday shall be  $\sigma$ 

Provided also that all time worked by a worker on Sundays and on Customary Public and Statutory Holidays shall be regarded as overtime to which the Overtime Rates shall apply.

SECTION II.—The Minimum Rates for Overtime in respect of all time worked by a worker in excess of the declared normal number of hours shall be calculated as follows :—

(A) For Workers Employed on Time-Work:

1. For the first two hours of overtime on any day, except Saturdays (or the weekly short day substituted therefor), Sundays, and Customary Public and Statutory Holidays, the Overtime Rate shall be one-and-a-quarter times the minimum rate otherwise applicable, that is to say, Time-and-a-Quarter.

2. For overtime after the first two hours of overtime on any day except Sundays, and Customary Public and Statutory Holidays, and for all overtime on Saturdays (or the weekly short day substituted therefor), the Overtime Rate shall be one-and-a-half times

is to say, Time-and-a-Half. 3. For all time worked on Sundays and Customary Public and Statutory Holidays the Overtime Rate shall be twice the minimum rate otherwise applicable, that is to say, Double-Time.

4. For all time worked in any week in excess of 48 the Overtime Rate shall be Timeand a Quarter except in so far as higher overtime rates are payable under the provisions of paragraphs 2 and 3 of this Section. The Overtime Rate shall be payable where on any day (not being a Sunday or a Customary Public or Statutory Holiday) the number of hours worked exceeds 9 or, in the case of Saturday (or the weekly short day substituted therefor), exceeds 5, notwithstanding that the number of hours worked in the week does not exceed 48.

(B) For Workers Employed on Piece-Work: Workers employed on Piece Work shall receive in respect of all overtime worked, in addition to Piece-Rates, each of which would yield, in the circumstances of the case, to an Ordinary worker, not less than the Piece-Work Basis Time-Rate applicable, a sum equivalent to one-quarter of the appropriate Piece-Work Basis Time-Rate, one-half of the appropriate Piece-Work Basis Time-Rate or the appropriate Piece-Work Basis Time-Rate, according as the Overtime Rate which would have been payable under the provisions of paragraph (A) of this Section if the worker had been employed on Time-Work, v Time-and-a-Quarter, Time-and-a-Half, were Time-and-a-Quarter, or Double-Time, respectively.

SECTION III. — Notwithstanding anything contained in Sections I. and II. of this Part, in the application of the Overtime Rates the following provisions shall apply :-

(a) That where it is or may become the established practice of an employer only to require attendance on 5 days a week, the Overtime Rate shall only be payable on such days after 91 hours have been worked.

(b) That where it is or may become the established practice of an employer to require attendance only on alternate Saturdays, the Overtime Rate in the week in which attendance on Saturday is required shall only be payable after 50 hours have been worked.

(c) That where it is or may become the established practice of an employer to require attendance on Sunday instead of Saturday the Minimum Rates for Overtime as set out above shall apply in like manner as if in the provisions of this Notice as to Overtime the word "Saturday" were substituted for "Sunday" and the word "Sunday" for "Saturday."

# PART IV.

#### Applicability of Minimum Rates of Wages.

SECTION I.—Subject to the provisions of the Trade Boards Acts, the Minimum Rates of Wages effective under these Acts in the Ostrich and Fancy Feather and Artificial Flower Trade apply to all Male and Female Workers (other than those specified in Section II. of this Part) in respect of all time during which they are employed in Great Britain in any branch of the trade specified in the Trade Boards (Ostrich

the minimum rate otherwise applicable, that and Fancy Feather and Artificial Flower) Order, 1920.

> SECTION II.—The Minimum Rates of Wages effective shall not apply to Male Workers employed as Dyers in the Feather Trade.

> The Trade as specified in the above-mentioned Order is as follows :--

1. The preparation throughout of ostrich or fancy feathers from the natural condition to the finished feather product.

2. The making of artificial flowers, fruit, foliage, grasses, mosses, seeds or pods from paper, wax, textile materials, porcelain, glass, plaster, metal composition, rubber, leather, raffia, celiphane and similar materials.

3. The preservation of natural flowers, foliage, grasses, mosses, ferns, seeds or pods.

4. The making of hats of any of the articles specified in paragraphs 1, 2 and 3 above, when made in or in association with or in conjunction with any business or establishment or branch or department or workroom mainly engaged in any of the operations specified in those paragraphs.

5. The making of feather garments (in-cluding neckwear and muffs), feather trimmings for dresses, feather fans or feather mountings of any description, when made in or in association with or in conjunction with any business or establishment or branch or department or workroom mainly engaged in the preparation of ostrich or fancy feathers.

6. The cleaning, dyeing or renovating of any of the articles specified in paragraphs 1, 2 and 3 above, when carried on as a main business or in association with or in conjunction with any business or establishment or branch or department or workroom mainly engaged in any of the operations specified in those paragraphs.

#### Including :

7. (a) Any of the following and similar operations or processes known in the trade as :-

- (i) The sorting, stringing, washing, bleaching, dyeing, beating, scraping, laying up. sewing, curling, finishing, sticking, twisting, mounting of ostrich or fancy feathers.
- (ii) Pattern-making, dyeing, stiffening, waterproofing, waxing, cutting, stamp ing, shading, veining, goffing, mould making, mounting, in connection with the manufacture of artificial flowers, fruits, foliage, grasses, mosses, seeds or pods.
- (iii) The dyeing, preserving, painting, varnishing, or decorating of natural flowers, foliage, grasses, mosses, ferns, seeds or pods.
- (b) The making of any of the articles specified in paragraph 2 above by needlework processes, when carried on in or in association with or in conjunction with a business or establishment or branch or department or workroom mainly engaged in any of the operations specified in that paragraph.
- (c) The making or mounting of any of the articles specified in paragraphs 1, 2 and 3 above for cakes or cracker ornaments, except when made or mounted in, or in as-

sociation with, or in conjunction with, an establishment or business or branch or department or workroom which is mainly engaged in the making of crackers.

- (d) The mounting (whether singly or in festoons or garlands) or assembling of any of the articles specified in paragraphs 1, 2 and 3 above for the purpose of decoration when mounted or assembled in a business or establishment or branch or department or workroom mainly engaged in these operations.
- (e) The warehousing of, the packing of, and similar operations, in regard to any of the articles specified in paragraphs 1 to 5 above, when carried on in or in association with or in conjunction with a business or establishment or branch or department or workroom mainly engaged in any of the operations specified in paragraphs 1 to 6 above.

#### But excluding :—

- 8. (a) The making of any of the articles mentioned in paragraph 2 above in a business or establishment or branch or department or workroom which is mainly engaged in the manufacture of the materials specified in that paragraph, and not of the articles therein specified.
  - (b) The preparation, making, or preservation of any of the articles specified in paragraphs 1, 2 and 3 above, when carried out in a business or establishment or branch or department or workroom mainly engaged in the manufacture of stationers' sundries.
  - (c) The stiffening or preparation of textile materials for the making of any of the articles mentioned in paragraph 2 above, when carried on in a business or establishment or branch or department or workroom mainly engaged in the preparation of textile materials for other purposes.
  - (d) The making of any of the articles specified in paragraph 2 above wholly from

metal, or the mounting thereof when so made or the making or mounting of plaster flowers, fruits, or foliage, except when made or mounted:—

- (i) For funeral tokens, wreaths or crosses.
- (ii) In association with, or in conjunction with the making of any of the articles specified in paragraph 2, from any of the materials specified therein.
- (iii) For cake or cracker ornaments as specifically mentioned in the operations and processes included in the trade.
- (e) The making from rubber of any of the articles mentioned in paragraph 2 above or the mounting thereof when so made, where carried on in or in association with or in conjunction with a business or establishment or branch or department or workroom mainly engaged in the manufacture of other rubber articles.
- (f) All operations covered by the following Orders:---
  - (i) The Trade Boards (Sugar Confectionery and Food Preserving) Order, 1913.
  - (ii) The Trade Boards (Hat, Cap and Millinery) Order, 1919.
  - (iii) The Trade Boards (Women's Clothing) Order, 1919.
  - (iv) The Trade Boards (Toy) Order, 1920.

Note.—The employment of women, young persons and children is subject to the provisions of the Factory and Workshop Acts, the Employment of Women, Young Persons and Children Act, 1920, and the Education Acts, 1918 and 1921.

# PROPOSAL TO VARY AND CANCEL MINIMUM RATES OF WAGES FOR CERTAIN CLASSES OF MALE AND FEMALE WORKERS.

In accordance with Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour, and dated 31st October 1918 and 1st August 1922, the Trade Board established under the Trade Boards Act, 1918, in Great Britain for the Hair, Bass and Fibre Trade as specified in the Trade Boards (Hair, Bass and Fibre) Order, 1919, HEREBY GIVE NOTICE as required by Section 3 (5) of the Trade Boards Act, 1918, that they PROPOSE TO VARY the General Minimum Time-Rates, Piece-Work Basis Time-Rates and Overtime Rates at present fixed and set out in Parts I. to V. of the Schedule to their Notice H.B. (10), dated 17th June 1922, for Certain Classes of Male and Female Workers, and to CANCEL the Minimum Rates of Wages at present fixed and set out in the said Notice H.B. (10) in their application to Certain Classes of Workers, as shown in the Schedule set out below.

# PART I.
