"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, *inter alia*, that all pay, pensions or other allowances in the nature thereof payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman, or Marine therein, shall be paid in such manner and subject to such restrictions, conditions and provisions as are from time to time directed by Order in Council:

"And whereas in the Regulations for the retirement of Officers of Your Majesty's Naval or Marine Force, which have been established by Order in Council from time to time, provision is made for the grant of retired pay at certain rates to Sub-Lieutenants and paymaster Sub-Lieutenants of Your Majesty's Navy and Lieutenants with less than four years' commissioned service and Second Lieutenants of the Royal Marines if invalided from Your Majesty's Service under certain conditions:

"And whereas we consider it desirable that the retiring allowances payable to Officers of these ranks if invalided and the conditions under which such allowances may be granted should be revised, and that corresponding provision should be made for Acting Sub-Lieutenants, Midshipmen, Acting Paymaster Sub-Lieutenants and Paymaster Midshipmen of Your Majesty's Navy and Probationary Second Lieutenants of the Royal Marines if discharged for physical unfitness not attributable to service:

We beg leave humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council, to sanction the proposals set forth in the annexed Schedule with effect from the first day of October 1921.

WHEREAS by Section 5 of the Merchant Shipping (Mercantile Marine Fund) Act, 1898, it is, amongst other things, enacted as follows:—

"5.—(1) On and after the commencement of this Act, the general lighthouse authorities shall levy light dues with respect to the voyages made by ships or by way of periodical payment, and not with respect to the lights which a ship passes or from which it derives benefit, and the dues so levied shall take the place of the dues now levied by those authorities.

"(2) The scale and rules set out in the Second Schedule to this Act shall have effect for the purpose of the levying of light dues in pursuance of this Act, but Her Majesty may, by Order in Council, alter, either generally or with respect to particular classes of cases, the scale or rules and the exemptions therefrom."

And whereas by divers Orders in Council the said Scale was altered by reducing each of the dues thereby authorised to be levied, by the respective amounts referred to in the respective Orders in Council, but by Order in Council, dated the 30th March 1916, the respective Orders in Council referred to were repealed for the purpose of once more giving full effect to the Scale and Rules set out in the Second Schedule to the Act above referred to:

And whereas by Order in Council, dated the 30th day of July 1919, it was provided (*inter alia*) that each of the dues authorised to be levied by the said Scale should, as from the 1st day of January 1919, be subject to an increase of forty per cent. beyond the amount of the dues specified in the said Scale :

And whereas by Order in Council, dated the 22nd July 1920, it was provided that each of the dues authorised to be levied by the said Scale should, as from the 1st day of April 1920, be subject to an increase of one hundred per cent. beyond the amount of the dues specified in the said Scale, in lieu of the increase of forty per cent. mentioned in the said Order in Council, dated the 30th day of July 1919:

And whereas it has been made to appear to His Majesty that the Scale and Rules set out in the said Second Schedule should be further altered in manner hereinafter appearing:

Now, therefore, His Majesty, in exercise of the powers conferred upon Him by the hereinbefore recited Section, and by and with the advice of His Privy Council, doth order, and it is hereby ordered, that each of the dues authorised to be levied under the hereinbefore recited Order in Council, dated the 22nd day of July 1920, shall as from the 1st day of October 1922, up to and including the 31st day of March 1923, be subject to a reduction of fifteen per cent. from the amount of the dues thereby authorised to be levied and shall, as from the 1st day of April 1923, be subject to a reduction of thirty per cent. from the amount of the dues authorised to be levied under the said Order in Council, dated the 22nd day of July 1920, and the said dues as so reduced respectively shall be levied and the Rules construed accordingly.

V., c. 50, initial "An Act to make such amendments of the law relating to Merchant Shipping as are necessary or expedient to give effect to an International Convention for the Safety of Life at Sea" (being the Convention above referred to) was passed on the 10th day of August 1914, the short title of which is "The Merchant Shipping (Convention) Act, 1914":

And whereas by Section 29, Sub-section 5, of the said Act it was provided as follows :---

"This Act shall come into operation on the 1st day of July 1915:

"Provided that His Majesty may, by Order in Council, from time to time postpone the coming into operation of this Act for such period, not exceeding on any occasion of postponement one year, as may be specified in the Order ":

And whereas by divers Orders in Council the coming into operation of the said Act has been from time to time postponed, and now stands postponed, by virtue of an Order in Council of the 2nd day of November 1922, until the 1st day of July 1923:

And whereas His Majesty deems it expedient that the provisions of the said Act should be further postponed:

Now, therefore, His Majesty, by and with the advice of His Privy Council, in pursuance of the powers vested in Him by the above-recited provision and of all other powers Him thereunto enabling, doth order, and it is hereby ordered, that the provisions of the Merchant Shipping (Convention) Act, 1914, shall be postponed from coming into operation until the 1st day of January 1924.

On 14th November 1922, in the course of operations at Nixon's Navigation Colliery at Mountain Ash, Glamorganshire, a workman named Jones was completely buried by a heavy fall of stones and rubbish. Four other men were present at the time, and made some attempt to get Jones out, as, although they could not see him, they could hear him moaning. Further falls, however, took place, and the four men, considering the risk too great, retreated under cover.

At this moment Bert Craig, another workman at the Colliery, arrived on the scene, and hearing of what had happened at once ran to where Jones was buried and began to remove the stones. In spite of his appeals for help, the other men present hung back until the falls ceased, but they then came to Craig's assistance, and Jones was extricated. All the time falls were taking place, and within two minutes of Jones being pulled out so large a fall took place that both he and Craig would certainly have been killed.

Craig's action was a very gallant one, and he undoubtedly saved Jones's life. He was working under conditions of very great danger, and his conduct appears even more gallant in view of the fact that he suffers from the result of a severe bullet wound in the head, and any blow might have been fatal.

DEFINITIONS, CONDITIONS, AND PROVISIONS GOVERNING THE APPLICATION OF ALL THE MINIMUM RATES OF WAGES EFFECTIVE IN THE TRADE UNDER THE TRADE BOARDS ACTS.

PART I.

DEFINITIONS.

For the purpose of the application of the Minimum Rates of Wages fixed by the Trade Board, the following definitions shall apply:—

SECTION I.

A Female Learner is a worker who:-

- (a) Is employed by an Employer who provides such Learner with reasonable facilities for practically and efficiently learning the branch of the Trade as carried on by him and the various processes involved in the making of any of the articles specified in the definition of the trade set out in Part IV. of this Notice; and
- (b) Has received a certificate or has been registered in accordance with rules from time to time laid down by the Trade Board, and held subject to compliance with the conditions contained in this Section, or has made an application for such certificate or registration, which has been duly acknowledged and is still under consideration. Provided that the certification or registration of a Learner may be cancelled if the other conditions of Learnership are not complied with.

Provided that an Employer may employ a Female Learner on her first employment without a certificate or registration for a probation period not exceeding four weeks, but in the event of such Learner being continued thereafter at her employment, the probation period shall be included in her period of learnership.

Provided that, notwithstanding compliance with the conditions contained in this Section, a person shall not be deemed to be a Learner if she works in a room used for dwelling purposes, and is not in the employment of her parent or guardian.

SECTION II.

The expression "Homeworker" means a worker who works in her own home or any other place not under the control or management of the employer.

PART II.

PROVISIONS RELATING TO THE MINIMUM RATES OF WAGES FOR FEMALE LEARNERS.

Section I.

With respect to Female Learners in all branches of the trade other than the Wholesale Cloth Hat and Cap making branch:—

- (a) The advances to be given to Learners shall become due on the completion of each twelve months of employment in any branch of the trade other than the Wholesale Cloth Hat and Cap making branch.
- (b) A Learner shall cease to be a Learner and be entitled to the General Minimum Time-Rate applicable to workers other than Learners on the completion of 4 years' employment in any branch of the trade other than the Wholesale Cloth Hat and Cap Making branch.

SECTION II.

With respect to Female Learners in the Wholesale Cloth Hat and Cap Making branch of the Trade:—

(i.) A Learner shall cease to be a Learner and be entitled to the General Minimum Time-Rate applicable to workers other than Learners upon the fulfilment of the conditions appropriate to her as set out below :—

Age of Entering upon Employment and Conditions.

- Under 15 years of age, the completion of three years' employment and the attainment of 18 years.
- 15 and under 16 years of age, the completion of two years' employment and the attainment of the age of 18 years.
- 16 years of age and over, the completion of two years' employment.
- (ii.) No Female Learner shall be entitled to the General Minimum Time-Rate for workers other than Learners until she has attained the age of 18 years, notwithstanding any employment she may have had. Provided that in determining the age of entry and the length of employment all service prior to the age of 14 shall be disregarded.

The Minimum Rates for Overtime in respect of hours worked by a worker, whether employed on Time-Work or on Piece-Work, in excess of the declared normal number of hours, shall be as follows:—

- (1) For the first two hours of Overtime on any day, except Saturdays (or the weekly short day substituted therefor), Sundays and Customary Public and Statutory Holidays, the Overtime Rate shall be One-and-a-Quarter times the minimum rate otherwise applicable, *i.e.*, Time-and-a-Quarter.
- (2) For overtime after the first two hours of overtime on any day except Sundays and Customary Public and Statutory Holidays, and for all overtime on Saturdays (or the weekly short day substituted therefor), the Overtime Rate shall be One-and-a-Half times the minimum rate otherwise applicable, *i.e.*, Time-and-a-Half.
- (3) For all time worked on Sundays and Customary Public and Statutory Holidays, the Overtime Rate shall be Twice the minimum rate otherwise applicable, *i.e.*, Double-Time.
- (4) For all hours worked in any week in excess of 46, the Overtime Rate shall be Time-anda-Quarter, except in so far as higher overtime rates are payable under the provisions of paragraphs 2 and 3 of this Section. The Overtime Rate shall be payable where on any day (not being a Sunday or a Customary Public or Statutory Holiday), the number of hours worked exceeds 8½ or, in the case of Saturday (or the weekly short day substituted therefor), exceeds five, notwithstanding that the number of hours worked in the week does not exceed 46.

Provided-

- (a) That where it is the established practice of an employer only to require attendance on five days a week, the daily Overtime Rate shall only be payable on such days after $9\frac{1}{2}$ hours have been worked.
- (b) That where it is the established practice of an employer to require attendance only on alternate Saturdays, the weekly Overtime Rate specified in paragraph (4) of this Section shall only be payable in the week
- in which attendance on Saturday is required after 50 hours have been worked.

c) That where it is the established practice of an employer to require attendance on Sunday instead of Saturday, the Minimum Rates for Overtime as set out above shall apply in like manner, as if in the provisions of this Notice as to Overtime, the word "Saturday" were substituted for "Sunday" and the word "Sunday" for "Saturday."

SECTION III.

With respect to workers in the Wholesale Cloth Hat and Cap Making branch of the Trade:---

The Minimum Rates for Overtime in respect of hours worked by a worker whether employed on Time-Work or on Piece-Work in excess of the declared normal number of hours shall be as follows:—

- For the first two hours of Overtime subsequent to the first half-hour of Overtime, *i.e.*, for the First Two Hours in excess of 9 hours, on any day except Saturdays (or the weekly short day substituted therefor), Sundays and Customary Public and Statutory Holidays, the Overtime Rate shall be One-and-a-Quarter times the minimum rate otherwise applicable, *i.e.*, Time-and-a-Quarter.
- (2) For Overtime after the first two-and-a-half hours of Overtime, *i.e.*, All Hours in excess of 11 hours, on any day except Sundays and Customary Public and Statutory Holidays, and for all Overtime on Saturdays (or the weekly short day substituted therefor), the Overtime Rate shall be One-and-a-Half times the minimum rate otherwise applicable, *i.e.*, Time-and-a-Half.
- (3) For all time worked on Sundays and Customary Public and Statutory Holidays, the Overtime Rate shall be Twice the minimum rate otherwise applicable, *i.e.*, Double Time.
- (4) For all hours worked in excess of two hours of Overtime in any week, *i.e.*, All Hours in excess of 48 hours, the Overtime Rate shall be Time-and-a-Quarter, except in so far as higher Overtime Rates are payable under the provisions of paragraphs 2 and 3 of this Section.

Provided-

- (a) That where it is the established practice of an employer only to require attendance on five days a week, the daily Overtime Rate shall only be payable on such days after 9½ hours have been worked.
- (b) That where it is the established practice of an employer to require attendance only on alternate Saturdays, the weekly Overtime Rate specified in paragraph (4) of this Section shall only be payable in the week in which attendance on Saturday is required after 50 hours have been worked.
 (c) That where it is the established practice of an employer to require attendance on Sunday instead of Saturday, the Minimum Rates for Overtime as set out above shall apply in like manner as if in the provisions of this Notice as to Overtime the word "Saturday" were substituted for "Sunday" and the word "Sunday" for "Saturday."

Note.—As respects workers in the Wholesale Cloth Hat and Cap Making Branch of the Trade, during the first half-hour in excess] of 81 hours on any day except Saturdays (or the weekly short day substituted therefor), Sundays and Customary Public and Statutory Holidays and during the first two hours in excess of 46 hours in any week, the minimum rate applicable is the appropriate general minimum time-rate or piece-work basis timerate, except in so far as a higher rate may be payable under the provisions of paragraph (3) of this Section.

PART IV.

Applicability of Minimum Rates of Wages. SECTION I.

Subject to the provisions of the Trade Boards Acts the Minimum Rates of Wages which are effective in the Hat, Cap and Millinery Trade (Scotland) apply to all workers in Scotland in respect of all time during which they are employed in any branch of the Hat, Cap and Millinery Trade as specified in the Regulations made by the Minister of Labour, dated 31st March 1920.

Section II.

The Trade as specified in the above-mentioned Regulations is as follows:-

The making from any material of men's, women's or children's headgear, or the trimming thereof;

Including :-

Warehousing, packing or other operations incidental to or appertaining to the making or trimming of men's, women's or children's headgear;

But excluding:

(1) The casting and making of solid metal helmets:

(2) The making of rubberised or oilskin headgear where carried on in association with or in conjunction with the making of other rubberised or oilskin articles;

(3) The making of nurses' or servants' caps, chefs' caps, hospital ward caps, or similar articles; (4) The making of field bonnets,

sunbonnets, boudoir caps, or infants' millinery where carried on in association with or in conjunction with the making of dresses, nontailored skirts, wraps, blouses, blouse-robes, jumpers, sports coats, neckwear, tea-gowns, dressing gowns, dressing jackets, pyjamas, underclothing, underskirts, aprons, overalls, nurses' and servants' caps, juvenile clothing, baby linen or similar articles;

(5) The making of fur hats, where made in association with or in conjunction with the manufacture of furs or furriers' skins into garments, rugs, or similar articles;

(6) The making of knitted headgear and the making of headgear from knitted fabrics where carried on in association with or in conjunction with the manufacture of the knitted fabric;

(7) Warehousing and packing of men's, women's and children's headgear and other similar operations carried on in shops mainly engaged in the retail distribution of articles of any description that are not made or trimmed on the premises.

Note.-The employment of women, young persons and children is subject to the provisions of the Factory and Workshop Acts, the have, after consultation with the Dumfries and 4

Employment of Women, Young Persons and Children Act, 1920, and the Education (Scotland) Act, 1918.

And whereas by the Dumfries and Galloway Joint Sanatorium Board Order, 1920 (herein-after referred to as " the Order of 1920 "), made by the Scottish Board of Health as in right of the powers and duties of the Local Government Board for Scotland by virtue of Sub-section (1) of Section 4 of the Scottish Board of Health Act, 1919, it is provided that the said Joint Board shall be a body corporate, and several amendments were made on the principal Order

And whereas the Scottish Board of Health

Galloway Joint Sanatorium Board, resolved to amend the principal Order and the Order of 1920 as hereinafter contained :

Therefore We, the Scottish Board of Health, by virtue of the powers conferred on Us under the enactments before referred to and of all other powers enabling Us in that behalf Do Hereby Order as follows:-

1. This Order may be cited as the Dumfries and Galloway Joint Sanatorium Board Order, 1923, and shall be read as one with the Principal Order, and the Dumfries and Galloway Joint Sanatorium Board Orders, 1914 and 1920, and this Order may be cited together as the Dumfries and Galloway Joint Sanatorium Board Orders, 1914 to 1923

2. All deeds granted by the Dumfries and Galloway Joint Sanatorium Board shall, in addition to being sealed, be signed by two members of the Board and by the Clerk of the Board.

3. Paragraphs (2) and (3) of Article 2 of the principal Order shall have effect as if the words "twenty-six" were therein substituted for the words "twenty-five," and Paragraph (3) of Article 2 of the principal Order so far as relating to the number of members to be appointed by the Joint Committee of the Town Councils of the Burghs of Dumfries and Maxwelltown shall have effect as if the word "six" were therein substituted for the word " five."

4. Article 4 of the Order of 1920 is hereby revoked, and the following Article shall be substituted for Article 9 of the principal Order :-

"Article 9. Fifty beds (i.e., the accommoda-"tion for fifty patients) shall be provided in the " sanatorium, and these beds shall be allocated " to the combining authorities as follows:-To "the County Council of Dumfries, 22; to the "County Council of Kirkcudbright, 9; to the "County Council of Wigtown, 6; and to the " Joint Committee of Dumfries and Maxwell-"town, 13. The Joint Board may increase the " accommodation for patients to such extent as "We may approve, and such increase shall be " allocated among the combining authorities in " such manner as the Joint Board and the com-" bining authorities may agree, and failing agree-"ment as We, having regard to the whole cir-" cumstances, may determine; and in the event ` of the allocation among the combining authori-" ties of the increase of accommodation being in " different proportions to the allocation of the " original accommodation of fifty beds, such " financial adjustment may be made among the " combining authorities in respect of capital "expenditure previously made or incurred as " the Joint Board and the combining authoritics "may agree, and, failing agreement. as We '' may determine.

5. Notwithstanding anything in Article 10 of the principal Order, all capital expenditure in-curred prior to the date hereof in connection with the provision of the sanatorium at Lochmaben, including the acquisition of land for that purpose, shall be borne by the combining authorities in the same proportions as if this Order had been in operation at the time such expenditure was incurred.
