- A Stamper of Grade III. is a Male Worker of 21 years of age or over who, in addition to fulfilling the conditions of Grade II. as above defined, is an expert in all classes of Stamping, Pressing and Cutting-out by hand or who is a Charge Hand responsible for all work and order in the shop.
- Polishers.—A Polisher of Grade I. is a Male Worker of 21 years of age or over employed on Polishing and not fulfilling the conditions of Grade II. or Grade III. next hereinafter respectively defined.
  - A Polisher of Grade II. is a Male Worker of 21 years of age or over who has had not less than six years' experience as a Polisher and is an expert in all processes of any class of common work and can emery-bob and mop best work.
  - A Polisher of Grade III. is a Male Worker of 21 years of age or over who, in addition to fulfilling the conditions of Grade II. as above defined, is also an expert in all processes of both common and best work or is a Charge Hand responsible for all work and order in the shop.
- Planishers or Wheelers.—A Planisher or Wheeler of Grade I. is a Male Worker of 21 years of age or over employed on Planishing or Wheeling and not fulfilling the conditions of Grade II. or Grade III. next hereinafter respectively defined.
  - A Planisher or Wheeler of Grade II. is a Male Worker of 21 years of age or over who has had not less than six years' experience as a Planisher or Wheeler and is an expert in all processes and is able to do good class work.

SECTION II.—The Overtime Rates for Time-Workers in respect of time worked in excess of the declared normal number of hours of work in the trade are as follows:—

- (a) For all time worked on Customary Public and Statutory Holidays, one-and-a-half times the General Minimum Time-Rate otherwise applicable, *i.e.*, Time-and-a-Half, and
- (b) For all time worked on Sundays, twice the General Minimum Time-Rate otherwise applicable, *i.e.*, Double-Time.
- (c) For all other Overtime worked, one-anda-fifth times the General Minimum Time-Rate otherwise applicable, *i.e.*, Time-and-a-Fifth.

SECTION III.—The Overtime Rates for Piece-Workers in respect of time worked in excess of the declared normal number of hours of work in the trade are as follows :—

- (a) For all time worked on Sundays, piecerates each of which would yield, in the circumstances of the case, to an ordinary worker at least the Piece-Work Basis 'Time-Rate applicable, or where no Piece-Work Basis Time-Rate has been fixed the General Minimum Time-Rate applicable, with the addition in either case of the General Minimum Time-Rate applicable as set out above.
- (b) For all time worked on Customary Public and Statutory Holidays, Piece-Rates each of which would yield, in the circumstances of the case, to an ordinary worker at least the Piece-Work Basis-Time-Rate applicable, or where no Piece-Work Basis Time-Rate has been fixed the General Minimum Time-Rate applicable, with the addition in either case of one-half of the General Minimum Time-Rate applicable as set out above.
- (c) For all other Overtime worked, piecerates each of which would yield, in the circumstances of the case, to an ordinary worker at least the Piece-Work Basis: Time-Rate applicable, or where no Piece-

Work Basis Time-Rate has been fixed the General Minimum Time-Rate applicable, with the addition in either case of one-fifth of the General Minimum Time-Rate applicable as set out above.

SECTION IV.—The Overtime Rates are payable in respect of all time worked in excess of 5 hours on a Saturday and in respect of all time worked in excess of 9 hours on any other day (not being a Sunday or Customary Public or Statutory Holiday) notwithstanding that the total number of hours worked in the week does not exceed 47.

## " COST OF LIVING " CLAUSES.

SECTION. I.—Each "Cost of Living" period referred to in Columns I. to VI. of Part I. and in Columns I. and II. of Part II. of this Schedule, is a period from the first day of the month following the publication in the "Ministry of Labour Gazette" of a Cost of Living figure (as defined in Section II. below), within the range of percentages specified in the appropriate column until the first day of the month following the publication of a figure within the range specified in another column.

Provided that in cases where the first day of the month does not coincide with the beginning of the weekly pay period, the "Cost of Living" period shall begin or end as the case may be at the beginning of the next following weekly pay period.

SECTION II.—The Cost of Living figure specified in this Schedule is :—the average percentage increase since July 1914, in retail prices (all items) in the United Kingdom, as published each month in the "Ministry of Labour Gazette."

SECTION III.—The minimum rates set out in this Schedule are operative only during the several periods specified, or until such time as the cancellation or variation thereof may become effective.

SECTION IV.—The Minimum rates payable on the date specified by the Minister of Labour as the date for which the minimum rates shall become effective, viz., 1st January 1924, are the rates set out in Column III. of Part I. and Column I. of Part II. and Overtime Rates as specified in Part III. of this Schedule.

## PART V.

The Minimum Rates of Wages set out in Parts I., II., and III. of this Schedule apply. Subject to the provisions of the Trade Boards Acts, to all Male Workers in Great Britain in respect of all time during which they are employed in the Coffin Furniture Section of the trade specified in the Trade Boards (Coffin Furniture and Cerement-Making) Order, 1919, that is to say:—

- (a) The manufacture, wherever carried on, of Coffin Furniture from any metal by any process.
- (b) The manufacture of Cerements, including shrouds, face curtains, face cloths.

sidecloths, winding sheets, pillow covers, coffin pads, sleeves or frilling.

Including-

(c) The operations of folding, packing, warehousing, despatching or other operations incidental to or appertaining to the manufacture of any of the abovementioned articles.

## PART VI.

SECTION I .- The General Minimum Time-Rates, Piece-Work Basis Time-Rates and Overtime Rates set out in Parts I., II., and III. of this Schedule must be paid clear of all deductions. other than deductions under National Insurance Act, 1911,the as amended by any subsequent enactments, deductions authorised by 3.0 V Act to be made from wages in respect of contributions to any superannuation or other provident fund.

SECTION II.—The above General Minimum Time-Bates, Piece-Work Basis Time-Bates and Overtime Bates are without prejudice to workers who are earning higher rates of wages, or to agreements made, or that may be made, between employers and workers for the payment of wages in excess of these Minimum Bates of Wages.

Should this date not correspond with the beginning of the period for which wages are paid by an employer who pays wages at intervals not exceeding seven days, the rates become effective as from the beginning of the next full pay period, but in any case not later than 7th January 1924.

- (a) For all time worked on Customary Public and Statutory Elolidays, one-and-a-half times the General Minimum Time-Rate otherwise applicable, *i.e.*, Time-and-a-Half, and
- (b) For all time worked on Sundays, twice the General Minimum Time-Rate otherwise applicable, *i.e.*, Double-Time.
- .(c) For all other Overtime worked, one-anda-fifth times the General Minimum Time-Rate otherwise applicable, *i.e.*, Time-and-a-Fifth.

SECTION III.—The Overtime Rates for Piece-Workers in respect of time worked in excess of the declared normal number of hours of work in the trade are as follows :—

- (a) For all time worked on Sundays, Piece-Rates each of which would yield, in the circumstances of the case, to an ordinary worker at least the Piece-Work Basis Time-Rate applicable, or where no Piece-Work Basis Time-Rate has been fixed the General Minimum Time-Rate applicable, with the addition in either case of the General Minimum Time-Rate applicable as set out above.
- (b) For all time worked on Customary Public and Statutory Holidays, Piece-Rates each of which would yield, in the circumstances of the case, to an ordinary worker at least the Piece-Work Basis Time-Rate applicable, or where no Piece-Work Basis Time-Rate has been fixed, the General Minimum Time-Rate applicable, with the addition in either case of one-half of the General Minimum Time-Rate applicable as set out above.
  (a) For initial action content of the General Minimum
- (c) For all other overtime worked, Pièce-Rates each of which would yield, in the circumstances of the case, to an ordinary worker at least the Piece-Work Basis Time-Rate applicable, or where no Piece-Work Basis Time-Rate has been fixed, the General Minimum Time-Rate applicable, with the addition in either case of one-fifth of the General Minimum Time-Rate applicable as set out above.

SECTION IV.—The Overtime Rates are payable in respect of all time worked in excess of 5 hours on a Saturday and in respect of all time worked in excess of 9 hours on any other day (not being a Sunday or Customary Public or Statutory Holiday) nowithstanding that the total number of hours worked in the week does not exceed 47.

#### PART IV.

The respective Minimum Rates of Wages set out in Parts I., II., and III. of this Schedule apply, subject to the provisions of the Trade Boards Acts, to all female workers in Great Britain in respect of all time during which they are employed in any branch of the trade specified in the Trade Boards (Coffin

Furniture and Cerement-Making) Order. 1919, that is to say :---

- (a) The manufacture, wherever carried on, of Coffin Furniture from any metal by any process.
- (b) The manufacture of Cerements, including shrouds, face curtains, face cloths, sidecloths, winding sheets, pillow covers, coffin pads, sleeves or frilling.

(c) The operations of folding, packing, warehousing, despatching or other operations. incidental to or appertaining to the manufacture of any of the above-mentioned articles.

#### PART V.

SECTION I.—The above Minimum Rates of Wages must be paid clear of all deductions other than deductions under the National Insurance Act, 1911, as amended by any subsequent enactments, or deductions authorised by any Act to be made from wages in respect. of contributions to any Superannuation or other Provident Fund.

SECTION II.—The above Minimum Rates of Wages are without prejudice to workers who are earning higher rates of wages or to agreements made or that may be made between employers and workers for the payment of wages in excess of the Minimum Rates.

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1922, and of every other power enabling him in this behalf, hereby orders as follows:—

#### Further Extension of Controlled Area.

1. The Renfrewshire and District (Footand-Mouth Disease) Order of 1923 (No. 6) and any Order amending that Order shall be read and have effect as if the Area described in the Schedule hereto were included in and formed part of the Controlled Area described in the Schedule to the first mentioned Order.

#### Commencement.

2. This Order shall come into operation on the first day of January, nineteen hundred and twenty-four.

#### Short Title.

3. This Order may be cited as the REN-FREWSHRE AND DISTRICT (FOOT-AND-MOUTH DISEASE) ORDER OF 1923 (No. 11) and shall be read with the Orders referred to in Article 1.

## FIFE AND PERTHSHIRE DISTRICT (FOOT-AND-MOUTH DISEASE) ORDER OF 1923 (No. 6).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested

in him under the Diseases of Animals Acts, 1894 to 1922, and of every other power enabling him in this behalf, hereby orders as follows:—

. 1

## Meaning of Terms.

1. In this Order:—

The "Controlled Area" means the Area described in the Schedule hereto in which the movement of animals is hereby controlled. If any farm (excluding any detached part) is partly within and partly outside the Controlled Area the whole shall be deemed to be within that Area.

"Animals" means cattle, sheep, goats and pigs.

pigs. "Slaughterhouse" means premises used habitually and solely for the purpose of slaughtering animals, but does not include a slaughterhouse which forms part of a farm.

#### Restrictions in Force in the Controlled Area.

2.—(a) No animal shall be moved out of the Controlled Area, except as provided in Article 3 of this Order.

(b) No animal shall be moved without a licence under Article 3 of this Order

(i.) into the Controlled Area; or

(ii.) along or across any road or other highway or by water within the Controlled Area.
(c) No animals shall be permitted by the owner or person in charge thereof to stray upon any road or other highway in the Controlled Area.

(d) No market sale or exhibition of animals shall be held in the Controlled Area, except a market or sale of fat animals intended for immediate slaughter, or a sale of animals on farm premises. A licence must be obtained from the Local Authority to hold any such madket or sale, and a Veterinary Inspector of the Local Authority shall attend and examine the animals exposed thereat. No licence shall be granted for the holding of any such market or sale on any premises within a radius of five miles from any place infected with Footand-Mouth Disease.

(e) No slaughterhouse manure or refuse shall be moved out of the Controlled Area or be brought into contact with animals in such Area.

Movement of Animals by Licence into, within, or out of the Controlled Area.

3. Licences may be granted by an Inspector of a Local Authority for the following movement of animals only:—

(a) From premises outside the Controlled Area to a slaughterhouse in the Controlled Area;

(b) From premises outside the Controlled Area to a farm in the Controlled Area;

(c) From a farm in the Controlled Area to a licensed fat stock market or fat stock sale in such Area;

(d) From a licensed fat stock market or sale in the Controlled Area or from a farm or other premises in the Controlled Area, to a slaughterhouse in such Area;

(e) From one farm to another in the Controlled Area or between different parts of the same farm in such Area, if the Inspector considers the movement to be necessary or expedient. (These licences may be made available for movement as often as required if the Inspector endorses the licence "Occupation Licence.")

(f) From a licensed fat stock market or sale in the Controlled Area or from a farm in that area to any public slaughterhouse in the Controlled Area to which the Renfrewshire and District (Foot-and-Mouth Disease) Order of 1923 (No. 6) for the time using applies. In the case of such movement the licence shall be granted by an Inspector of the Local Authority of the district in which the slaughterhouse is situated, and shall not be available unless and until it is countersigned by an Inspector of the Local Authority of the district in which the movement commences.

Provided that no licence shall be granted under this Article for (i.) the movement of any animal on a road within a radius of two miles from any place infected with Foot-and-Mouth Disease, or (ii.) the movement of animals from any premises to any farm for the purpose of sale at a licensed farm sale.

#### Conditions of Licence.

4.—(a) Licences may be granted only by an Inspector of the Local Authority in whose district the movement commences, except where otherwise expressly stated and also except in the case of movement from premises outside the Controlled Area to a destination in such Area, in which case the licence shall be granted by an Inspector of the Local Authority of the district in which the place of destination is situate;

(b) Licences shall not permit movement on any road within a radius of two miles of a Foot-and-Mouth Infected Place, or movement out of the Controlled Area, in order to reach a destination in that Area;

(c) Occupation Licences may be withdrawn at any time by a notice served by an Inspector of the Local Authority on the person to whom such licence was granted;

(d) Licences, other than Occupation Licences, must be delivered up at or sent by post to the nearest Police Station, or to an Officer of the Local Authority, immediately after completion of the movement;

(e) Licences, other than Occupation Licences, shall only be available for four days, including the day of issue, and shall accompany the animals throughout the movement; (f) Animals, while being moved with a licence under this Order, shall be moved as far as practicable by the nearest available route, and without avoidable delay, to the place of destination specified in the licence, and not elsewhere, and shall be kept separate, as far as practicable, from all other animals;

(g) Copies of licences authorising movement into the district of another Local Authority shall be sent by the Inspector issuing such licences to such other Local Authority.

(h) Licences shall be produced by the person in charge of the animals moved therewith on demand to an Inspector or to a Constable, and such person shall, if required by such Officer, give his name and address.

## Movement through Controlled Area by Railway Permitted.

5. This Order shall not prevent the move- enforced by the Local Authority.

ment of animals direct by railway through the Controlled Area if the animals are not untrucked within the Area.

#### Animals for Slaughter to be Marked.

6.-(a) Animals moved to a slaughterhouse in accordance with a licence under this Order shall be detained at such slaughterhouse until they are slaughtered;

(b) Before movement commences all such animals shall be marked as follows:—

Cattle.—A broad arrow six inches long clipped on the left hind-quarter and the hair clipped off the end of the tail.

Sheep.—A broad arrow clipped on the forehead and a letter M six inches long painted or stamped with red or blue adhesive composition on both sides of each sheep.

*Pigs.*—Letter M painted or stamped on both sides of the pig with red or blue adhesive composition.

## Power to Reduce Time Limit for Slaughter of Animals.

7. Where any animals are moved with a licence under this Order to a slaughterhouse the Local Authority of the district in which the slaughterhouse is situated may, if they think fit, require the animals to be slaughtered within a less period than 96 hours from the time of their arrival at the slaughterhouse.

#### Closing of Footpaths and Premises.

8.—(1) An Inspector of the Ministry or of the Local Authority may (notwithstanding the existence of any footpath or right of way) prohibit the entry of any person into any field, shed or other place in the Controlled Area by giving notice in writing to that effect to the occupier. In such cases the owner of the animals in such places, or his agents, or servants, may enter for the sole purpose of feeding or tending the animals, but no other persons shall enter any such place until such notice has been withdrawn by a further notice from an Inspector, unless he has obtained **a** licence to do so from an Inspector of the Ministry or of the Local Authority.

(2) Copies of such notices shall be affixed or exhibited by the Inspector in such manner as he may think desirable for ensuring notification of the restrictions thereby imposed.

(3) Copies of such notices, when served, shall be sent to the Ministry.

## Control of Dogs and Poultry.

9.—(1) An Inspector of the Ministry or of the Local Authority may, by a written notice served upon the occupier of any premises in the Controlled Area on which dogs or poultry are kept, require such occupier to keep such dogs or poultry under such control as may be prescribed in the notice, or to confine them to any specified part of the premises.

to any specified part of the premises. (2) Copies of such notices, when served, shall be sent to the Ministry.

#### Local Authority to enforce Order.

10. This Order shall be executed and nforced by the Local Authority.

#### Offences.

11. Any contravention of this Order or of any notice served thereunder, shall be deemed to be an offence against the Diseases of Animals Act, 1894, and renders the offender liable to prosecution.

## Revocation of Previous Orders.

12. The Fife and Perthshire District (Footand-Mouth Disease) Order of 1923 (No. 3) and the Fife and Perthshire District (Foot-and-Mouth Disease) Orders of 1923 (Nos. 4 and 5) are hereby revoked.

Commencement.

13. This Order shall come into operation on the first day of January, nineteen hundred and twenty-four.

#### Short Title.

14. This Order may be cited as the FIFE AND PERTHSHIRE DISTRICT (FOOT-AND-MOUTH DISEASE) ORDER OF 1923 (No. 6).


