REGULATIONS FOR THE APPOINTMENT BY COMPETITIVE SELECTION OF LIVE STOCK OFFICERS UNDER THE MINISTRY OF AGRICULTURE AND FISHERIES.

*N.B.—These Regulations are liable to alteration from time to time.*

1. Application for appointment shall be made in the first instance to the Secretary, Ministry of Agriculture and Fisheries, at such time and in such manner as may be fixed by the Ministry. When a vacancy occurs the Ministry will cause notice to be given by advertisement in the Press, which will include a statement of the last day fixed for the receipt of applications.

2. A candidate must have attained the age of 25 and must not have attained the age of 45 on the last day fixed for the receipt of applications; provided that in reckoning age for this purpose a candidate who served in the Army, Navy or Air Force between the 4th August 1914 and the 11th November 1918, may deduct from his actual age any period of service between the 4th August 1914 and the 31st December 1919.

3. A candidate must be a natural-born British subject and the child of a father also a natural-born British subject; provided that exception may be made in the case of candidates serving in a civil situation to which they were admitted with the certificate of the Civil Service Commissioners, and provided that exception may be made as regards the father in the case of candidates who served in His Majesty's Armed Forces during the Great War between the 4th August 1914 and the 11th November 1918.

4. Until further notice preference will be given to candidates who served in His Majesty's Forces during the War between the 4th August 1914 and the 11th November 1918.

No person will be eligible who obtained from any tribunal established under the Military Service Acts, 1916–1918, exemption from service in His Majesty's Forces under those Acts on the ground of conscientious objection to the undertaking of military service, or, although not so exempted, declined to comply with obligations imposed upon him by those Acts.

5. Persons holding situations in the Civil Service must obtain the permission of the authorities of their Department to apply for appointment.

No person actually serving in the Army, Navy or Air Force will be eligible for consideration unless he produces, when called upon to do so, the permission of his Commanding Officer to apply for appointment, dated before his appearance before the Selection Board, and given in accordance with such orders as may from time to time be issued.

Persons upon whose training for the occupation of teacher public money has been spent cannot be appointed until the consent of the

appropriate Education Authority has been notified to the Civil Service Commissioners.

6. A candidate must satisfy the Ministry as to his practical knowledge and experience of farming and of stock-breeding, especially of the breeding and the management of pedigree stock (including dairy cattle). He should also have had experience of milk-recording.

7. The completed application forms will be scrutinised by the Ministry, and selected candidates will be interviewed by a Board consisting of representatives of the Ministry and of the Civil Service Commissioners, who will recommend those candidates whom they consider most suitable for appointment by the Ministry.

Any attempt on the part of candidates to enlist support for their applications through Members of Parliament or other influential persons will disqualify them for appointment. The Selection Board will disregard spontaneous recommendations from persons who are not personally acquainted with the candidate's previous work.

8. The necessary number of candidates will be appointed on probation, subject to their satisfying the Civil Service Commissioners that they are eligible for appointment in respect of age, nationality, health and character, and to the payment of a fee of £4.

9. Service as Live Stock Officer will be probationary for a period of two years, and the retention of an officer beyond that period will be conditional on his passing a prescribed examination after the expiry of that period.

10. A Live Stock Officer, after passing the examination, is eligible for consideration for appointment to the established staff. ORDER OF THE MINISTER OF  
AGRICULTURE AND FISHERIES.

(DATED 29TH DECEMBER 1924.)

BUTE (CONTROL OF DOGS) ORDER OF  
1924.

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1922, and of every other power enabling him in this behalf, hereby orders as follows:—

*Power to make Regulations.*

1.—(1) The Local Authority of the District specified in the Schedule to this Order may, in accordance with the provisions of this Order, make Regulations, with a view to the prevention of worrying of cattle (including sheep), for requiring that dogs or any class of dogs shall, during all or any of the hours between sunset and sunrise, be kept by the owners

thereof under control in manner prescribed by the Regulations.

(2) The Regulations may apply to the whole or any part of the District, and may exempt any class of dogs either generally or under prescribed conditions.

#### *Confirmation of Regulations.*

2.—(1) Regulations made under this Order shall not take effect unless and until they have been submitted to and confirmed by the Minister of Agriculture and Fisheries.

(2) A copy of any Regulations made by a Local Authority under this Order, signed and certified by the Clerk of that Local Authority to be a true copy and to have been duly confirmed shall be evidence, until the contrary is proved, in all legal proceedings, of the due making, confirmation and existence of the Regulations, without further or other proof.

#### *Seizure of Dogs where Regulations are Contravened.*

3. Any dog in respect of which an offence is being committed against a Regulation made under this Order may be seized and treated as a stray dog under the powers conferred by Section three of the Dogs Act, 1906.

#### *Extension of Definition in Diseases of Animals Act, 1894.*

4. Dogs shall be animals for the purposes of the following sections of the Diseases of Animals Act, 1894 (namely):—

Section forty-three (powers of police).

Section forty-four (powers of inspectors): and also for the purposes of all other sections of the said Act containing provisions relative to or consequent on the provisions of those sections and this Order, including such sections as relate to offences and legal proceedings.

#### *Local Authority to enforce Order.*

5. The provisions of this Order shall be executed and enforced by the Local Authority.

#### *Short Title.*

6. This Order may be cited as the BUTE (CONTROL OF DOGS) ORDER OF 1924.
