"Whereas it is provided by Section 3 of the Naval and Marine Pay and Pensions Act, 1865. that all pay, pensions, or other allowances in the nature thereof payable in respect of services in Your Majesty's Naval or Marine Force to a person being, or having been, an Officer, Seaman or Marine therein, or to the widow or any relative of a deceased Officer, Seaman or Marine, shall be paid in such a manner, and subject to such restrictions, conditions and provisions as are from time to time directed by Order in Council:

" And whereas Your Majesty was graciously pleased, by Your Order in Council dated the 7th day of November 1924, to empower us at our discretion to award pensions and gratuities to widows and allowances to children and certain other dependent relatives of Petty Officers, Non-Commissioned Officers and men of the Royal Navy and Marines and of the Reserve Forces on the scales and under the conditions contained in the Schedule annexed thereto:
