"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, inter alia, that all pay, pensions, or other allowances in the nature thereof, payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman, or Marine therein, shall be paid in such manner, and subject to such restrictions, conditions and provisions as are from time to time directed by Order in Council:

"And whereas by an Order in Council of His late Majesty bearing date the 22nd day of October 1906, sanction was given to the payment of Flag allowance to the Commander appointed as Executive Officer on board the Flag Officers:

Flag Officers:

"And whereas we consider that the allowance should not be withheld from a Lieutenant Commander appointed as Executive Officer to a Flag Ship in which an Executive Commander is not borne:

"We beg leave humbly to recommend that Your Majesty may be graciously pleased by Your Order in Council to sanction payment of Flag Allowance, at existing rates, with retrospective effect to the 1st April 1926, to either the Commander or the Lieutenant Commander appointed for Executive Duties to a ship bearing a Flag or Broad Pendant:

"The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in this proposal."

"And whereas Your Majesty was graciously pleased by Your Order in Council bearing date the 22nd January 1920, to approve the payment of Machinery Allowance to Engineer Officers in charge of the machinery of Your

Majesty's Ships in commission:

And whereas Your Majesty was graciously pleased by Your Order in Council bearing date the 5th April 1921 to sanction the payment, at our discretion, of Machinery Allowance to the Engineer Officers borne for charge of the machinery of the Central Reserve of Mine-sweepers, although these vessels are not in commission:

"And whereas there is now a Reserve of Minesweepers at Malta, constituted on similar lines to the Central Reserve of Minesweepers, in respect of which we consider that Machinery Allowance should also be paid to the Engineer Officers borne for charge of machinery:

"We beg leave humbly to recommend that Your Majesty may be graciously pleased by Your Order in Council, to authorize us, at our discretion, to issue as from the 1st April 1925 payment of Machinery Allowance to the Engineer Officers borne for charge of machinery of the Reserve of Minesweepers at Malta.
"The Lords Commissioners of

Your Majesty's Treasury have signified their concurrence in this proposal."

THEREAS by Section 80 of the Merchant Shipping Act, 1906, power is given to His Majesty by Order in Council to make Regulations with respect to the manner in which Government ships may be registered as British ships for the purpose of the Merchant Shipping Acts:

And whereas by the said Section it is provided that those Acts shall, subject to any exceptions and modifications which may be made by Order in Council, either generally or as respects any special class of Government ships, apply to Government ships registered in accordance with such Regulations as if they were registered in manner provided by those

And whereas the provisions of Section 1 of the Rules Publication Act. 1893, have been complied with:

Now, therefore, His Majesty, by virtue of on behalf of the Colonial Government.

the powers in this behalf by the said Act, or otherwise in Him vested, is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, that the following Regulations shall have effect as regards any Government ships in the service of the Government of the Colony of the Straits Settlements (hereinafter referred to as the Colonial Government):-

1. An application for registry of a Government ship in the service of the Colonial Government shall be made in writing under the hand of the Colonial Secretary of the Straits Settlements or other officer of the Colonial Government nominated by the Governor, or by one of the Crown Agents for the Colonies. Such application shall contain the following particulars:

(i) A statement of the name and descrip-

tion of the ship.

(ii) A statement of the time when and place where the ship was built, or, if the ship was foreign built, and the time and place of building are unknown, a statement to that effect and of her foreign name.

- (iii) A statement of the nature of the title to the said ship, whether by original construction by or for the Colonial Government, or by purchase, capture, condemnation, or otherwise, and a list of the documents of title, if any, in case she was not originally constructed by or for the Colonial Govern-
- (iv) A statement of the name of the Master.
- 2. The Registrar, on receiving such application in respect of a Government ship in the service of the Colonial Government, shall—
 - (i) enter the ship in the Register Book as belonging to "His Majesty, represented by the Government of the Colony of the Straits Settlements " and shall also enter therein:

(ii) the name of the port to which she belongs:

(iii) the particulars stated in the application for registration:

(iv) the details comprised in the Surveyor's Certificate.

3. On the registry of a Government ship in the service of the Colonial Government the Registrar shall retain in his possession the Surveyor's Certificate and the application for registry and any documents of title mentioned in such application.

4. Upon the transfer of a registered Government ship in the service of the Colonial Government by Bill of Sale, the Colonial Government shall be the transferors, and the Bill of Sale shall be in Form A in the proper form pre-scribed under the Merchant Shipping Act, 1894, hereinafter called the principal Act, omitting the covenant therein contained. such Bill of Sale shall be signed by the Colonial Secretary or other officer or Crown Agent as aforesaid on behalf of the Colonial Govern-

5. The application for a Certificate of Sale referred to in Sections 39 to 42 and Sections 44 to 46 of the principal Act, may be made in respect of a Government ship in the service of the Colonial Government by the Colonial Secretary or other officer or Crown Agent as aforesaid

6. The person to whom the management of any Government ship in the service of the Colonial Government is entrusted by the Colonial Gevernment shall be registered as provided by Section 59 (2) of the principal Act.

7. Where any provision of the Merchant Shipping Acts which by virtue of the Merchant Shipping Act, 1906, and this Order in Council is applicable to Government ships in the service of the Colonial Government imposes any duty or liability or confers any right or power upon or contemplates any act being performed by the owner of a ship such duty, liability, right, or power shall, subject always to the other provisions of this Order in Council be carried out, borne, or exercised by the Colonial Government on behalf of His Majesty.

8. In this Order in Council the term Merchant Shipping Acts shall mean and include any of the Merchant Shipping Acts, any pro-vision of which is by virtue of the Merchant Shipping Act, 1906, and this Order, applicable

to Government ships.

9. The following sections and provisions of the Merchant Shipping Acts shall not apply to Government ships in the service of the Colonial Government registered in pursuance of this Order, namely:-

(i) The Merchant Shipping Act, 1894-

Sections 1, 8 to 12, 427 to 431.

The provisions of Part II. of the Act relating to the requirement of officers to hold certificates of competency and the production of these certificates.

(ii) The Merchant Shipping (Mercantile Marine Fund) Act, 1898—Sections 3 and 5.

(iii) The Merchant Shipping Act, 1906-

Sections 25 and 27.

Provided always that no provision of the Merchant Shipping Acts which, according to a reasonable construction, would not apply in the case of Government ships in the service of the Colonial Government, shall be deemed to apply to such ships by reason only that its application is not hereby expressly excluded.

10. Anything required or authorised by this Order in Council to be done by the Colonial Government may be done by the Colonial Secretary or other officer or Crown Agent as aforesaid.

TENDERS FOR TREASURY BILLS.

- Lords Commissioners 1. The Majesty's Treasury hereby give notice, that Tenders will be received at the Chief Cashier's Office, at the Bank of England, on Friday the 20th August 1926, at 1 o'clock, for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the War Loan Acts, 1914-1919, to the amount of £40,000,000.
- 2. The Bills will be in amounts of £5000 or £10,000. They will be dated at the option of the Tenderer on any business day from Monday the 23rd August 1926 to Saturday the 28th August 1926, inclusive, and will be payable at three months after date.
- 3. The Bills will be issued and paid at the Bank of England.

- 4. Each Tender must be for an amount not less than £50,000, and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.
- 5. Tenders must be made through a London Banker, Discount House or Broker.
- 6. The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than 2 o'clock (Saturday, 12 o'clock) on the day on which the relative Bills are to be dated.
- 7. In virtue of the provisions of Section 1 (4) of the War Loan Act, 1919, Members of the House of Commons are not precluded from tendering for these Bills.
- 8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.
- 9. The Lords Commissioners of Majesty's Treasury reserve the right of rejecting any Tenders.

TRADE BOARDS ACTS, 1909 AND 1918.

VARYING AND FIXING OF MINIMUM RATES OF WAGES IN THE CHAIN MAKING TRADE.

The Chain Trade Board (Great Britain) have issued a Notice dated 12th August 1926, setting out all the Minimum Rates of Wages in operation under the Trade Boards Acts for workers engaged in the making of Dollied or Tommied Chain from iron of sizes No. 6 I.S.W.G. up to and including $\frac{31}{32}$ inch, and in making Hand Hammered Chain from iron of sizes $\frac{3}{3}$ inch up to and including $\frac{17}{32}$ inch (including General Minimum Piece Rates for making Dollied or Tommied Long Link Chain and certain classes of Long Link Dollied or Tommied or Hand Hammered Chain for use in Meat Chains or as the End Portions of Backbands, which have been varied or fixed to take effect under an Order of the Minister of Labour as from 16th August 1926).
