#### TRADE BOARDS ACTS, 1909 AND 1918.

VARYING AND FIXING OF MINIMUM RATES OF WAGES IN THE PERAMBULATOR AND INVALID CARRIAGE TRADE.

The Perambulator and Invalid Carriage Trade Board (Great Britain) have issued a Notice dated 20th August 1926, setting out all the Minimum Rates of Wages in operation under the Trade Boards Acts for workers engaged in the trade (including the minimum rates fixed for workers brought within the scope of the trade for the first time by the Trade Boards (Perambulator and Invalid Carriage) Order, 1926, and also certain variations in the minimum rates previously in operation, which have been con-firmed by Order of the Minister of Labour to take effect as from 23rd August 1926).

#### Admiralty, 13th August 1926.

The Secretary of the Admiralty announces that it has been decided, with the KING'S approval, that Orders, decorations and medals shall be worn with frock coat and epaulettes dress and with white dress.

With these dresses, Knights Grand Cross and Knights Grand Commanders of Orders will wear the broad ribbon and badge over the shoulder, star or stars on the left side of the coat, and decorations and medals on the breast. Knights Commanders and Commanders and Companions of the Orders of the Bath, St. Michael and St. George, the Star of India and the Indian Empire will in general wear one badge only, namely, the badge of the senior Order round the neck (a bow tie being worn), but if the occasion requires a junior or foreign badge also to be worn it is to be worn emerging from between the buttons of the coat as in full dress decorations and medals will be worn on hundred and twenty-six.

the breast; and Knights Commanders will wear the star or stars on the left side of the coat. Companions of other Orders and members of Orders will wear badges, decorations and medals on the breast.

With frock coat and epaulettes dress the bar from which badges, decorations and medals are suspended is to extend from the shoulder inwards and over the lapel of the coat if necessary. To enable medals to be worn with a frock coat on which ribbons are already sewn, small twist loops or beckets are to be fitted to accommodate the pin of the medal brooch. These beckets are to be placed immediately above or immediately below the top row of medal ribbons, according to the position of the pin of the brooch and are to be so arranged that the ribbons on the frock coat shall be completely covered. Where more than four rows of medal ribbons are sewn on the frock coat it may be necessary, in order to cover them completely, for the medals to be mounted in Court style as described in Clause 12 of Article 167 of the King's Regulations and Admiralty Instructions, and slightly to lengthen the ribbons.

## IMPORTATION OF DOGS (AMENDMENT) ORDER OF 1926.

#### Amendment of Paragraph 2 of Article 1 of Importation of Dogs Order of 1914.

1. Paragraph 2 of Article 1 of the Importation of Dogs Order of 1914 as amended by the Importation of Dogs (Amendment) Order of 1923, is hereby revoked and the following paragraph is substituted therefor:

"(2) The provisions of this Order shall also apply to a dog taken from Great Britain, Ireland, the Channel Islands or the Isle of Man, into any port in any other country, (except Great Britain, Ireland, the Channel Islands, and the Isle of Man), as if the animal were an imported dog, and also to any dog which has, at any time before or after arrival at a port in Great Britain, been in contact with any imported dog as defined in this Order."

#### Revocation.

2. The Importation of Dogs (Amendment) Order of 1923 is hereby revoked.

#### Commencement.

3. This Order shall come into operation on the fifteenth day of September nineteen
