TENDERS FOR TREASURY BILLS.

1. The Lords Commissioners of His Majesty's Treasury hereby give notice, that Tenders will be received at the Chief Cashier's Office, at the Bank of England, on Friday the 10th September 1926, at 1 o'clock, for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the War Loan Acts, 1914-1919, to the amount of £40,000,000.

2. The Bills will be in amounts of £5000 or £10,000. They will be dated at the option of the Tenderer on any business day from Monday the 13th September 1926 to Saturday the 18th September 1926 inclusive, and will be payable at three months after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000, and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than 2 o'clock (Saturday,

12 o'clock) on the day on which the relative Bills are to be dated.

7. In virtue of the provisions of Section 1 (4) of the War Loan Act, 1919, Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

9. The Lords Commissioners of His Majesty's Treasury reserve the right of rejecting any Tenders.

THE ROADS ACT, 1920.

COUNTY OF WEST LOTHIAN.

Whereas by sub-section (4) of Section 7 of the Roads Act, 1920, it is enacted that the Minister of Transport may by Order on the application of any County Council (as defined in Sections 17 and 18 (b) of the Act), after holding a public inquiry, prohibit or restrict, subject to such exceptions or conditions as to occasional user or otherwise as may be specified in the Order, the driving of mechanically-propelled vehicles of any specified class on any specified highway within the area of the Council in any case in which it appears to him as the result of the inquiry to be proved that a vehicle of that class cannot be used on that highway without endangering the safety of the vehicle or the persons therein or of other traffic using the highway, or that the highway is unsuitable for use by a vehicle of that class;

And whereas the County Council of West Lothian have made application to the Minister of Transport for an Order to be made in pursuance of the said sub-section prohibiting or restricting subject to such exceptions or conditions as to occasional user or otherwise as may be specified in the Order the driving of Heavy Motor Cars and Locomotives on the highways specified in the Schedule hereto; provided that nothing in the Order shall prevent the driving upon the said roads of:—

(i) Any vehicle which is being used for the purposes of agriculture in connection with land adjoining or lying near to the said roads, or for the conveyance or haulage of timber felled upon such land; or

(ii) Any vehicle which is being used for the conveyance of goods or merchandise to or from any house, buildings or other premises situate on or adjacent to the said roads;

FOOT-AND-MOUTH DISEASE DECLARATION OF INFECTED AREAS ORDER OF 1926 (No. 96).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1925, and of every other power enabling him in this behalf, hereby orders as follows:—

Declaration of Further Foot-and-Mouth Disease Infected Area.

1. The Area described in the Schedule to this Order is hereby declared to be a Foot-and-Mouth Disease Infected Area for the purposes of the Foot-and-Mouth Disease (Infected Areas Restrictions) Order of 1925. The Foot-and-Mouth Disease Declaration of Infected Areas Order of 1926 (No. 74) shall be read and have

effect as if the Area described in the Schedule hereto were included as Area No. 12 in the First Schedule to that Order.

Short Title.

2. This Order may be cited as the FOOT-AND-MOUTH DISEASE DECLARATION OF INFECTED AREAS ORDER OF 1926 (No. 96), and shall be read with the Orders referred to in Article 1.
