A PROCLAMATION.

GEORGE R.I.

WHEREAS by the Emergency Powers Act, 1920, it is enacted that if it appears to Us that any action has been taken or is immediately threatened by any persons or body of persons of such a nature and on so extensive a scale as to be calculated, by interfering with the supply and distribution of food, water, fuel, or light, or with the means of locomotion, to deprive the community, or any substantial portion of the community, of the essentials of life, We may, by proclamation, declare that a state of emergency exists:

And whereas on the twenty-second day of September last, We did, by and with the advice of Our Privy Council, declare by proclamation, in pursuance of the said Act, that a state of emergency existed:

And whereas it is enacted by the said Act that no such proclamation shall be in force for more than one month, without prejudice to the issue of another proclamation at or before the end of that period:

And whereas the continued cessation of work in Coal Mines does, in Our opinion, constitute a state of emergency within the meaning of the said Act:

Now, therefore, in pursuance of the said Act, We do, by and with the advice of Our

Privy Council, hereby declare that a state of emergency exists.

A Proclamation for the Summoning of Parliament.

GEORGE R.I.

WHEREAS on the 30th day of April 1926, We were pleased, by virtue of the powers conferred upon Us by the Emergency Powers Act, 1920, to issue a Proclamation of Emergency:

And whereas on the 29th day of May 1926, the 28th day of June 1926, the 26th day of July 1926, the 25th day of August 1926, and the 22nd day of September 1926, We were pleased, by virtue of the said powers, to make further Proclamations of Emergency:

And whereas the Proclamation of Emergency made on the said 22nd day of September

1926 will expire after one month from the CENTRAL CHANCERY OF THE ORDERS date thereof:

And whereas We have this day been pleased to make a new Proclamation of Emergency under the said Act:

And whereas it is provided by the said Act that where a Proclamation of Emergency has been made the occasion thereof shall forthwith be communicated to Parliament, and, if Parliament is then separated by such adjournment or prorogation as will not expire within five days, a Proclamation shall be issued for the meeting of Parliament within five days, and Parliament shall accordingly meet and sit upon the day appointed by that Proclamation, and shall continue to sit and act in like manner as if it had stood adjourned or prorogued to the same day:

And whereas the House of Lords stands adjourned to Thursday, the 21st day of October instant, but in the ordinary course will not sit except for Judicial business until Tuesday the 9th day of November next:

And whereas the House of Commons stands adjourned to the said Tuesday the 9th day of November next:

Now, therefore, We, in pursuance of the said Act and all other powers enabling Us in that behalf, by and with the advice of Our Privy Council, hereby proclaim and give notice of Our Royal intention and pleasure that Our Parliament, notwithstanding that it now stands adjourned as aforesaid, shall assemble and be holden on Monday the 25th day of October instant; and the Lords Spiritual and Temporal, and the Knights, Citizens, and Burgesses, and the Commissioners for Shires and Burghs of the House of Commons, are hereby required and commanded to give their attendance accordingly, at Westminster, on the said Monday the 25th day of October.

VARYING OF MINIMUM RATES IN THE STAMPED OR PRESSED METAL WARES TRADE.
