# THE ROADS ACT, 1920. COUNTY OF DUNBARTON.

Notice is hereby given that on the 12th day of November 1926 the Minister of Transport made an Order under Section 7 (4) of the Roads Act, 1920, in respect of certain highways or portions of highways in the County of Dunbarton.

The Order will come into force on the 5th day of December 1926, and is to the following effect:—

During the period of five years from the date on which the Order comes into force, no person shall drive or cause to be driven on the highways or portions of highways specified in the Schedule hereto any locomotive, any heavy motor car (as defined by Article II. of the Heavy Motor Car (Scotland) Order, 1905), or any motor car with seats for more than fourteen persons exclusive of the driver.

Nothing in the Order contained shall prevent the driving on the said highways or portions of highways specified in the Schedule hereto (hereinafter referred to as "the said roads") of

(i.) Any vehicle which is being used for the purposes of agriculture in connection with land adjoining or lying near to the said roads or for the conveyance or haulage of timber felled upon such land;

(ii.) Any vehicle which is being used for the conveyance of goods or merchandise to or from any house, building or other premises situate on or adjacent to the said roads; or

(iii.) Any vehicle which is being used in connection with the maintenance, improvement or reconstruction of the said roads or the laying, alteration or repair in or near to the said roads or any sewer

or of any main, pipe or apparatus for the supply of gas, water or electricity.

To authorise the Town Council to purchase by agreement lands, houses, and other property, and to use lands, houses, and other property belonging to them which will or may be required for the purposes of the intended works or of the Order, or for the general purposes of the Harbour Undertaking or rights of easement or servitude or other rights in or over such lands and other property.

To empower the Town Council to sell, let, lease, exchange, or otherwise dispose of lands, houses, and other property or rights therein, and to exempt the Town Council from the provisions of the Lands Clauses Acts in reference to superfluous lands.

To define, alter, extend, or fix the limits of the Harbour.

To empower the Town Council in constructing the intended works or any of them to deviate laterally within the limits of deviation shown on the plans to be deposited as hereinafter mentioned and vertically from the levels shown on the sections to be deposited as hereinafter mentioned to such extent as may be de-

fined on the said plans and sections or as may be prescribed by the Order.

To cross, stop up, alter, appropriate, interfere with, or divert temporarily, or permanently, and make junctions and communications with all roads, streets, quays, footways, streams, water-courses, sewer drains, telegraphic and telephonic or electric apparatus, and lines gas and water and other pipes, and works of every description, which it may be necessary or expedient to cross, stop up, alter, appropriate, interfere with or divert, join, or communicate with, for the purposes of the intended works.

To authorise the Town Council to purchase, lease, hire, use, and let for hire or sell dredgers, eroders, engines, lighters, and other vessels, machinery, and apparatus.

To authorise the Town Council to levy, collect, and recover tolls, rates, dues, duties, and charges for or in respect of the Harbour and the intended works or any of them, and of any bins, hoists, tips, storage, sidings, slipways, shoots, hoppers, and other works, conveniences, and appliances provided at or in connection with the intended works, or any of them, or any other part of the Harbour which have been or may be provided by the Town Council.

To repeal, alter, or vary the tolls, rates, dues, duties, and charges, or some of them, which are or may be leviable by the Town Council in respect of the Harbour Undertaking or any part thereof.

To empower the Town Council to levy new or additional tolls, rates, dues, duties, and charges in respect of the Harbour Undertaking, and to confer, vary, or extinguish exemptions from payment of existing or new tolls, rates, dues, duties, and charges.

To provide, if deemed expedient, that the intended works shall for all or any purposes be and be deemed to be part of the Harbour Undertaking, and to extend and make applicable to the Order and the intended works with or without modification all or any of the provisions of the Acts and Orders relating to and the bye-laws

and regulations of the Town Council or the Harbour Undertaking.

To authorise the Town Council to borrow money for the purposes of the intended works. or any of them, and of the Order on the security of the rates, tolls, dues, and assessments now leviable by them or which they may be authorised to levy under the Order or otherwise, including the Special Harbour Rate hereinafter mentioned, and on the security of the Harbour Undertaking and the lands and property connected therewith, and the tolls, rates, dues, and duties arising therefrom, or upon the whole or any of the said securities or otherwise as the Order may prescribe, and to make all provisions necessary or expedient with reference to the repayment of monies borrowed or to be borrowed by the Town Council.

To empower the Town Council, acting under the Burgh Police (Scotland) Act, 1892, or otherwise, to charge any fund or rate leviable by them or under their control for the purpose of raising a loan from the Public Works Loan Commissioners or other Government Department or any other body, company, or person for the execution of improvements or additions to or alterations of the Harbour including inter alia the construction of the intended works, and to guarantee the principal and interest of any such loan, or in such other manner as may be provided in the Order. The Order will contain all the necessary provisions for granting or entering into the said guarantee, and the repayment of any money paid thereunder.

To provide that the Harbour and the works connected therewith shall be deemed to be for all purposes within the Burgh.
