7. In virtue of the provisions of Section 1 (4) of the War Loan Act, 1919, Members of the House of Commons are not precluded from

tendering for these Bills.

AYRSHIRE ELECTRICITY (EXTENSION).

NOTICE is hereby given that application has been made by the Ayrshire Electricity Board (hereinafter called "the Board"), whose address is Electricity Works, Greenholm Street, Kilmarnock, to the Electricity Commissioners for a Special Order under the Electricity (Supply) Acts, 1882 to 1922, for all or some of the following purposes, that is to say):—

In the Burgh of Largs—Aubery Crescent, Aubery Lane, Buchanan Street, Burnlea Road, Burnside Road, Douglas Place, John Clark Street, Kelvin Street, Seamore Street, Warriston Road, Warrenpark Road, from May Street to Warriston Road.

(b) Roadways on and approaches to the following bridges:—

In the Burgh of Maybole—Bridges carrying Alloway Road, Culzean Road, and Kirkoswald Road over the London, Midland and Scottish Railway (Ayr and Stranraer Branch).

In the Burgh of Largs—Bridges carrying Charles Street, John Street, May Street, and Warriston Road over the London, Midland and Scottish Railway (Ardrossan and Largs Branch).

(c) Roadways under the following bridges:-

In the Burgh of Girvan—Bridge carrying the London, Midland and Scottish Railway (Ayr and Stranraer Branch) over Vicarton Street. Bridge carrying the London, Midland and Scottish Railway (Harbour Siding) over the unnamed road leading to the Golf Course.

4. The streets and parts of streets in which it is proposed that electric lines shall be laid down or placed or erected within a period to be specified by the Order are as follows:—

In the Burgh of Girvan—Hamilton Street, Dalrymple Street, Henrietta Street, from Knockcushan Street to Duff Street, Church Square, Montgomerie Street, from Church Square to Parish Church.

In the Burgh of Maybole—Cargill Road, Carrick Street, High Street, Kirkoswald

Road, Whitehall.

In the Burgh of Largs—Broomfield Place, John Street, Main Street, Gallowgate Street, from Main Street to Nelson Street, Irvine Road, from Main Street to John Street.
