WHEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 16th day of December 1926, C.W. 7820/26, in the words following, viz.:—

"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, inter alia, that all pay, pensions or other allowances in the nature thereof payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman or Marine therein, shall be paid in such manner and subject to such restrictions, conditions, and provisions as are from time to time directed by Order in Council:

- "And whereas Your Majesty was graciously pleased, by Your Order in Council bearing date the 22nd day of January 1920 (Schedule V., Section III., Clause II.), to approve standard rates of pay for First, Second and Third Quartermasters in Your Majesty's Marine Force:
- "And whereas recent reductions in the establishment of Quartermasters, Royal Marines, necessitate certain changes in the titles, the scale of pay, and the existing system of promotion in vacancies of these Officers:
- "We beg leave humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council, to sanction the Regulations set forth in the annexed Schedule with effect from the 17th day of July 1926.
- "The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in these proposals.

"SCHEDULE.

"1. The present title of Third Quartermaster to be abolished and Quartermasters on promotion to be designated Second Quarter-

master and to hold the rank of Lieutenant. The existing appointment of Second Quarter-master at the Portsmouth Division to be designated Second Quartermaster (Ordnance).

- "2. On attaining eight years' seniority as such Second Quartermasters to be promoted to the rank of Captain.
- "3. The scale of full pay of Second Quartermasters to be as follows:-

The standard and current rates of pay shown in the two preceding paragraphs to be comparable with the standard and current rates authorized by Orders in Council of the 22nd January 1920 and the 16th December 1925 respectively, and the current rates to be subject to further review on or after the 1st day of July 1927, in like manner to the current rates specified in the latter Order in Council.
- "6. These arrangements to have effect from the 17th day of July 1926.
- "7. Nothing in these regulations shall be held to affect other Officers hitherto paid on the Quartermaster's scale, namely:-

Directors of Music of the Royal Musical Director Naval School Assistant Musical Director of Music Company Officers

or the Quartermaster of the R.N. School of Music."

His Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of His Privy Council, to approve of what is therein proposed.

JHEREAS by Part II. of the Administration of Justice Act, 1920, provision has been made for the reciprocal enforcement of judgments in the United Kingdom and in other parts of His Majesty's Dominions:

And whereas by the said Act it is, amongst other things, provided that where His Majesty is satisfied that reciprocal provisions have been made by the Legislature of any part of His Majesty's Dominions outside the Kingdom for the enforcement within that part of His Dominions of judgments obtained in the High Court in England, the Court of Session in Scotland, and the High Court in Ireland, His Majesty may by Order in Council declare that the said part of that Act shall extend to that part of His Dominions and that on any such Order being made the said part of that Act shall extend accordingly:

And whereas on the 6th day of December 1922, the Irish Free State was established under the provisions of an Act of Parliament shortly entitled the Irish Free State Constitu-

tion Act, 1922 (Session 2):

And whereas His Majesty is satisfied that. the Legislature of the part of His Majesty's Dominions outside the United Kingdom hereinafter mentioned has made reciprocal provisions for the enforcement within that part of judgments obtained in the High Court in England, the Court of Session in Scotland, and

the High Court in Ireland:
Now, therefore, His Majesty, by virtue and in exercise of the powers by the above-recited Act in His Majesty vested, is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, as follows:-

1. Part II. of the Administration of Justice

Act, 1920, shall extend to Saint Helena.
2. Nothing in this Order shall affect the registration or enforcement in the Irish Free State of any judgment in pursuance of Part II. of the said Act.

And the Right Honourable Leopold Charles Maurice Stennett Amery, one of his Majesty's Principal Secretaries of State, is to give the necessary directions herein accordingly.

THEREAS by Section 4 of the Merchant Shipping Act, 1906, it is provided that Sections 427 to 431 of the Merchant Shipping Act, 1894 (hereinafter called the Principal Act), relating to life-saving appliances shall, after the appointed day, apply to all foreign ships while they are within any port of the United Kingdom as they apply to British ships:

Provided that His Majesty may by Order in Council direct that those provisions shall not apply to any ship of a foreign country in which | the provisions in force relating to life-saving appliances appear to His Majesty to be as effective as the provisions of Part V. of the Principal Act, on proof that those provisions are complied with in the case of that ship:

And whereas by Section 5 of the said Act it is provided that the said appointed day shall be the First day of January nineteen hundred and nine, or such other day not being more than twelve months later, as the Board of

Trade may appoint:

And whereas the Board of Trade have appointed the First day of October nineteen hundred and nine to be the day after which the provisions of the Principal Act relating to lifesaving appliances shall apply to all foreign ships while they are within any port of the United Kingdom as they apply to British ships:

And whereas it appears to His Majesty that the provisions in force in Portugal relating to life-saving appliances are as effective as the

provisions of Part V. of the Principal Act:
Now, therefore, His Majesty, by and with
the advice of His Privy Council, is pleased to direct that the provisions of Sections 427 to 431 of the Principal Act shall not apply to any Portuguese ship while within any port of the United Kingdom, if it is proved that the aforesaid Portuguese provisions relating to lifesaving appliances are complied with in the case of that ship.

WHEREAS by Sub-section (1) of Section 84 of the Merchant Shipping Act, 1894, it is provided that whenever it appears to His Majesty the King in Council that the tonnage regulations of the said Act have been adopted by any foreign country and are in force there, His Majesty in Council may order that the ships of that country shall, without being remeasured in His Majesty's Dominions be deemed to be of the tonnage denoted in their certificates of registry or other national papers, in the same manner, to the same extent, and for the same purposes as the tonnage denoted in the certificate of registry of a British ship is deemed to be the tonnage of that ship:

And whereas it appears to His Majesty that the tonnage regulations of the said Act have been adopted by the Government of Greece and are now in force in that country:

'Now, therefore, His Majesty is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, as follows:-

1. This Order may be cited as "The Greek Tonnage Order, 1927."

2. Greek ships the certificates of registry or other national papers of which are dated on or after the 14th July 1909 (old style 1st July 1909) shall without being re-measured in His Majesty's Dominions be deemed to be of the tonnage denoted in such certificates of registry or other national papers in the same manner, to the same extent, and for the same purposes as the tonnage denoted in the certificate of registry of a British ship is deemd to be the tonnage of that ship.

3. The Order in Council, dated the 14th day of August 1879, made under the provisions of the Merchant Shipping Act Amendment Act, 1862, with regard to the tonnage of ships of Greece is hereby revoked.

And whereas Notice of the said Representation, and of the time when it pleased His Majesty to order the same to be taken into consideration by the Privy Council has been duly published in the Edinburgh Gazette, and fixed in the manner required by the said Order in Council:

The following is an account of the services in respect of which the Decoration has been conferred:—

On the 3rd January 1927, at Port Hacking near Sydney, New South Wales, a youth named Mervyn Allum was swimming a short distance from the shore when he was attacked by a large shark. It was at first thought that he was drowning, and Stanley Gibbs, who was standing on the nose of a launch he was driving, ready to give assistance to Allum, observed that he was being attacked by the shark. Gibbs dived from the launch and fought the shark with his hands and feet and eventually succeeded in getting Allum, who was very badly injured, from the jaws of the shark, and with the assistance of a man named Macdonald placed him in a rowing boat. The victim died of injuries shortly afterwards.
