THE REGISTER OF BOOKING (PAISLEY) DISCONTINUANCE ORDER, 1927, DATED 3RD MAY 1927, MADE BY THE SECRETARY OF STATE UNDER THE BURGH REGISTERS (SCOTLAND) ACT, 1926 (16 AND 17 GEO. V., c. 50).

Whereas the Town Council of the Burgh of Paisley, with the consent of the Keeper of the Register of Booking for the said Burgh, at a meeting held on the 15th day of March 1927, passed a Resolution under subsection two of section one, as read with section five, of the Burgh Registers (Scotland) Act, 1926, that the said Register shall be discontinued:

Now therefore, I, the Right Honourable Sir John Gilmour, Baronet, one of His Majesty's Principal Secretaries of State, in pursuance of subsection one of section one of the said Act, do hereby order as follows:—

The following are the Regulations to be observed:—

1. Peers, Bishops, His Majesty's Lieutenants of Counties, Deputy Lieutenants of Counties, Members of Parliament, Officials connected with the Houses of Parliament, Clergy of all Denominations, and all gentlemen other than those mentioned in the following Regulations, should communicate with the Comptroller, Lord Chamberlain's Office, St. James's Palace. No applications can be received from gentlemen in the foregoing categories wishing to be presented. Their names must be forwarded by the gentleman making the presentation.

2. All gentlemen referred to in the following Regulations, wishing to attend or be presented at a Levée, should make a written application as directed below.

3. All Officers, whether on the active or retired lists of the Royal Navy and the Royal Marines, will communicate with and obtain their cards, whether for attendance or presentation, from the Private Secretary to the First Lord of the Admiralty.

4. All Officers on the active, retired, and reserve lists of the Regular Army, the Militia, and the Territorial Army, except Officers of the Household Cavalry and the Brigade of Guards, and those on the Indian and Colonial Establishments, will communicate with and obtain their cards, whether for attendance or presentation, from the Under-Secretary of State, War Office.

Officers of the Household Cavalry and the Brigade of Guards will communicate, through their Regimental Headquarters, with the Comptroller, Lord Chamberlain's Office, St. James's Palace, to obtain their cards for attendance or presentation.

5. All Officers on the active list of the Royal Air Force and Officers of the Special Reserve and Auxiliary Air Force will obtain their cards, for attendance or presentation, through the usual channels. Officers of the Reserve of Air Force Officers and Officers on the retired list of the Royal Air Force will communicate with and obtain their cards, whether for attendance or presentation, from the Secretary, Air Ministry, Kingsway, W.C.2.

6. All Officers of the Indian Services and of the Indian Army, whether on the active or retired lists, will communicate with and obtain their cards, for attendance or for presentation, from the Political A.D.C. to the Secretary of State at the India Office, Whitehall.

7. All Officers of the Colonial Service and Colonial Forces, whether on the active or retired lists, will communicate with and obtain their cards, whether for attendance or presentation, from the Colonial Office, Whitehall, with the exception of Officers of the local Forces of the self-governing Dominions, who will apply to the Under-Secretary of State, the War Office, for their cards for attendance

or for presentation, supporting their application in all cases by a credential from the Governor-General, Governor, Officer commanding the local Forces, or the representative in London of the Dominion concerned.

8. Lord Mayors and Mayors, High Sheriffs, Sheriffs, Recorders, Chairmen of Quarter Sessions, Metropolitan Police Magistrates and other Stipendiary Magistrates, and all gentlemen connected with the Home Office, will make their applications, whether for attendance or for presentation, through the Private Secretary to the Secretary of State for the Home Department.

9. Chairmen of County Councils, and all gentlemen connected with the Ministry of Health, will similarly make their applications through the Private Secretary to the Minister of Health.

10. Judges, Law Officers, King's Counsel, and all Legal Officials holding appointments under the Crown, other than those already mentioned, will similarly make their applications through the Private Secretary to the Lord Chancellor.

11. All gentlemen connected with the Foreign Office or any other Government Department will adopt the same procedure, and will communicate with and obtain their cards for attendance or presentation from the Department under which they serve.

12. The names both for attendance and presentation must be received at the various Offices above indicated not later than ten days prior to the date of the Levée.

The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than 2 o'clock (Saturday, 12 o'clock) on the day on which the relative Bills are to be dated.

7. In virtue of the provisions of Section 1 (4) of the War Loan Act, 1919, Members of the House of Commons are not precluded from tendering for these Bills.
