WHEREAS by the Cyprus (Annexation) Orders in Council 1914 and 1917, provision was made for the acquisition of British nationality by certain Ottoman subjects:

And whereas it is desirable to make further provision for the acquisition of British nationality by former Ottoman Nationals resident in Egypt who opt for British nationality under the Egyptian Nationality Law of the 26th of May 1926:

Now, therefore, His Majesty is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, as follows:—

- 1. The Cyprus (Annexation) Amendment Order in Council, 1917, is hereby amended in the following respects:—
 - (I.) By the addition at the end of Article 1 thereof of the following Sub-Article:—
 - "(iii.) Any former Ottoman national who shall have opted for British nationality under Article 4 of the Egyptian Law of Nationality (Décret-Loi sur la Nation-

alité Egyptienne) of the 26th of May 1926 and who

- (a) shall satisfy the Governor that he has validly exercised such option, and
 (b) shall return to Curring within six
- (b) shall return to Cyprus within six months from the 31st of May 1927, and
- (c) shall apply after his return to Cyprus to the Governor before the expiration of nine months from the said 31st of May 1927, for a Certificate of British Nationality under this Order, and
- (d) shall make a declaration in such form as the Governor may direct that he intends forthwith to become ordinarily resident in Cyprus, and

(e) shall have taken the Oath of Allegiance as hereinafter directed."

Provided that any such person shall acquire British nationality as from the date of the Certificate granted to him under this Order.

- (II.) By the addition at the end of Article 2 thereof of the following Sub-Article:—
 - " (iii.) A Certificate of British Nationality shall be granted to any person coming within Article 1 (iii.) of this Order who shall have complied with the conditions laid down in paragraphs (a) (b) (c) (d) and (e) thereof."
 - (III.) By the insertion in Article 4 (ii.)

thereof after the words "Article 2 (ii.)" of Government of the words "and Article 2 (iii.)." Honduras in cert

2. This Order may be cited as the Cyprus (Annexation) Amendment Order in Council, 1927, and shall be read as one with the Cyprus (Annexation) Orders in Council, 1914 and 1917, and the said Orders may be cited as the Cyprus (Annexation) Orders in Council, 1914 to 1927.

MERCHANDISE MARKS ACT, 1926.

THE MERCHANDISE MARKS EXEMPTION DIREC-TION (No. 1), 1927, DATED MAY 16, 1927, MADE BY THE BOARD OF TRADE UNDER SECTION 1, SUB-SECTION (3), OF THE MERCHANDISE MARKS ACT, 1926 (16 & 17 GEO. 5, c. 53).

Whereas the Merchandise Marks Act, 1926 (16 & 17 Geo. 5. c. 53), Section 1, provides that it shall not be lawful to sell, expose for sale, or, by way of advertising goods of some other kind, distribute, in the United Kingdom, any imported goods to which there is applied any name or trade mark being, or purporting to be, the name or trade mark of any manufacturer, dealer or trader or the name of any place or district in the United Kingdom, unless the name or trade mark is accompanied by an indication of origin.

And whereas Subsection (3) of the said Section 1 provides that if the Board of Trade are satisfied after considering such representations (if any) as may be made to them by any persons appearing to the Board of Trade to have a substantial interest in the matter, that, having regard to the special circumstances of the trade, difficulties would arise if the said Section 1 applied to goods of any class or description, or goods sold under any particular designation, and that public interests in the United Kingdom would not be materially prejudiced by exempting such goods from the operation of the said Section 1, they may direct that the said Section 1 shall not apply to such goods, or that goods shall not be treated as falling under the said Section 1 by reason only that they are so designated.

Now therefore the Board of Trade, having considered representations made to them in that behalf by persons appearing to the Board to have a substantial interest in the matter and being satisfied that, having regard to the special circumstances of the trade, difficulties would arise if the said Section 1 applied to Petroleum and Liquid Products thereof, and that public interests in the United Kingdom would not be materially prejudiced by exempting Petroleum and Liquid Products thereof from the operation of the said Section 1, hereby direct in pursuance of the powers conferred upon them by the said Subsection (3) as follows:—

- 1. Section 1 of the Merchandise Marks Act, 1926, shall not apply to Petroleum and Liquid Products thereof.
- 2. This Direction may be cited as the Merchandise Marks Exemption Direction (No. 1), 1927.
