The KING's Most Excellent Majesty in Council.

WHEREAS there was this day read at the VV Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 20th day of July 1927 (C.W. 5998/26), in the words following, viz.:—

"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, inter alia, that all pay, pensions or other allowances in the nature thereof payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman or Marine therein, shall be paid in such manner and subject to such restrictions, conditions and provisions as are from time to time directed by Order in Council:

'And whereas Your Majesty was graciously pleased, by Your Orders in Council bearing date the 22nd day of January 1920, and the 28th day of June 1920. to approve, inter alia, of the payment of specialist allowances of 2s. 6d. a day to Medical Officers of Your Majesty's Navy below the rank of Surgeon Captain who have specialised in certain professional subjects, and by Your Orders in Council bearing date the 11th day of March 1920 and the 26th day of May 1925, to fix establishments for Surgeon Captains and for Dental Officers, respectively:

'And whereas we consider it desirable in I

the interests of Your Majesty's Naval Service that the specialist allowances granted to Medical Officers should be increased in numbers and should be paid at a higher rate, that the establishments of Surgeon Captains and of Dental Officers should be increased, and that certain other changes as set forth in the Schedule annexed hereto should be made in the conditions of service of Medical and Dental Officers of Your Majesty's Navy:

We beg leave humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council, to sanction the proposals contained in the annexed Schedule with effect from the 1st day of July 1926.

"The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in these proposals.

" SCHEDULE.

"I. MEDICAL OFFICERS, R.N.

'(1) Specialist Allowances.

The number of specialist allowances to be increased from forty-six to sixty, and the professional subjects in respect of which the allowances are payable to be extended to include Medicine, Surgery, Radiology and Hygiene, in addition to the subjects specified in Order in Council of the 28th June 1920.

The rate of allowance payable to be increased

from 2s. 6d. to 5s. a day.

A Surgeon Commander holding the appointment of Naval Health Officer to be exempt from the rule laid down in Order in Council of the 22nd January 1920, Schedule V., Section

VI., and Order in Council of the 28th June 1920, which debars Surgeon Commanders who are appointed solely for specialist duties from receiving specialist allowance.

" (2) Charge Pay.

Medical Officers in charge of hospitals and sick quarters to be granted charge pay at the discretion of the Admiralty on the following scale:-

Rear - Admirals Surgeon and Surgeon Captains—10s. a day.

Surgeon Commanders-5s. a day.

"(3) Increase in Establishment of Surgeon Captains.

The number of Surgeon Captains to be increased from 16 to 20.

" (4) Counting of previous hospital service.

An Officer who enters the Service on or after the 1st July 1926, and who has held, for a period of not less than one year before the date of his entry into the Service, a resident appointment as Medical or Surgical Officer in a Civil hospital after becoming a qualified medical practitioner, to be eligible, at the discretion of the Admiralty, to have his seniority ante-dated by not more than one year, provided that the appointment is one recognised by the Admiralty for this purpose, but this concession not ordinarily to be granted where the interval between the termination of the hospital appointment and the date of entry into the Service exceeds six months. The period of not less than one year in a 'resident' appointment may, at the discretion of the Admiralty, include a period of not more than six months spent in a 'non-resident' appointment recognised by the Admiralty.

The increase of seniority allowed under the above conditions not to render an Officer eligible to receive pay before the date of his actual entry into the Naval Service, but the time concerned to reckon for increase of full. unemployed and half pay while on the active list and retired pay or gratuity on retirement

or withdrawal.

In the event of a temporary Officer or an Officer entered for short service, being transferred to the permanent list on or after the 1st July 1926, he may be granted the above concession, at Admiralty discretion, under similar conditions to those applicable to candidates who may enter the permanent service direct, except that the time shall not count for gratuity on retirement or withdrawal.

The above concession may also be extended, at Admiralty discretion, to include Officers entered for short service, who have held a recognised civil hospital appointment, but were transferred to the permanent list before For such Officers, howthe 1st July 1926 ever, the concession shall be limited to such an ante-date of seniority as will preserve their position on the seniority list in relation to Officers transferred on or after that date. Any increased seniority thus granted shall count for purposes of increments of full, half and unemployed pay, and for promotion, but not for retired pay or gratuity. and no arrears of full pay shall be paid in respect of any period prior to the 1st July 1926.

"II. DENTAL OFFICERS, R.N.

The rank of Surgeon Captain (D) to be introduced and the establishment of Dental Officers to be as follows:-

- " (2) Surgeon Captain (D)—Pay and conditions of service.

The rates of pay and conditions of service, &c., applicable to the rank of Surgeon Captain (D) to be as follows:—

The above standard rates of pay to be comparable with the standard rates authorised by Order in Council of the 22nd January 1920, and the rates to be subject to alteration on the same dates and in like manner to the rates specified in that Order in Council.

Unemployed pay, half pay, retired pay, widows' pensions and allowances to dependants to be at the same rates and subject to the same conditions as for Captains, R.N.

Retirement.

To be retired at the age of 55, and to be retired at any age, at the discretion of the Admiralty, if found physically unfit to serve; optional retirement at 40 to be allowed at Admiralty discretion.

To be retired at any age so soon as two years have elapsed since last service in the rank of Surgeon Captain (D), but not less than three years from date of promotion to that rank.

"(3) Promotion to Surgeon Commander (D) and Surgeon Captain (D).

To be strictly by selection, and to be confined to Officers who have proved themselves to be fitted for promotion both professionally and as administrators.

"(4) Counting of previous Hospital Service.

A Dental Officer who enters the Service on or after 1st July 1926, and who has held, for a period of not less than six months before the date of his entry into the Service, a whole-time appointment as Dental Officer in a recognised civil dental hospital, or in the dental department of a recognised civil general hospital, after becoming a qualified dental practitioner, to be eligible, at the discretion of the Admiralty, to have his seniority antedated according to the period (not exceeding six months), during which such appointment has been held, provided that the appointment is one recognised by the Admiralty for this purpose, but this concession not ordinarily to

be granted where the interval between the termination of the hospital appointment and the date of entry into the Service exceeds six months.

The increase of seniority allowed under the above conditions not to render an Officer eligible to receive pay before the date of his actual entry into the Naval Service, but the time concerned to reckon for increase of full, unemployed and half pay while on the active list, and retired pay or gratuity on retirement or withdrawal."

WHEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 18th day of July 1927 (C.W. 11868/26), in the words following, viz.:—

"Whereas by Section 5 of the Greenwich Hospital Act, 1865, it is enacted, inter alia, that Your Majesty may, from time to time, by Your Order in Council appoint such Pensions as seem fit to Officers of the Royal Navy and Marines and others for the time being entitled to the benefits of Greenwich Hospital:

"And whereas Your Majesty was graciously pleased, by Your Orders in Council bearing date the 16th day of January 1924 and the 9th day of October 1924, to sanction, inter alia, the number of Greenwich Hospital Pensions allotted to Chief Officers of Coastguard (Old Force) being increased to 12 pensions of £25 a year, and the period of qualifying service required for the award of these pensions being reduced to five years, including for this purpose service after retirement in time of war or emergency:

ment in time of war or emergency:

"And whereas certain Chief Officers of Coastguard (Old Force) after retirement as such served in the Coastguard (New Force) or in the Royal Naval Shore Signal Service, and we consider that such further service should count as qualifying service for the award of Greenwich Hospital Pensions provided that the total service before and after retirement was continuous, and also that Officers of the Royal Naval Shore Wireless Service and of the Permanent Cruiser Service should be eligible for these Pensions under the regulations applicable to Chief Officers of Coastguard as contained in the aforesaid Orders in Council:

"We beg leave humbly to recommend that Your Majesty may be graciously pleased, by

Your Order in Council, to sanction the following proposals:—

"(1) Chief Officers of Coastguard (Old Force) who served after retirement in the Coastguard (New Force) or in the Royal Naval Shore Signal Service to be allowed to count such service after retirement as qualifying service for the award of a Greenwich Hospital Pension, provided that the service before retirement and the service after retirement was continuous.

"(2) Officers of the Permanent Cruiser Service and the Royal Naval Shore Wireless Service to be eligible for Greenwich Hospital Pensions under the regulations applicable to Chief Officers of Coastguard (Old Force) as laid down in Orders in Council bearing date the 16th day of January 1924 and the 9th day of October

"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, inter alia, that all pay, pensions or other allowances in the nature thereof payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman or Marine therein, shall be paid in such manner and subject to such restrictions, conditions, and provisions as are from time to time directed by Order in Council:

by Order in Council:

"And whereas by Orders in Council bearing dates the 12th day of October 1925 and the 1st day of June 1926, we are empowered at our discretion to award compassionate allowances to Officers who have been dismissed the Service or dismissed with disgrace by sentence of Court Martial or whose names have been removed from the list of Officers or who have been allowed to resign their commissions or warrants to avoid trial by Court-Martial:

"And whereas by Orders in Council bearing dates and the service of the

"And whereas we are of opinion that Officers who have been removed from the list of retired Officers and who have in consequence been deprived of their retired pay should be eligible at our discretion to be awarded compassionate allowances at rates not exceeding the rates of compassionate allowances which might have been granted to them if at the

dates of their retirement they had been

removed from the active list:

We beg leave humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council, to sanction the substitution of the Schedule hereto annexed for the Schedule annexed to Your Majesty's Order in Council of the 1st day of June 1926.

'The Lords Commissioners of Your Majesty's Treasury have signified their con-

currence in this proposal.

"SCHEDULE.

"1. An Officer who in the opinion of the Admiralty by reason of an act or acts of misconduct or through intemperate or irregular habits of life has become unfit for or is unworthy of further employment may be placed on the retired list, irrespective of age or service, whether he has been tried by Court Martial or not.

"2. An Officer placed on the retired list under Clause 1 may be granted such rate of retired pay or such gratuity as the Admiralty in their discretion may think fit, provided

that-

"(i) Retired pay be not granted to any Officer who would not have been eligible therefor if placed on the retired list for incapacity.

"(ii) The maximum rate of retired pay shall be the lower of the two following

rates, viz.:-

"(a) The rate admissible on the incapacity scale, after crediting the Officer with any service lost as the result of sentence by Court Martial, less 10 per cent.; or

"(b) The rate admissible on the incapacity scale, calculated upon the Officer's service as reduced by sentence

of Court Martial.

"(iii) The gratuity be not in excess of that for which the Officer might have been eligible if retired for incapacity.

- "3. An Officer who has been dismissed the Service or dismissed with disgrace by sentence of Court Martial or whose name has been removed from the list of Officers or who has been deprived of retired pay in consequence of the removal of his name from the list of retired Officers or who has been allowed to resign his commission or warrant to avoid trial by Court Martial, may be awarded a compassionate allowance, but the grant of such an allowance and its duration, if granted, shall be entirely at the discretion of the Admiralty. No Officer may, however, be awarded a compassionate allowance in excess of the retired pay or gratuity which might have been granted to him if placed on the retired list under Clause 1 of this Schedule, and no Officer who has been deprived of retired pay in consequence of the removal of his name from the list of retired Officers may be awarded a compassionate allowance in excess of the compassionate allowance which might have been granted to him if at the date of his retirement his name had been removed from the list of Officers.
- "4. Nothing in this Schedule shall prejudice or affect the power of the Admiralty to discharge or dismiss Officers or shall confer

on any person who has been removed from His Majesty's Service any right to half pay, retired pay or pension, compassionate allow-

ance or gratuity.

'5. The expression 'an Officer' in this Schedule shall include Commissioned Officers. Commissioned Officers from Warrant Rank, Warrant Officers and Subordinate Officers of all ranks in the Royal Navy and the Royal

"And whereas by the Naval Forces Act, 1903, it is enacted that the Admiralty shall have power to raise and maintain a Force to be called the Royal Naval Volunteer Reserve, and that any volunteer enrolled under this Act, when serving for training afloat or called out for actual service shall be deemed to be serving in Your Majesty's Naval or Marine Force within the meaning of the Naval and Marine Pay and Pensions Act, 1865:

- "I. Pay when under training or serving in the Royal Navy as R.N.V.K. Officers in time

Such Officers to receive the pay and allowances for which they may be eligible under the regulations of the Royal Naval Volunteer Reserve in virtue of their R.N.V.R. rank, their retired pay being suspended, subject to the following provisos:-

- (a) In the case of an Officer who has conmuted his retired pay in whole or in part or who received a gratuity on retirement or discharge from the Royal Navy, a deduction is to be made from his full pay equal to the amount of retired pay commuted or to the annual value of the gratuity. Officers retired or discharged under the special reduction schemes sanctioned by Orders in Council of the 14th July 1922 and the 12th February 1923, or any corresponding reduction scheme shall, however, be exempt from this reduction in respect of any gratuity awarded to them thereunder.
- (b) Any Officer may continue to receive his retired pay instead of the full pay of his rank in the R.N.V.R. if such course be to his advantage.

"II. Counting of time.

Time served in the R.N.V.R. whether the Officer be in receipt of full pay in respect thereof or not, to count in the usual manner for all purposes under the regulations of that Force, but not to affect an Officer's rank, status or pay as an Officer of the Royal Navy."
