THE KING has been pleased, by Warrant under His Majesty's Royal Sign Manual bearing date the 22nd August 1927, to direct the issue, under the Seal appointed by the -Treaty of Union to be kept and made use of in place of the Great Seal of Scotland, of a Commission to enquire into and report upon questions of public amenity or artistic importance relating to Scotland, as follows:—

Our Trusty and Well-Beloved James Pittendrigh Macgillivray, Esquire, Our Sculptor in Ordinary for Scotland, Doctor of Laws, Academician of the Royal Scottish Academy of Painting, Sculpture and Architecture;

Whereas We have deemed it expedient that a Commission should be appointed to enquire into such questions of public amenity or of artistic importance relating to Scotland as may be referred to them by any of Our Departments of State, and to report thereon to such Department; and furthermore, to give advice on similar questions when so requested by public or quasi-public bodies where it appears to the said Commission that their assistance would be advantageous; and that the said Commission should be known as the Royal Fine Art Commission for Scotland.

Now know ye that We. reposing great trust and confidence in your knowledge, discretion, and ability, have nominated, constituted and appointed and do by these presents nominate, constitute, and appoint you, the said Sir John Maxwell Stirling-Maxwell (Chairman), Gavin George, Baron Hamilton of Dalzell, Sir John Ritchie Findlay, Sir George Macdonald, Sir George Washington Browne, Sir Robert Stodart Lorimer, James Whitelaw Hamilton, and James Pittendrigh Macgillivray to be Our Commissioners in Scotland for the purposes aforesaid.

And We do by these Presents will and ordain that this Our Commission shall continue in full force, and virtue, and that you, Our said Commissioners, or any three or more of you, may from time to time proceed in the execution thereof, and of every matter and thing therein contained, although the same be not continued from time to time by adjournment; provided always that three years after the date hereof and every subsequent year thereafter one of your number shall retire from this Our Commission in such order as shall be determined by One of Our Principal Secretaries of State after consultation with the Chairman of this Our Commission, and that to the place thereby made vacant there may be appointed by Warrant under Our Sign Manual such person as We shall think fit to appoint.

And We do further ordain that you have liberty to report to Us your proceedings under this Our Commission from time to time if you shall judge it expedient so to do.

And We Will and Command the said Letters Patent to be extended in the most ample form and to pass the Seal aforesaid per saltum without passing any other Seal or Register. For doing whereof these Presents shall be to the Director of Our Chancery for writing the same and to the Keeper of the Said Seal for causing the same to be appended thereto a sufficient Warrant.

Given at Our Court at Saint James's this twenty-second day of August 1927, in the eighteenth year of Our Reign.

MERCHANDISE MARKS ACT, 1926. IMPORTED APPLES AND PEARS.

MERCHANDISE MARKS ACT, 1926. IMPORTED LARD.

The KING has approved of the following alterations in the Regulations for Civil Uniform:—

- (1) The present First Class Uniform shall in future be designated "Privy Counsellor's Uniform," and shall be worn only by Members of His Majesty's Privy Council and by Members of the Privy Council of Northern Ireland.
- (2) The introduction of a new First Class Uniform differentiated in the following manner from the Privy Counsellor's Uniform:—
 - (a) The embroidered edging throughout both Full Dress and Levée Coats to be wavy and to be worked with rough purls. An example of the above edging can be seen at the Lord Chamberlain's Office, St. James's Palace, S.W.1.

- (b) The width of the embroidery, exclusive of the edging, to be $4\frac{1}{2}$ inches instead of 5 inches.
- (c) The hat to have treble gold bullion loop and tassels without hangers.

All persons in possession of Civil Uniforms made in accordance with previous Regulations may continue to wear them as heretofore.

COAL MINES ACT, 1911. EXPLOSIVES IN COAL MINES.

The Secretary for Mines gives notice that on the 20th August 1927 he made an Order in pursuance of Section 61 of the Coal Mines Act, 1911.

(a) Adding to the First Schedule to the Explosives in Coal Mines Order of the 1st September 1913 (relating to "Permitted Explosives") the following explosives:—

Antifrost Gelammonite No. 1.—Manufactured by Cooke's Explosives Ltd., Penryhyndeudraeth, Merionethshire.
