TENDERS FOR TREASURY BILLS.

To enable the Governors of Robert Gordon's Colleges to sell the Gray's School of Art building to the Corporation for the purposes of the proposed Art Gallery.

To enable the Corporation to borrow money for Art Gallery purposes and to increase the limit now imposed on the proportion of the City Rate applicable to Art Gallery purposes.

To alter the existing districts for the registration of births, deaths and marriages and to form one united district for the City for the purposes of registration.
