PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS it is provided by the Colonial Prisoners Removal Act, 1884, that it shall be lawful for His Majesty in Council from time to time to direct that the said Act shall apply, as if, subject to the conditions, exceptions, and qualifications (if any) contained in the Order, any place out of His Majesty's dominions in which His Majesty has jurisdiction, and which is named in the Order, were a British possession and part of His Majesty's dominions, and to provide for carrying into effect such application:

And whereas His Majesty has power and jurisdiction within the Uganda Protectorate:

Now, therefore, His Majesty, in pursuance and exercise of the powers in this behalf by the said Act of Parliament or otherwise in Him vested, is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, as follows:—

- 1. The Colonial Prisoners Removal Act, 1884, shall apply to and take effect within the Uganda Protectorate as if that Protectorate were a British possession and part of His Majesty's dominions.
- 2. In order to carry out the application of the said Act to the Uganda Protectorate, the Governor, or any person or persons lawfully discharging the functions of Governor, may exercise all powers vested by the said Act in the Governor of a British possession.

3. This Order may be cited as the Uganda Protectorate (Colonial Prisoners Removal) Order, 1927.

And the Right Honourable Leopold Charles Maurice Stennett Amery, one of His Majesty's principal Secretaries of State, is to give the necessary directions herein accordingly.

MERCHANDISE MARKS ACT, 1926.

In accordance with the provisions of Section 2, Sub-section (4) of the Merchandise Marks Act, 1926, the Board of Trade give notice that, in pursuance of applications received by them for the making of Orders in Council to require imported goods of certain classes and descriptions to bear an indication of origin, they have made a reference to the Standing Committee appointed by them under the Act in respect of the following classes and descriptions of imported goods:-

- 1. Ball and roller bearings of all descriptions, finished or unfinished and parts thereof, finished or unfinished, other than the balls rollers or cages.
- 2. Vacuum cleaners, electrically worked.

3. Copper tubes.

- 4. Cotton wool, bleached or unbleached, medicated or unmedicated; absorbent gauze tissue, sanitary towels of all descriptions.
- 5. (a) Pumps of all descriptions (other than semi-rotary wing pumps).
 - (b) Parts of pumps of all descriptions.

MERCHANDISE MARKS ACT, 1926.

MERCHANDISE MARKS (IMPORTED GOODS) EXEMPTION DIRECTION (No. 1) 1928.

In accordance with the provisions of Section 3, Sub-section (2) of the Merchandise Marks Act, 1926, the Board of Trade give notice that they have, in pursuance of the powers conferred upon them by the said Section 3, given a Direction in the following terms:—

Whereas by Section 3, Sub-section (1) of the Merchandise Marks Act, 1926 (16 & 17 Geo. V. c. 53), it is provided that if where an Order in Council has been made under that Act with respect to any goods, it is shown to the satisfaction of the appropriate Department by persons appearing to the Department to have a substantial interest in the matter that the application of the provisions of the Order or of some of those provisions to any particular class or description of those goods has caused or is likely to cause injury or hardship to the said persons or any of them, the Department may direct that the Order or any particular provisions of the Order shall cease to apply to goods of that class or description, or shall apply to such goods subject only to such modifications and conditions as the Department think fit, and the Order shall, while the Direction is in force, have effect subject thereto:

And whereas it is provided by (inter alia) the Merchandise Marks (Imported Goods) Order, 1927 (S.R. & O. 1927, No. 1203), that it shall not be lawful to sell or expose for sale in the United Kingdom any imported cabinet furniture of metal not including locks unless such goods bear an indication of origin stamped, punched or cast thereon in a conspicuous manner:

And whereas the Board of Trade, being the appropriate Department in this case, having considered representations made to them in that behalf by persons appearing to the Board to have a substantial interest in the matter are satisfied that the application of the said provisions of the Order to the particular classes or descriptions of the goods hereinafter specified is likely to cause hardship to the said persons:

Now therefore the Board of Trade, in pursuance of the powers conferred upon them by the said Section 3, hereby direct as follows:—

- 1. The Merchandise Marks (Imported Goods) Order, 1927, shall cease to apply to cabinet furniture of metal of the descriptions hereinafter specified, provided that goods of those descriptions are sold and exposed for sale (wherever they are so exposed) in a container having an indication of origin printed thereon in a conspicuous manner:—
 - (a) Articles to which because of their small size it is not practically possible to apply an indication of origin in the manner prescribed by the said Order; and
 - (b) Articles of an ornamental character to which it is not practically possible to apply an indication of origin in manner prescribed by the said Order without injury to the ornamental appearance of the goods.
 - 2. This Direction may be cited as the Mer-

chandise Marks (Imported Goods) Exemption Direction (No. 1), 1928.

These charges are in all cases for a telephonic communication of not more than 3 minutes' duration. The charge for each additional minute or fraction of a minute after the first 3 minutes is one-third of the above mentioned charges.

The hours during which the day charges apply are those between 8 a.m. and 7 p.m. (legal time of the country in which the call originates). The hours during which the night charges apply are those between 7 p.m. and 8 a.m. (legal time of the country in which the call originates).

In the case of a call from a call office the usual call office fees will be charged in

addition to the other charges.

Note.—Communication with the Grand Duchy of Luxemburg is at present limited to calls to or from Luxemburg City.

FALKIRK BURGH EXTENSION DRAINAGE &c.

NOTICE is hereby given that application is intended to be made to the Right Honourable the Secretary of State Scottish Office Whitehall London on or before the 17th day of April next by the Provost Magistrates and Councillors of the Burgh of Falkirk (hereinafter called "the Town Council") for a Provisional Order (hereinafter called "the Order") under the provisions of the Private Legislation Procedure (Scotland) Act 1899 the principal subject matters of which Order are as follows:—

To extend alter and define for all purposes the boundaries of the existing Burgh of Falkirk (hereinafter called "the existing Burgh") in the County of Stirling and to include and incorporate in the existing Burgh such part or parts of the Parishes of Falkirk and Larbert in the County of Stirling as are situate within the following boundaries viz.:—

FIRST.

IN THE PARISHES OF FALKIRK AND LARBERT.

Commencing at a point in the centre of the River Carron on the boundary of the existing burgh at the breakwater at Carronside thence proceeding along the centre of the River Carron in a northerly, southerly, northerly, easterly, southerly and easterly direction to a point 500 yards or thereby north-west of Kerse Bridge over the River Carron thence southwards following the east bank of the burn forming the west boundary of the saltings numbered 2252 on the Ordnance Survey Edition of 1916 (1 2500 scale) and continuing along the east bank of said burn forming the west boundary of field numbered 2228 on said Ordnance Survey to a point on the north side of the towing path of the Forth and Clyde Canal immediately to the east of the houses and in line with the said east boundary of said burn thence westwards along said north side of said towing path to a point 27 yards or thereby from the centre of the London and North Eastern Mineral Railway (Grahamston Branch) thence in a south-easterly direction across the Forth and Clyde Canal thence along the south-west boundary of the said Mineral Railway and across the road leading from Falkirk to Grangemouth thence in an easterly direction along the said southern boundary of said Mineral Railway to the western boundary of the road leading from the Grangemouth Road to Laurieston thence southwards along the said western boundary of said last mentioned road to a point on the centre of the bridge carrying the said last mentioned road over the London Midland and Scottish Railway Grangemouth Branch thence across said road to the eastern boundary thereof thence in a southerly direction along the said eastern boundary of said road to Newlands Cottage thence across the service road to Mid Newlands thence in a southerly direction through fields numbered 2092 and 2093 on said Ordnance Survey until it reaches

PERTH CORPORATION.

NOTICE is hereby given that application is intended to be made to the Secretary of State on or before the 17th day of April next under and in pursuance of the Private Legislation Procedure (Scotland) Act, 1899, by the Lord Provost, Magistrates and Councillors of the City and Royal Burgh of Perth (hereinafter called "the Corporation" and "the Burgh" respectively) for a Provisional Order (hereinafter called "the Order") to be confirmed by Parliament under the provisions of the said Private Legislation Procedure (Scotland) Act, 1899.

The principal subject matters of the Order are as follows:—

To authorise the Corporation to abandon the whole or any part of the tramways of the Corporation authorised by the Perth Tramways Orders, 1892 to 1921, and to discontinue the

working of the same and to take up, remove, sell and dispose of all rails, posts, wires, standards, apparatus and equipment used in connection therewith and make good the surface of the road.

Provisions as to authority by whom such removal and reinstatement shall be effected and as to the payment and recovery of costs thereof.

To release the Corporation from all powers, obligations and liabilities statutory and otherwise in relation to the said tramways or any part thereof or the running thereof or otherwise at the expiration of such period as the Order may prescribe.

Other provisions relating to the discontinuance of working and abandonment of the tramways and the taking up and removal thereof or of the tramway equipment.

To authorise the Corporation to appropriate for the purposes of the omnibus undertaking any part of the lands acquired by them for and buildings used in connection with the tramways.

To provide as to the security for and repayment of the moneys borrowed for tramway purposes and outstanding and interest thereon.

To amend Section 56 (Power to provide and run omnibuses) of the Perth Corporation Order, 1908, and subsection one thereof by omitting therefrom the words "in connection with their tramways" and the words "from any part of the tramways" and to give the Corporation further powers of running omnibuses and to empower them to run omnibuses with the consent of the Minister of Transport and Local Authority of the district along any route beyond the Burgh in respect of which they have not at present power to run omnibuses.

To make provision for the adaptation of roads, bridges, &c.

To give to the Corporation all the powers in connection with the running and working of omnibuses usually given to local authorities and provide as to fares and charges, working and other agreements, starting and stopping places, attachment of signs indicating stopping places to lamp posts &c., through omnibuses, power to reserve omnibuses for special purposes, shelters and waiting rooms, cloakrooms.

To restrict or prohibit the running of omnibuses by any local authority, company, body or person (other than the Corporation) along any roads in the burgh or district on which any of the tramways of the Corporation proposed to be abandoned are situate or on which services of omnibuses may be provided by the Corporation and along routes in competition with the services of the Corporation.

To empower the licensing authority when licensing an omnibus to ply for hire to grant license subject to conditions and to give the Corporation right to notice of and to be heard on any applications for licenses and appeals in respect thereof.

As to rates, fares, tolls and charges and the recovery thereof.

To empower the Corporation to borrow money for the purposes of their omnibus undertaking.

To enable the Corporation and other bodies and persons to enter into agreements in refer-
