#### PRESENT,

The KING's Most Excellent Majesty in Council. HEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 13th day of April 1928 (C.W. 11370/27), in the words following, viz. :-

"Whereas by Section 5 of the Greenwich Hospital Act, 1865, it is enacted, inter alia, that Your Majesty may, from time to time, by Your Order in Council, appoint such pending of the Barrel Name sions as seem fit to Officers of the Royal Navy and Royal Marines and others for the time being entitled to the benefits of Greenwich

"And whereas we are desirous of awarding a Greenwich Hospital Pension of £100 a year to Rear Admiral Gordon Campbell, V.C., D.S.O., in recognition of his distinguished and exceptional services during the great war, such pension to be in addition to those authorised by Your Majesty's Order in Council bearing

date the 16th January 1924:
"We beg leave humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council, as an exceptional and isolated case and not to be drawn into a pre-cedent for the future, to approve of the establishment of an additional Greenwich Hospital Pension of £100 a year accordingly, and to sanction the award of this Pension to Rear Admiral Gordon Campbell, with effect from the 6th April 1928, until the date of the Officer's death, when the pension is to be regarded as lapsing."

His Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of His Privy Council, to approve of what is therein proposed.

And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly.

#### PRESENT,

#### The KING's Most Excellent Majesty in Council.

WHEREAS the Summary Jurisdiction (Process) Act, 1881 (hereinafter referred to as "the principal Act") provides for the service and execution in Scotland of process issued under the Summary Jurisdiction Acts in England, and for the service and execution in England of process so issued in Scotland:

And whereas the principal Act further provides that a court of summary jurisdiction in England and a sheriff court in Scotland shall respectively have jurisdiction to make certain orders or decrees in bastardy proceedings against a person within the jurisdiction of the court notwithstanding that such person ordinarily resides, or the child has been born, or the mother of it ordinarily resides, where the court is English, in Scotland, or where the court is Scotch, in England, and further makes provision for enforcing obedience to any such orders or decrees:

And whereas subsection (2) of section forty of the Criminal Justice Administration Act,

1914, provides that His Majesty may by Order in Council make rules extending the operation of the principal Act so as to make the provisions of the principal Act, subject to the necessary adaptations, applicable as between any one part of the British Islands and any other part of the British Islands in like manner as it applies between England and Scotland; and further provides that that subsection shall extend to the Isle of Man:

And whereas it is expedient to extend the operation of the principal Act so as to make its provisions applicable, subject to the necessary adaptations, as between England and the Isle of Man in like manner as it applies as between England and Scotland:

Now, therefore, His Majesty is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, as follows:—

- 1. The operation of the principal Act shall be extended so that the provisions of that Act shall apply as between England and the Isle of Man, subject to the adaptations set out in the Schedule to this Order.
- 2. This Order may be cited as the Summary Jurisdiction Process (Isle of Man) Order, 1928.

Pers, Bishops, His Majesty's Lieutenants of Counties, Deputy Lieutenants of Counties, Members of Parliament, Officials connected with the Houses of Parliament, Clergy of all Denominations, and all gentlemen other than those mentioned in the following Regulations, should communicate with the Comptroller. Lord Chamberlain's Office. St.

James's Palace. No applications can be received from gentlemen in the foregoing categories wishing to be presented. Their names must be forwarded by the gentleman making the presentation.

- 2. All gentlemen referred to in the following Regulations, wishing to attend or be presented at a Levée, should make a written application as directed below.
- 3. All Officers, whether on the active or retired lists of the Royal Navy and the Royal Marines, will communicate with and obtain their cards, whether for attendance or presentation, from the Private Secretary to the First Lord of the Admiralty.
- 4. All Officers on the active, retired, and reserve lists of the Regular Army, the Militia, and the Territorial Army, except Officers of the Household Cavalry and the Brigade of Guards, and except Officers of the Indian Services and Indian Army and Colonial Service and Colonial Forces, will communicate with and obtain their cards, whether for attendance or presentation, from the Under-Secretary of State, War Office.

Officers of the Household Cavalry and the Brigade of Guards will communicate, through their Regimental Headquarters, with the Comptroller, Lord Chamberlain's Office, St. James's Palace, to obtain their cards for attendance or presentation.

Clergy of all Denominations, and all gentlemen other than those mentioned in the following Regulations, should communicate with the Comptroller, Lord Chamberlain's Office, St. 5. All Officers on the active list of the Royal Air Force and Officers of the Special Reserve and Auxiliary Air Force will obtain their cards, for attendance or presentation, through the

usual channels. Officers of the Reserve of Air Force Officers and Officers on the retired list of the Royal Air Force will communicate with and obtain their cards, whether for attendance or presentation, from the Secretary, Air Ministry, Kingsway, W.C.2.

- 6. All Officers of the Indian Services and of the Indian Army, whether on the active or retired lists, will communicate with and obtain their cards, for attendance or for presentation, from the Political A.D.C. to the Secretary of State at the India Office, Whitehall.
- 7. All Officers of the Colonial Service and Colonial Forces, whether on the active or retired lists, will communicate with and obtain their cards, whether for attendance or presentation, from the Colonial Office, Whitehall, with the exception of Officers of the local Forces of the self-governing Dominions, who will apply to the Under-Secretary of State, the War Office, for their cards for attendance or for presentation, supporting their application in all cases by a credential from the Governor-General, Governor, Officer commanding the local Forces, or the representative in London of the Dominion concerned.
- 8. Lord Mayors and Mayors, High Sheriffs, Sheriffs, Recorders, Chairmen of Quarter Sessions, Metropolitan Police Magistrates and other Stipendiary Magistrates, and all gentlemen connected with the Home Office, will make their applications, whether for attendance or for presentation, through the Private Secretary to the Secretary of State for the Home Department.
- 9. Lord Provosts and Provosts, Conveners of County Councils, and all gentlemen connected with Departments under the Secretary of State for Scotland, will make their applications for attendance or for presentation through the Private Secretary to the Secretary of State for Scotland, at the Scottish Office, Whitehall.

Scottish Judges, Law Officers, King's Counsel and legal officials in Scotland should make their applications through the Legal Secretary to the Lord Advocate.

#### NOTICE.

Northern Ireland Land Act, 1925 (15 & 16 Geo. V., c. 34).

#### Whitehall, April 24, 1928.

His Majesty The KING has been graciously pleased to award the Albert Medal to Gunner John Fairclough, Royal Artillery, in recognition of his gallantry in the following circumstances:—

On the night of April 27, 1927, a serious fire occurred in a petrol godown in Ambala. Three Indian boys had gone to the godown in a lorry to get petrol, and they entered the building carrying a lantern. The naked light ignited the petrol vapour with which in the hot weather the building was filled, and in a very short time the whole building was ablaze. On the outbreak of the fire the lorry driver departed, and before any organised aid could arise the boys were trapped in the burning building. Gunner Fairclough, who happened to be walking alone near by, at once went to In spite of the fact that the their assistance. heat from the burning building was so intense as to keep onlookers at a considerable distance from the fire, he three times entered the building and rescued the three children. Fairclough was severely burned, and unfortunately the three Indian boys later died.

Gunner Fairclough, in entering on three separate occasions a burning building containing a highly inflammable and in certain circumstances a highly explosive substance, three times put his life in the gravest danger. To enter the building the first time was an act calling for great courage, but to enter it twice thereafter, knowing the full danger to be run, was an act of exceptional gallantry.

#### Whitehall, April 26, 1928.

His Majesty The KING has been graciously pleased to award the Edward Medal to Mr. James Marron and Mr. James M'Mullin, in recognition of their gallantry in the following circumstances:—

On the 10th January last, while a furnace was being tapped at the Acklam Iron Works of Messrs. Dorman Long & Company, Middlesbrough, a portion of the brick flooring near the furnace was forced upwards by an explosion, tnd flames and several tons of molten metal belched forth. In a very short time all the ground near the furnace was covered with molten metal, flames were leaping into the air nearly fifteen feet high, and it was almost impossible to see on account of

steam. A man named Davies, aged 76, who was employed as a cleaner, was partially overwhelmed, and took refuge in a water channel surrounding the furnace. Two attempts were made to rescue him by the foreman, but he was beaten back. Marron and M'Mullin, hearing that a man was believed to be trapped by the molten metal, ran to the scene of the explosion and jumped over the tapping channel, which was then full of molten metal. At first they could see nothing on account of the steam and flames, but on the steam lifting for a few seconds they ran along the water channel, where they saw Davies lying and carried him away.

Davies subsequently died from his injuries, and at the inquest the jury, in returning a verdict of accidental death, commended Marron and M'Mullin very highly for their brave action, and requested the Coroner to call attention to their conduct, with a view to some recognition being accorded to them for their fearless action in the face of known danger. Although the time taken to effect the rescue was short, these men ran very considerable risks of a further upheaval, of burning by flames or molten metal, of asphyxiation, and of losing their way in the steam, and their bravery received high praise from their fellowworkmen.
