The KING's Most Excellent Majesty in Council.

WHEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 27th day of July 1928, in the words following, viz.:—

"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted inter alia, that all pay, pensions or other allowances in the nature thereof payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman or Marine therein shall be paid in such manner and subject to such restrictions, conditions and provisions as are from time to time directed by Order in Council:

"And whereas we deem it expedient that an allowance, to be termed Telegraphist Detector Allowance, should be paid to ratings of the Telegraphist branch who are qualified and employed as Submarine Detector operators in submarines:

"We beg leave humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council, to sanction the institution of a Telegraphist Detector Allowance of 3d a day and of a Higher Telegraphist Detector Allowance of 6d a day to be paid to those Telegraphist ratings who are actually detailed for the duties in vacancies in the complements of submarines.

"The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in this proposal."

His Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of His Privy Council, to approve of what is therein proposed.

And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly.

WHEREAS by Section 48 of the Patents and Designs Acts, 1907 to 1928 (7 Edw. 7, c. 29; 4 & 5 Geo. 5, c. 18; 9 & 10 Geo. 5, c. 80; and 18 Geo. 5, c. 3), it is provided that the said Section shall apply only to vessels, aircraft and land vehicles of a foreign state with respect to which His Majesty, by Order in Council, declares that the laws thereof confer corresponding rights with respect to the use of inventions in vessels, aircraft and land vehicles of the United Kingdom when coming into the foreign state or the territorial waters thereof:

And whereas by Section 91 of the said Acts it is provided that the provisions of that Section shall apply only in the case of those foreign states with respect to which His Majesty by Order in Council declares them to be applicable:

And whereas at The Hague on the 6th November 1925, His Majesty and the heads of certain foreign states having deemed it expedient to make certain modifications in and additions to the International Convention of the 20th March 1883, for the creation of an International Union for the Protection of Industrial Property, as revised at Brussels on the 14th December, 1900, and at Washington on the 2nd June 1911, agreed upon a Convention comprising the said International Convention as revised at Brussels and at Washington with the said modifications and additions, the ratification of which Convention was duly effected by Great Britain, Austria, Germany, Italy, the Netherlands and Spain:

And whereas Spain has acceded to the said Convention on behalf of that part of the Empire of Morocco which is under Spanish protection:

And whereas by reason of the ratification of and accession to the said Convention by the said foreign countries the laws thereof confer rights with respect to the use of inventions in vessels, aircraft and land vehicles of the United Kingdom when coming into the said foreign countries or the territorial waters thereof, corresponding to those mentioned in the said Section 48:

And whereas the said Convention is an arrangement of the nature contemplated by the said Section 91:

And whereas by various Orders in Council

Her late Majesty Queen Victoria and His late Majesty King Edward VII have been pleased to declare that the provisions of Section 103 of the Patents, Designs and Trade Marks Act, 1883, or the provisions of the said Section 91 as the case may be should apply to the foreign countries named in the said Orders, and it is expedient, on the making of this Order, that the said Orders in so far as they apply to Austria, Germany, Italy, the Netherlands and Spain should be revoked:

Now, therefore, His Majesty in exercise of the powers conferred upon Him in manner hereinbefore recited and of all other powers in that behalf, by and with the advice of His Privy Council, is pleased to declare, and it is hereby declared, as follows:—

1. The laws of Austria, Germany, Italy, the Netherlands, Spain and that part of the Empire of Morocco which is under Spanish protection confer rights with respect to the use of inventions in vessels, aircraft and land vehicles of the United Kingdom when coming into Austria, Germany, Italy, the Netherlands, Spain and that part of the Empire of Morocco which is under Spanish protection, or the territorial waters thereof, corresponding to those mentioned in Section 48 of the Patents and Designs Acts, 1907 to 1928.

2. The provisions of Section 91 of the Patents and Designs Acts, 1907 to 1928, shall be applicable to Austria, Germany, Italy, the Netherlands, Spain and that part of the Empire of Morocco which is under Spanish protection.

3. The Order in Council dated the 26th June 1884, in so far as it relates to Italy, the Netherlands and Spain, the Order in Council dated the 9th October 1903, relating to Germany, and the Order in Council dated the 17th May 1909, in so far as it relates to Austria, are hereby revoked.

4. This Order may be cited as The Hague Industrial Property Convention Order, 1928.

WHEREAS by Section 48 of the Patents and Designs Acts, 1907 to 1928 (7 Edw. 7, c. 29; 4 & 5 Geo. V, c. 18; 9 & 10 Geo. V, c. 80; and 18 Geo. V, c. 3), it is provided that His Majesty may by Order in Council apply the said Section to vessels, aircraft and land vehicles of a part of His Majesty's Dominions outside the United Kingdom in like manner as to vessels, aircraft and land vehicles of a foreign state and that the said Section shall apply only to vessels, aircraft and land vehicles of a foreign state with respect to which His Majesty, by Order in Council, declares that the laws thereof confer corresponding rights with respect to the use of inventions in vessels, aircraft and land vehicles of the United Kingdom when coming into the foreign state or the territorial waters thereof:

And whereas by Section 91 of the said Acts, it is provided inter alia that where it is made to appear to His Majesty that the legislature of any British possession has made satisfactory provision for the protection of inventions, designs or trade marks, patented or registered in this country, it shall be lawful for His Majesty, by Order in Council, to apply the provisions of the said Section to that possession, with such variations or additions, if any, as may be stated in the Order:

And whereas the laws of the Dominion of Canada confer rights with respect to the use of inventions in vessels, aircraft and land vehicles of the United Kingdom when coming into the Dominion of Canada or the territorial waters thereof corresponding to those mentioned in Section 48 of the said Patents and Designs Acts, 1907 to 1928:

And whereas it is made to appear to His Majesty that the legislature of the Dominion of Canada has made satisfactory provision for the protection of inventions, designs and trade marks, patented or registered in the United Kingdom:

And whereas it is expedient, on the making of this Order, that the Patents, Designs and Trade Marks (Canada) Order, 1923, should be revoked.

Now, therefore, His Majesty, in exercise of the powers conferred upon Him in manner hereinbefore recited and of all other powers in that behalf, by and with the advice of His Privy Council, is pleased to order, and it is hereby ordered as follows:—

1. The provisions of Section 48 of the Patents and Designs Acts, 1907 to 1928, shall apply to vessels, aircraft and land vehicles of the Dominion of Canada in like manner as they would apply to vessels, aircraft and land vehicles of a foreign state with respect to which an Order in Council had been made under sub-section (2) of that Section.

2. The provisions of Section 91 of the Patents and Designs Acts, 1907 to 1928, shall apply to the Dominion of Canada.

3. The Patents, Designs and Trade Marks (Canada) Order, 1923, is hereby revoked.

4. This Order may be cited as the Patents, Designs and Trade Marks (Canada) Order, 1928.

DISTRICT ELECTRICITY (EXTENSION).

Application for Special Order under the Electricity (Supply) Acts, 1882-1926.

NOTICE is hereby given that application has been made to the Electricity Commissioners by the Scottish Midlands Electricity Supply Limited (hereinafter called "the Company") whose registered office is situate at No. 10 Melville Street, Edinburgh, for a Special Order (hereinafter called "the Order") under the Electricity (Supply) Acts, 1882 to 1926 for the following amongst other purposes (that is to say):—

- 1. To extend the area of supply under the Linlithgow and Falkirk District Electricity Orders 1912 and 1926 (hereinafter called "the Orders of 1912 and 1926") by adding thereto the Burgh of Kilsyth in the County of Stirling as constituted at the commencement of the Order (hereinafter called "the added area").
- 2. To authorise the Company to supply, sell and distribute Electricity within the added area for all public and private purposes as defined by the Electricity (Supply) Acts 1882 to 1926.
- 3. To authorise the Company to exercise within the added area all the powers usually conferred on distributors of Electricity.
- 4. To extend and make applicable to the added area all or some of the powers and provisions contained in the Orders of 1912 and 1926 subject to such variations and exceptions as may be contained in the Order.
- 5. To authorise the Company in pursuance of special powers to break up streets and parts

of streets not repairable by the Local Authority and railways within the added area.

SHEEP SCAB MOVEMENT AREAS.

The following Areas are now "Movement Areas" for the purposes of Part II. of the Sheep Scab Order of 1928:—

Inverness.—An Area comprising the islands known as the Outer Hebrides (except the Islands of St. Kilda, Dune, Soay, and Boreray), in the county of Inverness.

Ross and Cromarty.—An Area comprising the Island of Lewis, including the smaller islands adjacent thereto, in the county of Ross and Cromarty.

Argyll.—So much of the parishes of Dunoon and Kilmun, Strachur and Lochgoilhead as is comprised within the following boundary, namely:—

Commencing at Strone Point in the parish of Dunoon and Kilmun, thence north-westerly and northerly along the road leading to Loch

Eck via Kilmun, Ardbeg, Rashfield and Inverchapel; thence continuing along the road in a generally northerly direction via the eastern shore of Loch Eck, Invernoaden, Strachur and the eastern shore of Loch Fyne to St. Catherine's; thence in a generally easterly and then southerly direction along the road via Laglingarten, Hell's Glen and Drimsyniebeg as far as Lochgoilhead Pier; thence proceeding southerly along the western shores of Loch Goil and Loch Long via Carrick Castle, Rudha nan Eoin, Ardentinny and Gairletter Point to the point of commencement.
