TENDERS FOR TREASURY BILLS.

1. AGRICULTURAL PRODUCE (GRADING AND MARKING) ACT, 1928.

The Department of Agriculture for Scotland hereby give notice that, in exercise of their powers under the above Act, they have made the Agricultural Produce (Grading and Marking) (Eggs) (Scotland) Regulations, 1929, dated 17th January 1929.

These Regulations (1) prescribe "grade designations." to indicate the quality of hen eggs produced in Scotland, (2) define the quality indicated by such "grade designations," and (3) prescribe a "grade designation mark" to represent each of the "grade designations."

The Regulations also prescribe the manner of marking, on sale or exposure for sale, of eggs which have been subjected to any process of preservation, and the manner of registration by Local Authorities of premises to be used by way of trade or for purposes of gain for the cold storage or chemical storage of eggs.

The Department further give notice that they have made an Order exempting from the provisions of Section 3 of the Act eggs which have been preserved by cold storage or chemical storage.

FOREIGN HAY AND STRAW (AMEND-MENT) ORDER OF 1929.

Prohibition of Landing of Hay and Straw from the United States of America.

1. Hay and Straw brought from the United States of America shall be subject to the prohibition of landing contained in the Foreign Hay and Straw Order of 1912.

Commencement.

2. This Order shall take immediate effect, provided that such prohibition shall not apply to hay or straw shipped from the United States of America before the date of this. Order.

Short Title.

3. This Order may be cited as the Foreign Hay and Straw (Amendment) Order of 1929.
