The expression "partly-fitted" means fitted on both sides with brake levers of a description not in accordance with the requirements of the said Schedule No. 1.

The expression "unfitted" means not fitted

with brake levers on both sides.

- 2. (c) satisfies the Minister within such time after the thirty-first day of December 1931, as the Minister may allow that the total number of unfitted and partlyfitted wagons belonging to him on the thirty-first day of December 1931, does not exceed the number specified in that behalf in the Schedule hereto.
