TENDERS FOR TREASURY BILLS.

- 1. The Lords Commissioners of His Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England on Friday the 26th April 1929, at 1 o'clock, for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the War Loan Acts, 1914-1919, to the amount of £45,000,000.
- 2. The Bills will be in amounts of £5000 or £10,000. They will be dated at the option of the Tenderer on any business day from Monday the 29th April 1929, to Saturday the 4th May 1929, inclusive, and will be payable at three months after date.
- 3. The Bills will be issued and paid at the Bank of England.
- 4. Each tender must be for an amount not less than £50,000, and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.
- 5. Tenders must be made through a London Banker, Discount House or Broker.
- 6. The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than 2 o'clock (Saturday 12 o'clock) on the day on which the relative Bills are to be dated.

- 7. In virtue of the provisions of Section 1 (4) of the War Loan Act, 1919, Members of the House of Commons are not precluded from tendering for these Bills.
- 8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.
- 9. The Lords Commissioners of His Majesty's Treasury reserve the right of rejecting any Tenders.

PROPOSAL TO VARY MINIMUM RATES OF WAGES FOR CERTAIN CLASSES OF MALE AND FEMALE WORKERS.

In accordance with Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour, and dated 21st April 1927, the Made-up Textiles Trade Board (Great Britain) HEREBY GIVE NOTICE that they PROPOSE TO VARY the Minimum Rates of Wages for certain classes of Male and Female Workers, by a variation in the Definition of a Learner as set out in the Trade Board's Notice M.T. The KING has been graciously pleased to approve of the award of the Albert Medal to No. Ply/21668 Marine Albert Ernest Richards for gallantry in saving life.

The following is the account of the services in respect of which the decoration has been conferred:—

On the 25th September 1928, blasting operations were in progress for the removal of rock on a site at St. Helena under the charge of No. Ply/14790 Sergeant Stewart Symons. Four charges had been laid, two in drilled holes and two in crevices in the rock. The drilled hole fuzes were each to be lit by a Marine, and the crevice fuzes by Sergeant Symons. The hole fuzes and the upper crevice fuze were lit simultaneously, and the Sergeant was bending down to light the lower crevice exploded unexpectedly, blinding Sergeant Symons and knocking him helpless close to one of the drilled holes. The Marines who had lit the other fuzes had by this time run clear, but Marine Richards, seeing that the Sergeant was disabled, turned back and helped him to his feet and dragged him clear of the subsequent explosions, from the effects of which he shielded him with his own body.

Marine Richards was well aware that at least two further charges were due to explode within some thirty seconds, and his presence of mind and disregard of personal danger undoubtedly saved Sergeant Symons from death.

AGRICULTURAL PRODUCE (GRADING AND MARKING) ACT, 1928.

The Department of Agriculture for Scotland hereby give notice that, in exercise of their powers under the above Act, they have made the Agricultural Produce (Grading and Marking) (Tomatoes) (Scotland) Regulations, 1929, dated 17th April 1929.

These Regulations (1) prescribe "grade designations" to indicate the quality of tomatoes grown in Scotland, (2) define the quality indicated by such "grade designations," and (3) prescribe a "grade designation mark" to represent each of the "grade designations."

MUSSELBURGH AND DISTRICT ELECTRIC TRAMWAYS.

WHEREAS the Musselburgh and District Electric Light and Traction Company Limited were authorised by the Portobello and Musselburgh Tramways (Port Seton Extension) Order, 1906, confirmed by the Tramways Orders Confirmation Act, 1906 (which Order is hereinafter referred to as "the Order of 1906") to construct and have constructed and opened for traffic the tramways in the Coun'ty of Haddington, the Burghs of Prestonpans and Cockenzie and Port Seton and the Parishes of Prestonpans and Tranent mentioned in the Schedule hereto and hereinafter referred to as the abandoned tramwavs.

And whereas the provisions of the Tramways Act, 1870, are incorporated with the Order of 1906, and in the said Act, it is enacted by Section 41, inter alia, as follows:-

" If at any time after the opening of any tramways in any district for traffic the promoters discontinue the working of such tramway, or of any part thereof, for the space of three calendar months (such discontinuance not being occasioned by circumstances beyond the control of such promoters, for which purpose the want of sufficient funds shall not be considered a circumstance beyond their control), and such discontinuance is proved to the satisfaction of the Board of Trade, the said Board, if they think fit, may by order declare that the powers of the promoters in respect of such tramway or the part thereof so discontinued shall, from the date of such order, be at an end, and thereupon the said powers of the promoters shall cease and determine, unless the same are purchased by the local authority in manner by this Act provided.

And whereas by virtue of the Ministry of Transport Act, 1919, and the Ministry of Transport (Board of Trade Exception of Powers) Order, 1919, the powers and duties of the Board of Trade under the said Section 41 of the Tramways Act, 1870, have been transferred to the Minister of Transport (hereinafter referred to as "the Minister"

And whereas it has been proved to the satisfaction of the Minister that the working of the abandoned tramways has been discontinued for the space of three calendar months.

Now therefore the Minister, in exercise of the powers in that behalf conferred on him by the said Section 41 of the Tramways Act, 1870, hereby orders and declares that the powers of the Company in respect of the abandoned tramways shall from the date of this Order be at an end.

This Order may be cited as "the Musselburgh and District Electric Tramways (Cesser of Powers) Order, 1929.'

The abandoned tramways referred to in the foregoing Order are the whole of the tramways constructed under the Order of 1906.
