FACTORY AND WORKSHOP ACTS, 1901 to 1929.

The Secretary of State for the Home Department hereby gives notice that on the 27th April 1929 he made Regulations under Section 1 of the Factory and Workshop (Cotton Cloth Factories) Act, 1929, to apply to all factories in which is carried on the weaving of cotton cloth. These Regulations, which may be cited as the Cotton Cloth Factories Regulations, 1929, will come into force on the 15th May 1929, from which date the Regulations under the Factory and Workshop (Cotton Cloth Factories) Act, 1911, will be repealed.
