A PROCLAMATION.

FOR DISSOLVING THE PRESENT PARLIAMENT AND DECLARING THE CALLING OF ANOTHER.

GEORGE R.I.

TATHEREAS We have thought fit, by and with the advice of our Privy Council, to dissolve this present Parliament which stands prorogued to Friday the twenty-fourth day of May instant; We do, for that End, publish this Our Royal Proclamation, and do hereby dissolve the said Parliament accordingly: And the Lords Spiritual and Temporal, and the Knights, Citizens and Burgesses, and the Commissioners for Shires and Burghs. of the House of Commons, are discharged from their Meeting and Attendance on the said Friday, the twenty-fourth day of Mav instant: And We being desirous and resolved, as soon as may be, to meet Our People, and to have their Advice in Parliament, do hereby make known to all Our loving Subjects Our Royal Will and Pleasure to call a new Parliament: And do hereby further declare, that, by and with the advice of Our Privy Council. We have given Order that Our Chancellor of Great Britain and our Governor of Northern Ireland do respectively, upon Notice thereof, forthwith issue out Writs. in due Form and according to Law, for calling a new Parliament: And we do hereby also, by this Our Royal Proclamation under Our Great Seal of Our Realm, require Writs forthwith to be issued accordingly by Our said Chancellor and Governor respectively. for causing the Lords Spiritual and Temporal and Commons who are to serve in the said Parliament to be duly returned to, and give their Attendance in, Our said Parliament on Tuesday the twenty-fifth day of June next, which Writs are to be returnable in due course of Law.

A PROCLAMATION

In Order to the Electing and Summoning the Sixteen Peers of Scotland.

GEORGE R.I.

WHEREAS We have in Our Council thought fit to declare Our pleasure for summoning and holding a Parliament of Our United Kingdom of Great Britain and Northern Ireland, on Tuesday, the twenty-fifth day of June next ensuing the date hereof: In order, therefore, to the electing and summoning the Sixteen Peers of Scotland who are to sit in the House of Peers in the said Parliament,

We do, by and with the advice of Our Privy Council, issue forth this Our Royal Proclamation, strictly charging and commanding all the Peers of Scotland to assemble and meet at the Palace of Holyroodhouse, in Edinburgh, on Friday the thirty-first day of May instant, at twelve o'clock noon, to nominate and choose the Sixteen Peers to sit and vote in the House of Peers in the said ensuing Parliament by open Election and Plurality of Voices of the Peers that shall be then present. and of the Proxies of such as shall be absent (such Proxies being Peers, and producing a Mandate in Writing duly signed before Witnesses, and both the Constituent and Proxy being qualified according to Law); and the Lord Clerk Register and the Principal Clerk of the Session appointed by him to officiate in his name, are hereby respectively required to attend such Meeting, and to take the Votes of the said Peers, and immediately after such Election made and duly examined to certify the Names of the Sixteen Peers so elected, and to sign and attest the same in the presence of the said Peers the Electors, and return such Certificate into Our High Court of Chancery of Great Britain: And We do, by this Our Royal Proclamation, strictly command and require the Lord Provost of Edinburgh, and all other the Magistrates of the said City, to take especial care to preserve the Peace thereof during the time of the said Election, and to prevent all manner of Riots, Tumults, Disorders, and Violence whatsoever: And We strictly charge and command that this Our Royal Proclamation be duly published at the Market Cross at Edinburgh, and in all the County Towns of Scotland, Ten Days at least before the Time hereby appointed for the Meeting of the said Peers to proceed to such Election.

Given at Our Court of Saint James, this tenth day of May, in the year of Our Lord one thousand nine hundred and twenty-nine, and in the twentieth year of Our Reign.

Whereas the Hereditary Degree of Baronet was instituted by Our Royal Predecessor King James the First in the Ninth Year of His Reign with divers privileges and preeminences:

And whereas Our Royal Predecessor King Charles the First did by Warrant under His Hand bearing date the seventeenth day of November one thousand six hundred and twenty-nine, authorise and allow Baronets of the Kingdom of Scotland to wear a badge or cognisance therein described:

And whereas We having taken into Our Royal Consideration certain circumstances humbly represented unto Us and being desirous of enhancing the state and dignity of the aforesaid Hereditary Degree of Baronet, have thought fit to grant and prescribe a Badge which may be worn by Baronets other than the aforesaid Baronets of Scotland:

Now know Ye that We of Our Princely Grace Special Favour and Mere Motion have for Ourselves Our Heirs and Successors given and granted and do by these Presents give and grant unto all Baronets other than Baronets of Scotland Our Royal Licence and Authorit that they may henceforth upon all appropriate occasions wear round their necks a Badge as hereinafter described and as shown in the painting hereunto annexed, that is to say, a shield of the arms of Ulster, viz. on a silver field a left hand gules, surmounted by an Imperial Crown enamelled in its proper colours, the whole enclosed by an oval border embossed with gilt scroll-work having a design of roses, of shamrocks, and of roses and thistles combined for those Baronets who were created Baronets of England, of Ireland, and of Great Britain respectively, and for all other Baronets other than Baronets of Scotland a design of roses thistles and shamrocks combined, such badge to be suspended from an orange riband with a narrow edge of dark blue on both sides, the total breadth of the riband to be one inch and three-quarters and the breadth of each badge to be one-quarter of

Our Will and Pleasure therefore is that you Edmund Bernard, Viscount FitzAlan of Der-

went, Deputy to Our said Earl Marshal, to whom the coignisance of matters of this nature doth properly belong, do require and command that this Our Grant and Prescription be recorded in Our College of Arms to the end that Our Officers of Arms and all others upon occasion may take full notice and have knowledge thereof:

And for so doing this shall be your Warrant.

TENDERS FOR TREASURY BILLS.

- 1. The Lords Commissioners of His Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England, on Friday the 17th May 1929, at 1 o'clock, for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the War Loan Acts. 1914-1919, to the amount of £35,000,000.
- 2. The Bills will be in amounts of £5000 or £10,000. They will be dated at the option of the Tenderer on any business day from Tuesday the 21st May 1929 to Saturday the 25th May 1929 inclusive, and will be payable at three months after date.
- 3. The Bills will be issued and paid at the Bank of England.
- 4. Each Tender must be for an amount not less than £50,000, and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.
- 5. Tenders must be made through a London Banker, Discount House or Broker.
- 6. The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England by means of Cash or a Bankers' Draft on the Bank of England not later than 2 o'clock (Saturday 12 o'clock) on the day on which the relative Bills are to be dated.

TRIAL OF THE PYX OF THE LONDON MINT.

VERDICT.

WE, whose names are hereunder written, having been sworn on the fifth day of March, one thousand nine hundred and twenty-nine, before the King's Remembrancer, at Goldsmiths' Hall, in the City of London, have made the assays and trials of His Majesty's silver coins in the Pyx of the Royal Mint in London, which, according to accounts produced by the Officers of the Mint, were coined in the said Mint from the 1st day of January, one thousand nine hundred and twenty-eight, to the 31st day of December one thousand nine hundred and twenty-eight, both days inclusive. We ascertained the number of coins in each packet produced to us, and that such number corresponded with the number which the Officers of the Mint represented it to contain, and we took one coin from each of such packets of silver coins, making altogether 2 crowns, 95 half-crowns, 48 florins, 70 shillings, 67 sixpences, 4 fourpences, 7 threepences, 4 two-pences and 12 pennies. We then weighed each one pound troy weight (at its standard weight) of the coins so taken out and ascertained that the said coins so bulked were within the remedy as to weight prescribed by the Coinage Acts 1870 to 1920. We then took for assay one pound troy (at its standard weight) of the coins so weighed comprising 1 crown, 10 halfcrowns, 10 florins, 10 shillings, 10 sixpences, 1 fourpence, 1 threepence, 2 twopences and 1 penny, and we ascertained that the amount of variation from the standard weight allowed under the Coinage Acts 1870 to 1920 was, for such pound so taken for assay minus one thousandth (- 001) of an ounce on the whole, and that, therefore, such pound troy of silver coins weighed and assayed as aforesaid was on the whole within the variation from standard weight so allowed. We then assayed separately the coins in the pound troy so taken for assay, comparing them with the standard Trial Plate made of pure silver (as prescribed by the Coinage Act, 1920), produced by the Board of Trade, so as to ascertain whether the metal of the said coins was on the whole within the remedy as to fineness prescribed by the Coinage Acts, 1870 to 1920, and we found that the amount of variation from the standard fineness so prescribed was plus nine ten-thousandths (+ 0009) on the whole of the coins in such pound, and that, therefore, the said pound troy of silver coins weighed and assayed as aforesaid was, on the whole, within the variation from fineness allowed under the Coinage Acts 1870 to 1920. We weighed in bulk the residue of the coins remaining in the said packets of silver coins and we ascertained that they were on the whole within the remedy as to weight allowed under the Coinage Acts, 1870 to 1920, being five hundred and seventy-three thousands (-573) of an ounce below the standard weight prescribed by the said Acts.

TRIAL OF THE PYX OF THE PRETORIA BRANCH MINT.

VERDICT.

WE, whose names are hereunder written. having been sworn on the 5th day of March one thousand nine hundred and twenty-nine, before the King's Remembrancer, at Goldsmiths' Hall in the City of London, have made the assays and trials of His Majesty's gold coins in the Pyx of the Branch Mint at Pretoria in the Union of South Africa, which, according to accounts produced by the Officers of the Mint, were coined in the said Branch Mint from the 1st day of January one thousand nine hundred and twenty-eight to the 31st day of December one thousand nine hundred and twenty-eight, both days inclusive. We ascertained the number of coins in each packet produced to us and that such number corresponded with the number which the Officers of the Mint represented it to contain, and we took out one coin from each of such packets of gold coins, amounting altogether to 183 sovereigns or twenty-shilling pieces, and we weighed separately each of the coins so taken out, and ascertained that they were within the remedy as to weight prescribed by the Coinage Acts, 1870 to 1920. We found that the amount of variation from the standard weight so prescribed was plus six thousandths of an ounce (+ 006 oz.) on the whole of such coins. We then melted all the said gold coins so taken out and separately weighed into an ingot, and assayed such ingot, comparing it with the standard Trial Plate of gold produced by the Board of Trade, so as to ascertain whether the metal of the said ingot

was within the remedy as to fineness prescribed as aforesaid, and we found that the amount of variation thereof from the standard fineness so prescribed was minus three hundredthousandths (or -: 00003) and that therefore the said metal was within the remedy as to fineness allowed under the Coinage Acts, 1870 to 1920. We weighed in bulk the residue of the said coins remaining in the said packets of gold coins and we ascertained that they were on the whole within the variation from standard weight allowed under the Coinage Acts, 1870 to 1920, being one hundred and one thousandths of an ounce above (+ 101) the standard of weight prescribed by the said Acts. We then took from such residue six sovereigns and weighed and assayed them separately, and we found that such sovereigns weighed respectively,—the first 123 287 grains, the second 123 155 grains, the third 123 292 grains, the fourth 123 178 grains, the fifth 123 453 grains. the sixth 123 325 grains, and that therefore the said sovereigns were respectively,—the first thirteen thousandths of a grain above (+ 013), the second one hundred and nineteen thousandths of a grain below (-119), the third eighteen thousandths of a grain above (+ 018), the fourth ninety-six thousandths of a grain below (- 096), the fifth one hundred and seventy-nine thousandths of a grain above (+ 179) and the sixth fifty-one thousandths of a grain above (+.051) the standard weight prescribed by the Coinage Acts, 1870 to 1920. We then assayed the said six sovereigns separately, and we found the Millesimal fineness of such sovereigns to be, the first 916.56, the second 916.43, the third 916.79, the fourth 916.71, the fifth 916.63, the sixth 916.59 respectively, and that therefore the said sovereigns were respectively,—the first ten hundred-thousandths below (-.00010), the second twenty-three hundred-thousandths below (-00023), the third thirteen hundredthousandths above (+ 00013), the fourth five hundred-thousandths above (+ 00005), the fifth three hundred-thousandths below (-.00003) and the sixth seven hundred-thousandths below (-.00007) the standard fineness prescribed as aforesaid.

TRIAL OF THE PYX OF THE PERTH BRANCH MINT.

VERDICT.

WE, whose names are hereunder written, having been sworn on the fifth day of March one thousand nine hundred and twenty-nine, before the King's Remembrancer, at Gold-smiths' Hall in the City of London, have made the assays and trials of His Majesty's gold coins in the Pyx of the Branch Mint at Perth in the State of Western Australia, which, according to accounts produced by the Officers of the Mint, were coined in the said Branch Mint from the 1st day of January one thousand nine hundred and twenty-eight to the 31st day of December one thousand nine hundred and twenty-eight, both days in-clusive. We ascertained the number of coins in each packet produced to us and that such number corresponded with the number which the Officers of the Mint represented it to contain, and we took out Two coins from each of such packets of gold coins, amounting altogether to 36 sovereigns or twenty-shilling pieces, and we weighed separately each of the said coins so taken out and ascertained that they were within the remedy as to weight prescribed by the Coinage Acts, 1870 to 1920. We found that the amount of variation from the standard weight so prescribed was plus one thousandth of an ounce (+ 001) oz.) on the whole of such coins. We then melted all the said gold coins so taken out and separately weighed into an ingot, and assayed such ingot, comparing it with the standard Trial Plate of gold produced by the Board of Trade, so as to ascertain whether the metal of the said ingot was within the remedy as to fineness prescribed as aforesaid, and we found that the amount of variation thereof from the standard fineness so prescribed was plus twenty-two hundred-thousandths (or + 00022), and that therefore the said metal was within the remedy as to fineness allowed under the Coinage Acts 1870 to 1920. We weighed in bulk the residue of the said coins remaining in the said packets of gold coins and we ascertained that they were on the whole within the variation from the standard weight allowed under the Coinage Acts, 1870 to 1920 being twelve thousandths of an ounce above (+ 012) the standard weight prescribed by the said Acts. We then took from such residue four sovereigns and weighed and assayed them separately, and we found that such sovereigns weighed respectively,—the first 123:233 grains, the second 123:257 grains, the third 123.275 grains, the fourth 123.222 grains, and that therefore the said sovereigns were respectively,—the first forty-one thousandths of a grain below (-041), the second seventeen thousandths of a grain below (-017), the third one thousandth of a grain above (+ 001), the fourth fifty-two thousandths of a grain below (-052) the standard weight prescribed by the Coinage Acts, 1870 to 1920. We then assayed the said four sovereigns and we found the millesimal fineness of such sovereigns to be, the first 916.68, the second 916.93, the third 916.79, the fourth 916.93, and that therefore the said sovereigns were respectively,—the first two hundred-thousandths shove (+ 00002), the second twenty-seven within the remedy as to fineness allowed under

hundred-thousandths above (+ 00027), the third thirteen hundred-thousandths above (+ 00013) the fourth twenty-seven hundredthousandths above (+ 00027) the standard fineness prescribed as aforesaid.

TRIAL OF THE PYX OF THE MELBOURNE BRANCH MINT.

VERDICT.

WE, whose names are hereunder written, having been sworn on the 5th day of March one thousand nine hundred and twenty-nine, before the King's Remembrancer, at Goldsmiths' Hall, in the City of London, have made the assays and trials of His Majesty's gold coins in the Pyx of the Branch Mint at Melbourne in the State of Victoria, which, according to accounts produced by the Officers of the Mint, were coined in the said Branch Mint from the 1st day of January one thousand nine hundred and twenty-eight, to the 31st day of December one thousand nine hundred and twenty-eight, both days inclusive. We ascertained the number of coins in each packet produced to us and that such number corresponded with the number which the officers of the Mint represented it to contain, and we took out 8 coins from each of such packets of gold coins, amounting altogether to 32 sovereigns or twenty-shilling pieces, and we weighed separately each of the coins so taken out, and ascertained that they were within the remedy as to weight prescribed by the Coinage Acts, 1870 to 1920. We found that the amount of variation from the standard weight so prescribed was Nil on the whole of such coins. We then melted all the said gold coins so taken out and separately weighed into an ingot, and assayed such ingot, comparing it with the standard Trial Plate of gold produced by the Board of Trade, so as to ascertain whether the metal of the said ingot was within the remedy as to fineness prescribed as aforesaid, and we found that the amount of variation thereof from the standard fineness so prescribed was eleven hundred-thousandths - 00011), and that therefore the said metal was

the Coinage Acts, 1870 to 1920. We weighed in bulk the residue of the said coins remaining in the said packets of gold coins, and we ascertained that they were on the whole within the variation from standard weight allowed under the Coinage Acts, 1870 to 1920, being Nil above or below the standard weight prescribed by the said Acts. We then took from such residue Two sovereigns and weighed and assayed them separately, and we found that such sovereigns weighed respectively,-the first 123 313 grains, the second 123 219 grains, and that therefore the said sovereigns were respectively, the first thirty-nine thousandths of a grain above (+ 039) and the second fifty-five thousandths of a grain below (-055) the standard weight so prescribed by the Coinage Acts, 1870 to 1920. We then assayed the said Two sovereigns separately, and we found the millesimal fineness of such sovereigns to be, the first 916.68, the second 916.55 respectively, and that therefore the said sovereigns were respectively the first two hundred-thousandths above (+ 00002) and the second eleven hundred-thousandths below (-.00011) the standard fineness so prescribed.
