PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 15th day of May 1929, (C.W. 4810/29), in the words following,

"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted inter alia, that all pay, pensions, or other allowances in the nature thereof payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman, or Marine therein, or to the widow or any relative of a deceased Officer, Seaman, or Marine, shall be paid in such manner and subject to such restrictions, conditions and provisions as are from time to time directed by Order in Council:

"And whereas Your Majesty was graciously pleased, by Your Order in Council bearing date the 25th day of June, 1925, to approve regulations for the grant of pensions and allowances to the widows, children and other dependent relatives of Officers of Your Majesty's Naval and Marine Forces:

"And whereas under the aforesaid regulations pensions and children's allowances may be awarded to the widows of pensioners from the Royal Navy and Royal Marines who were granted temporary acting Warrant rank during the Great War, provided, inter alia, that their husbands had twelve months' service in such rank:

"And whereas certain ratings of the Royal Navy and non-commissioned Officers and men of the Royal Marines, who were serving on long service engagements, and certain pensioners, were promoted during the Great War either direct or after less than twelve months' service as Warrant Officer, to Temporary Commissions in the Royal Navy and Royal Marines, or attained Warrant or higher rank in the Naval Forces of Your Majesty's Dominion and Colonial Governments, during that period, but no provision exists for the award of pensions to their widows and allowances to their children:

"And whereas we consider that the widows and children of such Officers should be eligible, at our discretion, for pensions and allowances under similar conditions to the widows and children of Temporary Acting Warrant Officers promoted during the Great War:

"We beg leave humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council, to sanction the proposals contained in the annexed Schedules."

"The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in these proposals.

SCHEDULE.

- "1. Officers who were promoted during the Great War to temporary commissions under the Admiralty after service in warrant rank, or after service as Seamen or Marines serving on long service engagements or after service as Pensioners called up.
- "The widows of these Officers to be eligible for ordinary pensions of £35 a year and children's allowances of £12 a year, provided that the Officers had twelve months' service in warrant or higher rank, including acting or temporary time.
- " 2. Pensioner ratings who attained warrant or higher rank in Dominion or Colonial Navies during the Great War.
- "The widow of such an Officer to be eligible for an ordinary pension of £35 a year and children's allowances of £12 a year, provided
 - (a) the Officer had served at least twelve months in warrant or higher rank in the Royal Navy or in a Dominion or Colonial Navy, including acting or temporary time, service for this purpose being reckoned to the 31st March 1919, only, and

(b) pension contribution as for a Warrant Officer has been paid in respect of any period of reckonable service in a Dominion or

Colonial Navy.

"3. A pension or allowance under these regulations shall not be claimed as a right.
All awards shall be at the discretion of the
Admiralty and subject to the general rules laid down in the Order in Council of the 25th June 1925. Any pension or allowance granted under these conditions may be withheld, reduced, discontinued or restored, in whole or in part, at the discretion of the Admiralty in the same manner as if it had been a pension granted under the Order in Council of the 25th June 1925.

His Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of His Privy Council, to approve of what is therein proposed.

And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly.

"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted inter alia, that all pay, pensions or other allowances in the nature thereof payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having

been an Officer, Seaman or Marine therein shall be paid in such manner and subject to such restrictions, conditions and provisions as are from time to time directed by Order in Council:

"And whereas Your Majesty was graciously pleased by Your Order in Council of the 3rd day of November 1927, to sanction revised rates of substantive pay for Naval ratings, including the Writer and Supply branches, entering or re-entering Your Majesty's Navy subsequently to the 4th day of October 1925:

" And whereas we deem it desirable to establish ratings to be known as Writer Probationer and Supply Probationer and also to provide additional progressive pay for certain Writer and Supply ratings:

"We beg leave humbly to recommend that Your Majesty may be graciously pleased by Your Order in Council to sanction the institution of the ratings of Writer Probationer and Supply Probationer with the relative rank of Ordinary Seaman, and further to sanction as from the 10th day of May 1929, the substitution of the rates of pay for the Writer and Supply branches shown in the accompanying Schedule for those contained in Schedule I of Your Majesty's Order in Council of the 3rd November 1927, power being reserved to us to vary the rates of pay within the scales laid down or to associate payment with such conditions as we may deem necessary.

" The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in these proposals.

WHEREAS by Section 48 of the Patents and Designs Acts, 1907 to 1928, 7 E. 7 c. 29; 4-5 G. 5. c. 18; 9-10 G. 5. c. 80, and 18-9 G. 5. c.3, it is provided that the said Section shall apply only to vessels, aircraft and land vehicles of a foreign state with respect to which His Majesty, by Order in Council, declares that the laws thereof confer corresponding rights with respect to the use of inventions in vessels, aircraft and land vehicles of the United Kingdom when coming into the foreign state or the territorial waters thereof:

And whereas by Section 91 of the said Acts it is provided that the provisions of that Section shall apply only in the case of those foreign states with respect to which His Majesty by Order in Council declares them to

be applicable:

And whereas at The Hague on the 6th November 1925, His Majesty and the heads of certain foreign states having deemed it expedient to make certain modifications in and additions to the International Convention of the 20th March 1883, for the creation of an International Union for the Protection of Industrial Property, as revised at Brussels on the 14th December 1900, and at Washington on the 2nd June 1911, agreed upon a Convention, Treaty Series No. 16 (1928), comprising the said International Convention as revised at Brussels and at Washington with the said modifications and additions, the ratification of which the Convention was duly effected by Britain and certain other foreign Great

And whereas Hungary has acceded to the

said Convention:

And whereas by reason of the accession to the said Convention of Hungary the laws thereof confer rights with respect to the use of inventions in vessels, aircraft and land vehicles of the United Kingdom when coming into Hungary or the territorial waters thereof, corresponding to those mentioned in the said Section 48:

And whereas the said Convention is an arrangement of the nature contemplated by

the said Section 91:

And whereas by Order in Council dated the 17th May 1909, S.R. & O. 1909 (No. 585), p. 614, His late Majesty King Edward VII was pleased to declare that the provisions of Section 91 of the Patents and Designs Act, 1907, 7 E. 7. c. 29, should apply to Austria-Hungary:

And whereas by the Hague Industrial Property Convention Order, 1928, S.R. & O. 1928 (No. 637), the said Order of the 17th May 1909, was revoked, in so far as it related to Austria, and it is expedient, on the making of this Order, that the said Order of the 17th May 1909 should be entirely revoked:
Now, therefore, His Majesty, in exercise of

the powers conferred upon Him in manner hereinbefore recited and of all other powers in that behalf, by and with the advice of His Privy Council, is pleased to declare, and it is hereby declared, as follows:—

1. The laws of Hungary confer rights with respect to the use of inventions in vessels, aircraft and land vehicles of the United Kingdom when coming into Hungary or the territorial waters thereof, corresponding to those mentioned in Section 48 of the Patents and Designs

Acts, 1907 to 1928.
2. The provisions of Section 91 of the Patents and Designs Acts, 1907 to 1928, shall

be applicable to Hungary.
3. The Order in Council dated the 17th May 1909 relating to Austria-Hungary, is hereby revoked.

4. This Order may be cited as The Industrial Property Convention (Hungary) Order, 1929.

WHEREAS by Section 9 of the Weights and Measures Act, 1904 (4 Edw. 7, c. 28), it is provided that it shall be lawful for His Majesty by Order in Council to specify new fees to be paid in respect of the Verification and Stamping of Weights, Measures and Weighing and Measuring instruments in substitution for the fees specified in the First Schedule of the Weights and Measures Act, 1889 (52 & 53 Vict. c. 21):

And whereas it is provided by subsection 2 of Section 3 of the Weights and Measures (Amendment) Act, 1926 (16 & 17 Geo. 5, c. 8), that the aforesaid power of His Majesty shall include and be deemed always to have included the power of specifying fees to be paid whether or not the weighing or measuring apparatus is found correct or is stamped:

And whereas His Majesty by Order in Council dated the 7th day of May 1929 (S.R. & O. 1929, No. 396) directed that the fees specified in the Schedule to that Order should be taken upon the verification and stamping of measuring instruments used in trade for the measurement of liquid fuel or lubricating oil for sale in individual quantities not exceeding twenty gallons:

And whereas the Board of Trade have represented to His Majesty that it would be expedient to specify new fees to be paid upon the verification and stamping of such measur-

ing instruments:.

Now, therefore, His Majesty is pleased, by and with the advice of His Privy Council to order, and it is hereby ordered, as follows:-

1. This Order may be cited as the Measuring Instruments (Liquid Fuel and Lubricating Oil) 650 Verification and Stamping Fees Amendment Order, 1929, and shall have effect from the date of its publication in the London Gazette. 2. The Order in Council dated 7th May 1929 (S.R. & O. No. 396) is hereby revoked. 3. The fees specified in the Schedule hereto shall be paid in respect of the verification and stamping of measuring instruments used in trade for the measurement of liquid fuel and lubricating oil for sale in individual quantities not exceeding twenty gallons.

4. The fees specified in the Schedule hereto shall likewise be paid in respect of any such instrument which on verification is found to be incorrect or defective.
