

for the purposes of the Act be held to be within the county, and unless already represented on the County Council shall for such purposes be represented thereon as may be determined by the Secretary for Scotland.

Now therefore, in pursuance of the powers conferred on him by the Act of 1924 as read with the Secretaries of State Act, 1926, the Secretary of State hereby recalls the foregoing determinations and determines that, as from the 16th day of May 1930, the representation of the said burghs on the said County Councils under the Local Government (Scotland) Act, 1929, shall be treated as representation for the purposes of the Act of 1924.
