LOCAL GOVERNMENT (SCOTLAND) ACT, 1929.

RECONSTITUTED COUNTY COUNCIL  
FOR THE  
COUNTY OF KINROSS.

In accordance with the requirements of subsection (4) of Section 8 of the Local Government (Scotland) Act, 1929, intimation is hereby given that the Secretary of State proposes to make an Order in the terms annexed hereto, and that before making the said Order he will consider any objections and representations in writing respecting the same received in the Scottish Office, Whitehall, London, S.W.1, within twenty-one days of the date hereof.

ORDER by the Secretary of State determining the contents and boundaries of the electoral divisions of the County of Kinross, the number of county councillors for the County and the apportionment of these county councillors between the landward area and the burghs entitled to be represented on the County Council.

In pursuance of the powers conferred upon me by Section 8 of the Local Government (Scotland) Act, 1929, I hereby determine as follows:—

- 1. For the purposes of the reconstitution of the County Council of the County of Kinross (in this Order called the County) the number of county councillors for the County shall be 15.
- 2. The number of county councillors to be elected for the landward area of the County shall be 11.
- 3. The contents and boundaries of the electoral divisions of the County shall be as follows:—

1	Kinross North ...	That part of the parish of Kinross (exclusive of the portion included within the limits of the burgh of Kinross) which lies to the north of a line drawn in a generally westerly direction from the point at which the South Queich Burn falls into Loch Leven up the said burn to the point at which it is crossed by the road leading from Kinross to Crook of Devon, and thence along the centre of the said road to the parish boundary.

No. of Division.	Name of Division.	Contents and Boundaries.
2	Kinross South ...	The remainder of the parish of Kinross exclusive of the portion included within the limits of the burgh of Kinross.
3	Portmoak East ...	That part of the parish of Portmoak which is bounded on the west and north by a line drawn from the point on the shore of Loch Leven opposite the centre of the west end of the road leading therefrom past Grahamston farm-house to and along the centre of the said road in an easterly and northerly direction to the point at which it meets the road leading from Milnathort to Markinch, and thence in a southerly and easterly direction along the centre of the last mentioned road to the point at which it meets the boundary of the county at Auchmuirbridge.
4	Portmoak West ...	The remainder of the parish of Portmoak.
5	Cleish ... ..	The parish of Cleish.
6	Fossoway East ...	That part of the parish of Fossoway which lies to the east of a line drawn in a generally southerly direction from the point at the centre of the bridge crossing the river Devon near Fossoway United Free Church along the centre of the road leading by the farms of Keith Hills and Wester Aldie to the farm of Pow to a point at the centre of the bridge crossing the Pow Burn at which it meets the boundary of the parish.
7	Fossoway West ...	The remainder of the parish of Fossoway.
8	Milnathort North ...	That part of the parish of Orwell which is included within the Milnathort Special Water Supply Drainage and Scavenging District as existing at the date of this Order and which lies to the north of a line drawn from the point on the western boundary of the said district at which it is crossed by the Stirling Road in a generally easterly direction along the centre of the said road, New Road and the Great North Road to the point at which the last-mentioned road crosses the eastern boundary of the said district.
9	Milnathort South ...	The remainder of the Milnathort Special Water Supply, Drainage and Scavenging District as existing at the date of this Order.
10	Orwell East ... ..	That part of the parish of Orwell which is bounded on the west by a line drawn from the point at the south-eastern corner of the Milnathort Special Water Supply, Drainage and Scavenging District as existing at the date of this Order at which the Southern boundary of the parish meets the boundary of the said district in a generally northerly direction along the last-mentioned boundary to the point at which it meets the Middleton Road, and thence along the centre of the said road to the point at Newhill Farm at which it meets the boundary of the county.
11	Orwell West... ..	The remainder of the parish of Orwell.

4. The number of councillors to be elected by the Town Council of the Burgh entitled to be represented on the County Council shall be as follows:—

This Order shall come into force on the first day of October 1929, and the Order of the Secretary for Scotland dated the 27th August 1889, determining the number of County Councillors for each County Council in Scotland and apportioning them between the county and each of the burghs entitled to be represented on the County Council, so far as relating to the County of Kinross, and the Order of the Boundary Commissioners under the Local Government (Scotland) Act, 1889, dated the 3rd November 1891, relating to the County of Kinross are hereby repealed as from 16th May 1930.

#### AIR NAVIGATION ACT, 1920.

#### TENDERS FOR TREASURY BILLS.

1. 4. Each Tender must be for an amount not less than £50,000, and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. The persons whose Tenders are accepted will be informed of the same not later than the

following day, and payment in full of the amounts of the accepted tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than 2 o'clock (Saturday 12 o'clock) on the day on which the relative Bills are to be dated.

7. In virtue of the provisions of Section 1 (4) of the War Loan Act, 1919, Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.
