SCOTTISH CENTRAL ELECTRIC POWER.

A PPLICATION is intended to be made to the Secretary of State on or before the 17th day of December next under the Private Legislation Procedure (Scotland) Act 1899 by the Scottish Central Electric Power Company (hereinafter called "the Company") for a Provisional Order the principal subject matters of which are as follows:—

Additional capital, borrowing powers in respect of authorised and additional capital, temporary loans, redeemable securities, further capital powers and provisions for issuing and raising thereof, conversion or division of shares in authorised capital and incidental powers and to provide for increase by Special Order of Company's capital and borrowing powers.

Provisions as to meetings accounts dividends registers transfers voting notices quorum contracts directors managing director secretary and auditors pensions allowances, &c.

Acquisition of lands by agreement, power to enable persons under disability to grant servitudes, erection of dwelling houses offices and other buildings, power to hold &c. lands, to lay down maintain repair alter and use pipes for conveying water and other materials matters or things to or from generating stations or works belonging leased to or worked by Company and agreements with respect to construction &c. of electric lines pipes works appliances and apparatus on bed banks and foreshore of rivers &c. or affecting railways bridges or other property.

Powers of supplying electricity in bulk in areas contiguous to Company's area of supply or Company's area in relation to undertakings transferred to or authorised by a Provisional or Special Order granted to Company or for purposes of undertakings managed by them, to apply for Provisional Special or other Orders, to acquire undertakings of other authorised undertakers within or partly within or adjoining any such area and extend period for purchase or re-purchase by local authority of any undertaking transferred to Company and make other provisions in respect thereof, to acquire lease work maintain alter improve or dispose of generating stations substations and works, to issue

Breaking up and interference with public and private streets railways tramways &c., supply of fittings and appliances showrooms &c., sub-stations &c. in or under streets, telephone telegraph and electric posts wires &c., entry upon premises, and to provide that in event of owner or occupier of land over which Company propose to place electric lines failing to consent or attaching conditions thereto the Minister of Transport may authorise placing of line pending consideration by Minister of giving or withholding of his consent under Section 22 of Electricity (Supply) Act 1919.

Use of transformers &c., supply of electricity by agreement, prevention of improper use, cutting off and discontinuance of supplies, liability for failure to supply, notices by consumers, power in certain cases to refuse to supply electricity, to prohibit interference with works or apparatus, imposition and recovery of penalties, application of funds, agreements with local authorities &c., incorporation application amendment or repeal of Acts and Orders and other purposes.

The procedure subsequent to the deposit of the Petition for the Order and the Draft Order in the Scottish Office will be by way of Provisional Order unless it is otherwise decided in terms of the Private Legislation Procedure (Scotland) Act 1899 in which case the procedure may be by way of Private Bill and this Notice and other Notices and the deposits with reference to the said application will subject to the Standing Orders of Parliament apply to such Bill.
