## TOWN COUNCIL—SCOTLAND.

The Local Government (Kilmarnock Burgh Wards) Order (Scotland), 1930, dated 10th July 1930, made by the Secretary of State under the Local Government (Scotland) Act, 1929 (19 and 20 Geo. 5, Ch. 25), altering the boundaries of certain Wards of the burgh of Kilmarnock.

Whereas by subsection (1) of Section 36 of the Local Government (Scotland) Act, 1929, it is enacted that the provisions of the Town Councils (Scotland) Act, 1900, with regard to the alteration of the number of magistrates and councillors in burghs and to the number of councillors in each ward and to the division or re-division into wards shall cease to have effect as regards any large burgh within the meaning of the said Act of 1929, and that it shall be lawful for the Secretary of State on the representation of the Town Council of any large burgh by order, *inter alia*, to determine or alter the boundaries of the wards into which the burgh is divided:

And whereas it has been represented to the Secretary of State by the Town Council of the Burgh of Kilmarnock (hereinafter referred to as "the burgh"), which is a large burgh within the meaning of the said Act of 1929, that he should make an Order under the enactment above recited altering the boundaries of the First or Dean, the Second or Bonnyton, and the Fifth or Grange Wards of the burgh:

And whereas it is expedient to give effect to the said representation:

Now therefore the Secretary of State in exercise of the powers conferred on him as aforesaid hereby Orders as follows:—

1. The boundaries of the First or Dean Ward, the Second or Bonnyton Ward, and the Fifth or Grange Ward of the burgh shall respectively be the boundaries as set forth in the Schedule to this Order.

2. This Order may be cited as the Local Government (Kilmarnock Burgh Wards) Order (Scotland), 1930.

## SCHEDULE.

### BOUNDARIES OF FIRST OR DEAN WARD.

Commencing at the point on the centre of Glasgow Road where it crosses the burgh boundary, thence in a straight line along the centre of the said Glasgow Road through Beansburn, Dean Street, Wellington Street and Portland Street to the junction of the last-mentioned street with East George Street, thence along the centre of East George Street and New Street, thence across Green Street to the Kilmarnock Water, thence along the Kilmarnock

Water to the London Road Bridge, thence along the centre of London Road to the burgh boundary, thence along the burgh boundary in a general direction northwards, north-westwards and north-eastwards to the starting point.

#### BOUNDARIES OF FIFTH OR GRANGE WARD.

Commencing at a point in the centre of Irvine Road where it crosses the burgh boundary, thence in a straight line along the centre of Irvine Road, Portland Road and St. Marnock Street to a point in King Street opposite the centre of St. Marnock Street, thence along the centre of King Street and Titchfield Street to the centre of Douglas Street, thence along the centre of Douglas Street to the Bridge over Kilmarnock Water, thence along the Kilmarnock Water to the point at which the same joins the river Irvine, thence along the burgh boundary in a general direction north-westwards, eastwards and north-westwards to the starting point.

#### TENDERS FOR TREASURY BILLS.

1. The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than 2 o'clock (Saturday 12 o'clock) on the day on which the relative Bills are to be dated.

7. In virtue of the provisions of Section 1 (4) of the War Loan Act, 1919, Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

9. The Lords Commissioners of His Majesty's Treasury reserve the right of rejecting any Tenders.
