TRADE BOARDS ACTS, 1909-1918.

DRIFT NETS MENDING TRADE BOARD  
(GREAT BRITAIN).

PROPOSAL TO VARY MINIMUM RATES OF WAGES  
FOR FEMALE WORKERS.

In accordance with Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour, and dated 21st April 1927, the Trade Board established in Great Britain for the trade specified in the Trade Boards (Drift Nets Mending Trade, Great Britain) (Constitution and Proceedings) Regu-

lations, 1925, HEREBY GIVE NOTICE that they PROPOSE TO VARY the minimum rates of wages for female workers set out in their Notice E.(8), dated 24th January 1930, by providing that the General Minimum Time-Rates set out in Column I. of Paragraph 1 (and the Overtime Rates based thereon), and the General Minimum Piece Rates set out in Column I. of Paragraph 3, of the Notice E.(8) shall operate for a period of 18 months from 27th January 1930, instead of as at present provided for a period of 12 months from such date, and that the General Minimum Time-Rates set out in Column II. of Paragraph 1 (and the Overtime Rates based thereon), and the General Minimum Piece-Rates set out in Column II. of Paragraph 3, of the Notice E.(8) shall operate only as from 27th July 1931, instead of as from 27th January 1931, as at present provided.

This Notice is issued with the consent of the Minister of Labour.

Pursuant to Section 3 (5) of the Trade Boards Act, 1918, the Trade Board WILL CONSIDER ANY OBJECTIONS to the above Proposal to Vary which may be lodged with them within two months from the 10th October 1930, the date on which Notice of the Proposal was given in The London Gazette and The Edinburgh Gazette. Such Objections should be in writing and signed by the person making the same (adding his or her full name and address), and should be sent to the Secretary, Drift Nets Mending Trade Board (Great Britain), 1 Whitehall Gardens, London, S.W.1.

It is desirable that the Objections should state precisely and, so far as possible, with reasons, what is objected to.
