- 7. In virtue of the provisions of Section 1 (4) of the War Loan Act, 1919, Members of the House of Commons are not precluded from tendering for these Bills.

COFFIN FURNITURE AND CEREMENT MAKING TRADE BOARD (GREAT BRITAIN).

PROPOSAL TO VARY THE MINIMUM RATES OF WAGES FOR FEMALE WORKERS IN THE CEREMENT MAKING SECTION OF THE TRADE FOR SPECIAL PERIODS NOT DEPENDENT UPON THE COST-OF-LIVING INDEX FIGURE, AND TO CANCEL ALL THE MINIMUM RATES OF WAGES FOR MALE AND FEMALE WORKERS IN THE COFFIN FURNITURE SECTION OF THE TRADE IN THEIR APPLICATION TO CASTERS, PLATERS, AND ENGRAVERS.

This Notice is issued with the consent of the Minister of Labour.

In accordance with Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour, and dated the 21st April 1927, the Coffin Furniture and Cerement Making Trade Board (Great Britain), established under the Trade Boards Acts, 1909 and 1918, HEREBY GIVE NOTICE, that, (A) seeing that the specified period of operation of the minimum rates of wages set out in the Trade Board's Notice U. (26) dated 25th March 1930, will expire on the 31st March 1931, they again PROPOSE TO VARY the General Time-Rates, Piece-Work Basis Minimum Time-Rates and Overtime Rates for Female Workers in the Cerement Making Section of the trade which are set out in the Schedule to the Trade Board's Notice U. (16) issued by the Trade Board and dated 2nd December 1924, and which would, unless varied by the Trade Board, be effective on and after 1st April 1931, BY PROVIDING THAT the minimum rates of wages set out in the Trade Board's Notice U. (26) dated 25th March 1930, for the periods 1st April to 30th September 1930, and 1st October 1930 to 31st March 1931, respectively, shall be continued in operation for the corresponding 6-monthly periods 1st April to 30th September 1931, and 1st October 1931 to 31st March 1932; (B) they PROPOSE TO CANCEL all the Minimum Rates of Wages for Male and Female Workers in the Coffin Furniture Section of the Trade, set out in their Notices U (13) and U (16) dated 31st December 1923 and 2nd December 1924, re-spectively, in their application to Casters, Platers and Engravers.

Pursuant to Section 3 (5) of the Trade Boards Act, 1918, the Trade Board will consider any objections to the above Proposal to Vary and to Cancel which may be lodged with them within two months from the 2nd day of December 1930. Such objections should be in writing and signed by the person making the same (adding his or her full name and address), and should be sent to the Secretary of the Coffiin Furniture and Cerement Making Trade Board (Great Britain), at 1 Whitehall Gardens, London, S.W.1.

It is desirable that the objections should state precisely, and so far as possible with reasons, what is objected to.

REGULATIONS RESPECTING OPEN COMPETITIVE Examinations for the Situation of Male SORTING CLERK AND TELEGRAPHIST IN BEL-FAST, EDINBURGH AND CERTAIN PROVINCIAL Towns in Great Britain in the Depart-MENT OF THE POSTMASTER GENERAL.

These Regulations are liable to alteration from time to time.

- 1. The limits of age for this situation are 15 and 18. Candidates must be within the prescribed limits of age on the day of the examination.
- 2. Every candidate must be a natural-born British subject, the child of a person who is or was at the time of death a British subject; provided that exception may be made in the case of persons serving in a civil situation to which they were admitted with the certificate of the Civil Service Commissioners.

Provided also that if the Civil Service Commissioners are satisfied in the case of any candidate who is a British subject but does not fulfil all the requirements of the rule as to nationality and descent, that the candidate is so closely connected by ancestry and upbringing with His Majesty's dominions that an exception may properly be made to that rule, they may accept such candidate as eligible provided that this discretion shall not be exercisable unless (a) the father or the paternal grandfather of the candidate was a naturalborn British subject, and (b) neither the father nor the paternal grandfather has acquired any other nationality by naturalisation or by any other voluntary and formal act.

- 3. Candidates will be required to satisfy the Civil Service Commissioners that they are duly qualified in respect of health and character.
- 4. At each Examination the number of candidates to be selected will be such as the Postmaster-General may from time to time fix.

- 5. The Examination will be in the following subjects, viz:-
 - English.
 History.

 - 3. Geography.
 - 4. Arithmetic.

Candidates must satisfy the Civil Service Commissioners in Handwriting and in the Examination as a whole.

- 6. The Examination is open only to local candidates. A local candidate is regarded as one whose family home is situated where he can travel to and from the office conveniently and without detriment to his health or the interests of the Department. It will be within the authority of the Postmaster-General to decline to employ a candidate successful in the Examination if he is not satisfied on enquiry that the candidate complies with this requirement.
- 7. Candidates must be at least 5 feet in height, and no officer will be retained in the Service who does not attain the height of 5 feet 4 inches before completing his nineteenth y ar.
- 8. In view of the difficulty which left-h ded operators are libely to experience in the is of instruments designed for right-handed operators, candidates who are markedly left-handed are ineligible for appointment.
- 9.—(i) Persons actually serving in the Army, Navy, or Air Force are ineligible to compete, (ii) Persons holding situations in the Civil Service, Probationary Engineer Cadets in the Navy, and Apprentices in His Majesty's Dockyar ls must obtain the permission of the authorities of their Department to attend the Examination before the commencement of the competition.
- 10. Persons upon whose training for the occupation of teacher public money has been spent cannot be appointed until the consent of the appropriate education authority has been notified to the Civil Service Commissioners.
- 11. Application for permission to attend an Examination must be made at such time and in such manner as may be fixed by the Civil Service Commissioners.
- A fee of 10s. will be required from every Candidate attending an Examination.
