Where the telephone number of the person required is not known an effort will be made to trace it, if his name and address is given. Calling subscribers should, if possible, intimate at the time of booking a "person-to-person" call, the name of an acceptable substitute at the receiving exchange.

In the case of a "person-to-person" call,

when communication with the number required is established, but further efforts to complete the call are abandoned, neither the particular person required nor an accepted substitute being obtainable, a "Report Charge of 12s. (14s. in the case of the Isle of Man or Northern Ireland) will be made in place of the normal charge. The caller (or failing him his telephone station) will be notified of the impracticability of completing the call. When a "person-to-person" call matures, no "report charge" will be made.
