TREASURY MINUTE DATED THE 30th NOVEMBER 1931.

My Lords read Section 8 of the Currency and Bank Notes Act, 1928.

The Chancellor of the Exchequer informs the Board that the Governor and Company of the Bank of England have represented to him that it is in their opinion expedient that the amount of the fiduciary note issue be maintained at 275 million pounds, to which it was increased under the authority of Treasury Minutes dated the 1st August 1931, the 21st August 1931, the 11th September 1931, the 2nd October 1931, and the 30th October 1931. He proposes accordingly that the authority to the Bank to issue fiduciary bank notes to the total amount of 275 million pounds should be further extended until the 14th December 1931.

My Lords approve and direct that the Bank of England be notified accordingly.

Let a copy of this Minute be laid before both Houses of Parliament under Section 8 subsection (3) of the Currency and Bank Notes Act, 1928.

PORTABLE ELECTRIC LAMP CASINGS.

In accordance with the provisions of Section 2, Sub-section (4) of the Merchandise Marks Act, 1926, the Board of Trade give notice that, in pursuance of an application received by them for the making of an Order in Council to require imported casings for dry or secondary battery portable electric lamps, lanterns and torches, whether fitted with a battery or not, to bear an indication of origin, they have made a reference to the Standing Committee appointed by them under the Act in respect thereof.
