“Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, *inter alia*, that all pay, pensions, or other allowances in the nature thereof, payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman or Marine therein, shall be paid in such manner and subject to such restrictions, conditions and provisions as are from time to time directed by Order in Council:

“And whereas Your Majesty was graciously pleased, by Your Orders in Council bearing dates the 13th day of August 1920, and the 4th day of November 1925, to sanction the payment of certain salaries for Recruiting Staff Officers and Naval Medical Officers employed on Your Majesty's Naval Recruiting Staff:

“And whereas we consider it desirable that these salaries should be revised:

“We beg leave humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council, to sanction the payment of salaries at the following rates to those Officers with effect from the 1st October 1931:—

WHEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 19th day of January 1932 (C.W. 11660/31), in the words following, viz. :—

“Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, *inter alia*, that all pay, pensions or other allowances in the nature thereof payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman, or Marine therein, shall be paid in such manner and subject to such restrictions, conditions and provisions as are from time to time directed by Order in Council:

“And whereas Your Majesty was graciously pleased by Your Order in Council bearing date the 25th day of July 1921, to sanction the institution of a scheme of entry of Surgeon Lieutenants for Short Service in the Royal Navy:

“And whereas Medical Officers on the Permanent List of the Royal Navy are eligible under certain conditions for higher acting rank and the pay of such rank when acting in vacancies which may occur on foreign stations:

“And whereas we are of opinion that Surgeon Lieutenants entered for Short Service should likewise be eligible in similar circumstances for higher acting rank and the appropriate rate of pay:

“We beg leave humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council, to authorize us at our discretion to grant to Surgeon Lieutenants, entered for Short Service, the higher acting rank and the rate of pay laid down for such rank, when they are filling vacancies for Officers of higher rank, under the conditions applicable to Officers on the permanent list, with effect from the 1st day of January 1931.

“The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in this proposal.”

The KING's Most Excellent Majesty in Council.

WHEREAS by Section 48 of the Patents and Designs Acts, 1907 to 1928 (7 E. 7, c. 29, 4-5 G. 5, c. 18, 9-10 G. 5, c. 80, and

18-19 G. 5, c. 3), it is provided that the said Section shall apply only to vessels, aircraft and land vehicles of a foreign state with respect to which His Majesty, by Order in Council, declares that the laws thereof confer corresponding rights with respect to the use of inventions in vessels, aircraft and land vehicles of the United Kingdom when coming into the foreign state or the territorial waters thereof:

And whereas by Section 91 of the said Acts it is provided that the provisions of that Section shall apply only in the case of those foreign states with respect to which His Majesty by Order in Council declares them to be applicable:

And whereas at The Hague on 6th November 1925 His Majesty and the heads of certain foreign states having deemed it expedient to make certain modifications in and additions to the International Convention of the 20th March 1883 for the creation of an International Union for the Protection of Industrial Property, as revised at Brussels on the 14th December 1900, and at Washington on the 2nd June 1911, agreed upon a Convention (Treaty Series No. 16 (1928)) comprising the said International Convention as revised at Brussels and at Washington with the said modifications and additions, the ratification of which Convention was duly effected by Great Britain and certain other foreign states:

And whereas Italy has acceded to the said Convention on behalf of the Italian Colonies of Libia and Eritrea and the Italian Dependencies in the Ægean Islands:

And whereas by reason of the accession to the said Convention of the said Italian Colonies and Dependencies the laws thereof confer rights with respect to the use of inventions in vessels, aircraft and land vehicles of the United Kingdom when coming into the said Italian Colonies and Dependencies or the territorial waters thereof, corresponding to those mentioned in the said Section 48:

And whereas the said Convention is an arrangement of the nature contemplated by the said Section 91:

Now, therefore, His Majesty, in exercise of the powers conferred upon Him in manner hereinbefore recited and of all other powers in that behalf, by and with the advice of His Privy Council, is pleased to declare, and it is hereby declared, as follows:—

1. The laws of Libia, Eritrea and the Italian Ægean Islands confer rights with respect to the use of inventions in vessels, aircraft and land vehicles of the United Kingdom when coming into the said Italian Colonies and Dependencies or the territorial waters thereof, corresponding to those mentioned in Section 48 of the Patents and Designs Acts, 1907 to 1928.

2. The provisions of Section 91 of the Patents and Designs Acts, 1907 to 1928, shall be applicable to Libia, Eritrea and the Italian Ægean Islands.

3. This Order may be cited as The Industrial Property Convention (Libia, Eritrea and Italian Ægean Islands) Order, 1932.

1. The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than 2 o'clock (Saturday 12 o'clock) on the day on which the relative Bills are to be dated.

7. In virtue of the provisions of Section 1 (4) of the War Loan Act, 1919, Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.
