

And whereas it is expedient that the first-mentioned Order as so amended (hereinafter referred to as "the principal Order") should be further amended in manner hereinafter appearing:

And whereas it is necessary on account of the urgency of the matters dealt with by this

Order that this Order should come into operation forthwith:

Now, therefore, His Majesty is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, as follows:—

1. The following paragraph shall be substituted for paragraph (3) of Article nine of the principal Order:—

"(3) Whenever an aircraft registered in Great Britain and Northern Ireland is carrying passengers for hire or reward—

(a) the owner of the aircraft shall cause to be exhibited and kept exhibited in a conspicuous place in the aircraft a legible notice stating whether and to what extent smoking is permitted in the aircraft; and

(b) no person shall smoke in the aircraft unless, or except in so far as, smoking is stated by the notice to be permitted.

No notice exhibited in an aircraft for the purpose of the foregoing provisions of this paragraph shall state that smoking is permitted therein unless, or except in so far as, smoking therein is authorised by the aircraft's certificate of airworthiness or by the permission in writing of the Secretary of State.

No person shall smoke in an aircraft registered in Great Britain and Northern Ireland when it is not carrying passengers for hire or reward unless, or except in so far as, smoking therein is authorised by the aircraft's certificate of airworthiness or by the permission in writing of the Secretary of State."

2. The following paragraph shall be inserted

at the end of Article nine of the principal Order:—

"(5) Subject to the provisions of this paragraph, when an aircraft is flying within Great Britain and Northern Ireland, no person shall at any time be carried on the wings or undercarriage of the aircraft, or on or in any other part thereof which is not designed for the accommodation of the personnel or passengers, or on or in anything attached to the aircraft:

Provided that-

- (a) nothing in this paragraph shall prevent a person having temporary access—
 - (i.) to any part of the aircraft for the purpose of executing repairs to the aircraft or adjusting the machinery or equipment thereof or for the purpose of doing anything which may be necessary for the safety of the aircraft or persons or goods carried therein; or

(ii.) to any part of the aircraft in which goods or stores are being carried and to which proper means of access is

provided; and

- (b) a person may be carried on or in any part of the aircraft, or anything attached thereto, with the permission in writing of the Secretary of State and subject to any conditions which may be attached to that permission."
- 3.—(1) This Order may be cited as the Air Navigation (Amendment) Order, 1933.
- (2) This Order shall come in operation provisionally as from the date hereof in accordance with the provisions of Section two of the Rules Publication Act, 1893.

MERCHANDISE MARKS ACT, 1926.

REFERENCE TO THE STANDING COMMITTEE.

In accordance with the provisions of Subsection (4) of Section 2 of the Merchandise Marks Act, 1926, the Board of Trade give

notice that, in pursuance of an application received by them for the making of an Order in Council to require imported goods of certain classes and descriptions to bear an indication of origin, they have made a reference to the Standing Committee appointed by them under the Act in respect of the following classes and descriptions of imported goods:—

- Pipes for smoking tobacco made wholly or mainly of wood;
- (2) Wooden tobacco pipe bowls with drilled stems.

The reference previously made to the Standing Committee in respect of imported briar pipes, stained or unstained, and briar bowls, stained or unstained, is annulled.

ROAD TRAFFIC ACT, 1930.

Notice is hereby given that, in pursuance of the powers conferred upon him by Section 19 (3) of the Road Traffic Act, 1930 (hereinafter called "the Act"), the Minister of Transport has made an Order under the title of "The Road Traffic Act, 1930 (Variation of Provisions of Section 19) (No. 2) Order, 1933," which Order contains the following provisions:—

- 1. Paragraph (i.) of Sub-section (1) of Section 19 of the Act shall be varied so as to provide that in the case of a public service vehicle where in any period of 24 hours one period of duty only is worked not exceeding 8½ hours in length, then the limit of 8½ hours may be substituted for the limit of 5½ hours imposed by the said paragraph in respect of a continuous period of driving if the driver of the vehicle is allowed intervals of time for signing on and off and for looking over the vehicle before the vehicle leaves and after the vehicle returns to the garage, and for lay-over to an extent which in the aggregate is not less than 45 minutes, provided that where the continuous period of duty does not exceed 8 hours the allowed intervals of time need not exceed 40 minutes.
- 2. Paragraph (i.) of Sub-section (1) of Section 19 of the Act shall be varied so as to provide that in the case of a public service vehicle where in any period of 24 hours not more than two periods of duty are worked the aggregate duration of which does not exceed 8½ hours in length, then the limit of 6½ hours may be substituted for the limit of 5½ hours imposed by the said paragraph in respect of a continuous period of driving if the driver of the vehicle is allowed intervals of time for signing on and off and for looking over the vehicle before the vehicle leaves and after the vehicle returns to the garage, and for lay-over to an extent which, distributed over both periods of duty, amounts in the aggregate to not less than 45 minutes, provided that the driver has at least 12 consecutive hours for rest in the period of 24 hours calculated from the commencement of the first period of driving.
- 3. Paragraph (iii.) of Sub-section (1) of Section 19 of the Act shall be varied so as to provide that if between any two periods of driving an express carriage or contract carriage there is an interval of not less than four conconsecutive hours at a destination during which

the driver of the vehicle is able to obtain rest and refreshment, the period of 8 consecutive hours may be substituted for the period of 10 consecutive hours for rest on one day in any period of 7 consecutive days, or on two days in any period of 7 consecutive days if the said period includes a Bank Holiday.

4. The proviso to Sub-section (1) of Section 19 of the Act shall be varied so as to provide in the case of a stage carriage that on one day in any period of 7 consecutive days, or on two days in any period of 7 consecutive days if the said period includes a Bank Holiday, the period of 8 consecutive hours may be substituted for the period of 9 consecutive hours for rest if the driver has an interval of at least twelve consecutive hours for rest on the day next following any day on which he has not had nine consecutive hours for rest.

The Order came into operation on 1st June 1933, and is to remain in force until 31st May 1935.
