#### Civil Service Commission, September 12, 1933.

The Civil Service Commissioners hereby give notice that the following Regulations are published with the approval of the Lords Commissioners of His Majesty's Treasury, viz.:—

REGULATIONS RESPECTING A SPECIAL COMPETI-TION FOR APPOINTMENT AS SECOND CLASS CLERK IN HIS MAJESTY'S GENERAL REGISTER HOUSE, EDINBURGH.

1. The number of vacancies which it is proposed to fill on the result of this competition is not fewer than ten, provided so many candidates are recommended by the Selection Board as suitable for appointment.

The Keeper of the Registers and Records will take such steps as he thinks most appropriate to announce the competition, and the Civil Service Commissioners will satisfy themselves that the steps taken have been such as to secure all desirable publicity.

2. Applications for appointment must be made to the Keeper of the Registers and Records on the prescribed form not later than the 17th October 1933.

3. Candidates must have attained 21 years of age and must not have attained 30 years of age on the 1st July 1933. In the case, however, of candidates having exceptionally suitable qualifications, consideration may be given to applications from candidates up to the age of 40 years.

Female candidates must be unmarried or widows and will be required to resign their appointments on marriage.

4. Candidates must have served for at least five years after attaining the age of 16, and prior to the 17th October 1933, in the Office of a Conveyancer practising in Scotland, and must have passed the examination qualifying for admission as an apprentice to a Law Agent or an examination of a standard accepted as equivalent by the Civil Service Commissioners, provided, however, that the period of service in a Conveyancer's Office may be relaxed in the case of any candidate who has qualified by examination for a university degree in law.

Candidates without the above qualifications may, however, be accepted at the discretion of the Keeper of the Registers and Records provided they show the possession of special qualifications for historical research.

Evidence on these points must be sent in at such times and in such manner as may be appointed.

5. Every candidate must be a natural-born British subject, the child of a person who is or was at the time of death a British subject; provided that exception may be made:—

(a) In the case of candidates serving in a civil situation to which they were admitted with the certificate of the Civil Service Commissioners.

(b) In the case of natural-born British subjects who served in His Majesty's Armed Forces in the Great War between 4th August 1914 and 11th November 1918.

(c) In the case of natural-born British subjects who have satisfactorily completed a period of not less than five years' service on full pay in His Majesty's Regular Forces.

Provided also that if the Civil Service Commissioners are satisfied in the case of any candidate who is a British subject but does not fulfil all the requirements of the rule as to nationality and descent, that the candidate is so closely connected by ancestry and upbringing with His Majesty's dominions that an exception may properly be made to that rule, they may accept such candidate as eligible provided that this discretion shall not be exercisable unless (a) the father or the paternal grandfather of the candidate was a naturalborn British subject, and (b) neither the father nor the paternal grandfather had acquired any other nationality by naturalization or by any other voluntary and formal act.

6. Persons holding situations in the Civil Service must obtain the permission of the

authorities of their Department to apply for appointment.

No person actually serving in the Army, Navy, or Air Force will be eligible for consideration unless he produces, when called upon to do so, the permission of his Commanding Officer to apply for appointment, dated before his appearance before the Selection Board, and given in accordance with such orders as may from time to time be issued.

Persons upon whose training for the occupation of teacher public money has been spent cannot be appointed until the consent of the appropriate education authority has been notified to the Civil Service Commissioners.

7. The Keeper of the Registers and Records will examine the candidates' credentials and will submit to the Civil Service Commissoners the names of those candidates who appear to have the requisite qualifications and to be best fitted for appointment. The Civil Service Commissioners, if dissatisfied with the number or quality of candidates may require further search to be made for qualified candidates. The Civil Service Commissioners may, if they think fit, assist in the scrutiny of the application forms of the candidates.

The Civil Service Commissioners may submit any or all of the candidates to a qualifying examination in English Composition.

8. Candidates who are recommended by the Keeper of the Registers and Records and are accepted by the Civil Service Commissioners as possessing the requisite qualifications will be summoned to an interview before a Selection Board in Edinburgh, who will recommend for the vacancies existing those candidates who appear to them to possess the highest qualifications, and the decision of the Selection Board will be final. The Selection Board will be constituted by the Keeper of the Registers and Records, who will preside over the Board, in consultation with the Civil Service Commissioners, who will be represented on the Board. The Board will take into consideration the candidate's record of experience and education, any recommendations that they may receive from persons named by candidates as having direct knowledge of their work in the past, and the personal qualities of the candidate as shown at this interview; and on their estimation of all the above evidence they will frame their decisions.

9. The appointment of selected candidates will be subject to their satisfying the Civil Service Commissioners of their eligibility in respect of age, nationality, health and character, and will not be confirmed unless and until they have passed the prescribed period of probation to the satisfaction of the Department.

10. Candidates selected for appointment will be required to pay a fee of £5 10s.

11. Any attempt on the part of candidates to enlist support for their applications through Members of Parliament or other influential persons will disqualify them for appointment. The Selection Board will disregard spontaneous recommendations from persons who are not personally acquainted with the candidate's work, whether at school, at the university, in industry or business, in the Forces, or otherwise.

## PUBLIC HEALTH (IMPORTED FOOD) AMENDMENT REGULATIONS (SCOTLAND), 1933.

The Department of Health for Scotland hereby give notice, in pursuance of the abovenamed Regulations, that as from the date of operation of the Amendment Regulations they will recognise for the purposes of items (a) and (c) of the Second Schedule to the Amendment Regulations, *i.e.*:—

(a) A severed part of the carcase of an animal (including the head or any part thereof, and the whole carcase without the head, but not including any part of the carcase of a pig which has been salted, cured, pickled, dried or smoked or otherwise prepared in the manner in which bacon or ham is ordinarily prepared), from which no submaxillary, prescapular, pre-crural, superficial inguinal, supramammary, or popliteal gland has been taken out;

(c) All edible parts of an animal other than (i) the head or other severed parts of the carcase, (ii) the intestines prepared in the form of sausage casings, and (iii) meat which has before importation been made ready for human consumption in the form of a sausage or other prepared or manufactured article of food,

the Official Certificate of which particulars are given in the Schedule hereto as evidence that the meat to which it relates has been derived from an animal which was free from disease at the time of slaughter, and has been dressed or prepared and packed with all necessary precautions for the prevention of danger to public health.

The recognition applies only if the label is securely affixed to the meat, or to the package containing the meat, and if the label has not in any other circumstances or on any other occasion been used as an Official Certificate.
