MERCHANDISE MARKS ACT, 1926.

IMPORTED BACON AND HAM.

A draft of an Order in Council under the Merchandise Marks Act, 1926, to require imported Bacon and Ham to be marked with an indication of origin, has been laid before Parliament as required by Section 7 of the Act.
